HOUSE

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Young of Hallowell.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

The following bills and resolves were received and upon recommendation of the Committee on Reference of Bills were referred to the following committees:

Appropriations and Financial Affairs

Mr. Gagne of Lewiston: Resolve appropriating money to aid Girls' Orphanage, Lewiston.

By the same gentleman: Resolve appropriating money to aid St. Mary's General Hospital, Lewiston.

By the same gentleman: Resolve appropriating money to aid Healy Asylum, Lewiston.

Education

Mr. Wood of Bluehill: Resolve in favor of the Bluehill George Stevens Academy.

Mr. Reed of Harmony: Resolve in favor of Hartland Academy.

Inland Fisheries and Game

Mr. Piper of Jackman Pl.: An Act to amend Section 38 of Chapter 8 of the Revised Statutes, relative to the suspension of open season.

Interior Waters

Mr. Fickett of Naples: An Act to change the name of Trickey Pond, in Naples in the county of Cumberland, to Lake Wenonah.

By the same gentleman: An Act to authorize Greta M. Mendelsohn to construct and maintain a wharf in Long Pond, at Naples in Cumberland county.

Judiciary

Mr. Saunders of Lubec: An Act to amend Section 51 of Chapter 82 of the Revised Statutes, as amended by Chapters 73, 211 and 227 of the Public Laws of 1917, as amended by Section 51, Chapter 181 of the Public Laws of 1921, relating to trial terms of the Supreme Judicial Court.

Mr. Gardiner of Gardiner: An Act relating to a winter speed course or way above the Gardiner-Randolph bridge at Farmingdale.

Mr. Barwise of Bangor: Resolve amending the Constitution of the State of Maine so as to limit appropriations for private institutions and purposes

until Dec. 31, 1930, and so as to prohibit such appropriations after December 31, 1930.

Legal Affairs

Mr. Clarke of Stonington: An Act to legalize acknowledgments taken, cath administered, and marriages solemnized by Fred A. Torrey.

State Lands and Forest Preservation

Mr. Hammond of Van Buren: An Act to amend Section 35 of Chapter 8 of the Revised Statutes, relating to building of camp fires.

Mr. Granville of Parsonsfield: An Act to amend Section 1 of Chapter 164 of the Public Laws of 1921, relating to portable saw mills.

Mr. Curtis of Brewer: An Act to amend Section 29 of Chapter 8 of the Revised Statutes as amended by Chapter 61 of the Public Laws of 1921, providing for the appointment of forest fire wardens in towns.

Mr. Plummer of Bridgton: An Act to amend Section 36 of Chapter 8 of the Revised Statutes relating to forest fire notices.

Mr. Wills of Salem: An Act to amend Section 15 of Chapter 30 of the Revised Statutes, relating to kindling fires on forest land.

Mr. Melcher of Rumford: An Act to amend Section 70 of Chapter 8 of the Revised Statutes as amended by Chapter 83 of the Public Laws of 1921, relating to forest fire fighters in the Maine forestry district.

By the same gentleman: An Act to amend Section 68 of the Revised Statutes as amended by Chapter 58 of the Public Laws of 1921, relating to the compensation of chief forest fire wardens and their deputies.

Ways and Bridges

Mr. Tarr of Arrowsic: Resolve appropriating money to reimburse the town or Arrowsic for money expended in the repairs and maintenance of bridge in the town of Arrowsic.

Mr. Wood of Bluehill: Resolve in favor of Bluehill for repair of road.

Orders

On motion by Mr. Baker of Steuben, it was

Ordered, that the official reporter of the House be, and hereby is, authorized to procure the services of a typewriter operator for the use of the assistant reporter of the 81st Legislature in the preparation and completion of the Legislative Record, at the same compensation as was incurred at the last regular session.

Orders of the Day

On motion by Mr. Sturgis of Auburn, it was voted to take from the table an act tabled by him January 18, entitled "An Act to prevent crime by persons masked or disguised"; and on further motion by the same gentleman

it was voted that the bill be referred to the committee on judiciary.
