HOUSE

Tuesday, January 30, 1923.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Clark of Gardiner.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: An Act repealing Chapter 100, Private and Special Laws of 1921, creating the Belgrade Lakes Village Corporation.

In the Senate, referred to the committee on Towns.

In the House, on motion by Mr. Baker of Steuben, tabled pending reference to any committee.

Message From The Governor State of Maine Office of the Governor

Augusta, Jan. 29, 1923. Honorable Senate and To the House of Representatives:

On Wednesday, January 24, I sent a message to your Honorable Bodies, stating that arrangements were being made for the purchase and distribution of the six hundred tons of anthracite coal stored in Portland. Maine, and further stating that I hoped that it would not be necessary to seize this coal, as I considered such action would constitute a dangerous and unfortunate precedent.

I am glad to report to you that I have received the following telegram frem Fuel Director Andrew P. Lane,

dated January 26;

"Schipper Bros. (Owners of the coal) in Portland today. After consulting with me they have sold the entire lot of coal in the Portland Coal Co. yards to Deering Coal & Wood Co. at prices so that it can be sold to the people of Portland at the regular going rates which are satisfactory to me."

The distribution of this coal has already been undertaken. I should have reported to you on Friday, the 26th, but the above telegram came to me a few moments after the Legis-

lature adjourned.
