#### HOUSE

Friday, February 2, 1923

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Atkins of Gardiner.

Journal of previous session read and approved.

Mr. Pierce of Sanford presented the following order, out of order:

Ordered, the Senate concurring, that when the Senate and the House adjourn, they adjourn to meet Tuesday. February 6 at ten o'clock in the forenoon.

The order received passage and was sent up for concurrence.

Mr. Hale from the Committee on Legal Affairs on Bill "An Act to establish the Kennebunk Municipal Court" reported same in a new draft under same title and that it "ought to pass."

Mr. Crafts from the Committee on Inland Fisheries and Game on resolve offering a reward for the recovery of the bodies of David F. Brown and Mertley E. Johnson, game wardens, who disappeared in November, 1922, and for testimony leading to the conviction of the person or pesons responsible for their death, reported same in a new draft under same title and that it "ought to pass."

ing to exemption from taxation, be printed.

On motion by Mr. Dilling of Easton, Adjourned until Tuesday morning, February 6 at ten o'clock.
