HOUSE

Tuesday, February 6, 1923.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Graham of Randolph.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

Senate Bills in First Reading

Senate 26. An Act to amend Section 69 of Chapter 8 of the Revised Statutes, as amended by Chapter 58 of the Public Laws of 1921, relating to the compensation of chief forest fire wardens and their deputies.

Senate 22. An Act to amend Section 70 of Chapter 8 of the Revised Statutes, as amended by Chapter 83 of the Public Laws of 1921, relating to forest fire fighters in the Maine Forestry District.

Report read and accepted and the new draft ordered printed under the joint rules.

Mr. Martin, from the committee on Legal Affairs, reported "ought to pass" on Bill "An Act to amend Section 1 of Chapter 62 of the Revised Statutes as amended by Chapter 48 of the Public Laws of 1919 as further amended by Chapter 101 of the Public Laws of 1921, relating to corporations for literary, charitable, educational and other purposes."

Report read and accepted and the bill ordered printed under the joint rules.
