HOUSE

Friday, February 9, 1923. The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Folsom of Gardiner

Journal of previous session read and approved.

On motion by Mr. McIlheron of Lewiston, the rules were suspended and that gentleman introduced the following order, out of order:

Ordered, the Senate concurring, that when the Senate and House adjourn, they adjourn to meet, Tuesday, February 13, at ten o'clock in the forenoon.

Mr. Douglas of Lamoine presented the following order and moved its passage:

Ordered, that the use of the hall of the House be granted for Lincoln Day address at 10.30 in the forenoon of Tuesday, the 13th of February, and that Rev. Ashley A. Smith of Bangor be invited to deliver it.

Mr. GRANVILLE of Parsonstield: Mr. Speaker, will not that interfere with our adjournment order to 10 o'clock Tuesday?

The SPEAKER: The Chair will state that that might somewhat depend on the amount of business we have to do. The Chair would suggest to the gentleman (Mr. Douglas) possibly an amendment.

Mr. DOUGLAS: My idea was to get the Lincoln Day address, Mr. Speaker, that is all. The time is immaterial.

Mr. GRANVILLE: No other business interfering, it would be all right, but we are not sure of being through at 10.30.

Thereupon, the time being changed from 10.30 a. m. to 11 a. m. and the gentleman from Lamoine, Mr. Douglas, agreeing to that amendment, the order received passage as amended.

Mr. MOODY of York: Mr. Speaker, 1 have an order which I will read. Ordered, the Senate concurring, that the Librarian be requested to furnish each member and officer of the Senate and House of Representatives with one copy of "Maine in the Northeastern Boundary Controversy," by Burrage; and may 1 say a few words in explanation?

The SPEAKER: The Chair recognizes the gentleman.

Mr. MOODY: This (holding in his hand the book in question) is the volume referred to in the order. Down in the basement of this building there are between five and six hundred copies of it. They were printed in 1919, and it is a very valuable book by Dr. Burrage. It treats of the controversy relative to the northeastern boundary, and had it not been for the staunch and courageous stand taken by the statesmen who conducted our side of that case, a part of Oxford, almost all of Franklin, a large part of Somerset, a part of Penobscot and all that glorious Aroostook would be now in the Dominion of Canada; and for aught 1 know my friend Story would be sitting in the Parliament House at Ottawa (laughter), and for aught 1 know the representative from Fort Kent, with her sweet soprano, would be singing, "God Save Our Gracious King" instead of "America." (Laughter and applause.)

Thereupon the order received passage.
