### HOUSE

Monday, February 26, 1923. The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Skillin of Gardiner.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Report of the committee on School for Feeble Minded on Resolve in favor of the Maine School for Feeble Minded for maintenance reporting that same be referred to the Committee on Appropriations and Financial Affairs and School for Feeble Minded, jointly.

In the Senate, report read and accepted.

In the House, report read and accepted in concurrence, and on motion by Mr. Gagne of Lewiston 500 copies ordered printed.

From the Senate: Report of the committee on School for Feeble Minded on Resolve in favor of the Maine School for Feeble Minded for additions and improvements reporting that same be referred to the Committee on Appropriations and Financial Affairs and School for Feeble Minded, jointly.

In the Senate, report read and accepted

In the House, report read and accepted in concurrence, and on motion by Mr. Gagne of Lewiston 500 copies ordered printed.

From the Senate: Petition of M. O. Tibbetts, Rangeley, Maine and 40 others of Maine in favor of a Constitutional Amendment prohibiting the use of Public Funds for Sectarian Schools. This was referred to the Committee on Judiciary in the in the House February 22nd.

In the Senate referred to the Committee on Education in nonconcurrence.

In the House, it was voted to recede and concur with the Senate in the reference of petition.

From the Senate: An Act to amend Chapter 136 of the Public Laws of 1921, relating to Night Fishing in certain waters of Kennebec county.

This was passed to be engrossed in the House February 22nd.

In the Senate recommitted to the Committee on Inland Fisheries and Game in non-currence.

In the House, it was voted to recede and concur with the Senate and recommit the bill to the committee on Inland Fisheries and Game.

From the Senate: An Act to amend Chapter 128 of the Private and Special Laws of 1921, amending Chapter 103 of the Private and Special Laws of 1919, amending Chapter 444 of the Private and Special Laws of 1907, relating to Clerk Hire in the Lewiston Municipal court:

This was passed to be enacted in the House February 20th.

In the Senate, passed to be enacted as amended by Senate Amendment A. in non-concurrence.

Senate Amendment A. read:

Senate Amendment A to House Document No. 70 relating to Clerk Hire in the Lewiston Municipal Court.

Amend the title of House Doc. 70 which now reads "An Act to amend Chapter 128 of the private and special laws of 1921 amending chapter 103 of the private and special laws of 1919, amending chapter 444 of the private and special laws of 1907. relating to Clerk Hire in the Lewiston Municipal Court," so that said title will read as follows: "An Act to amend chapter 126 of the private and special laws of 1921 relating to Clerk Hire in the Lewiston Municipal Court."

In the House, on motion by Mr. Gagne of Lewiston, the House voted to reconsider the vote whereby this bill was passed to be enacted: and on further motion by the same gentleman the House voted to reconsider its action whereby this bill was passed to be engrossed. On motion of Mr. McIlheron of Lewiston it was voted to adopt Senate Amendment A in concurrence; and on further motion by the same gentleman, it was voted that the bill as amended by Senate Amendment A now be passed to be engrossed in concurrence.

By Mr. Maher of Augusta: An Act amending Public Laws 1919, Chapter 228 as amended by Chapter 222 of the Public Laws of 1921 known as the Workmens' Compensation Act.

(500 copies ordered printed.)

By Mr. Granville of Parsonsfield: An Act to exempt non-resident vchicles from registration and to establish Reciprocal Exemptions with other States.

(500 copies ordered printed.)

By Mr. Brown of Bar Harbor: Remonstrance of F. W. Phippen and 12 cthers; John Closson and 25 others of Bass Harbor; Geo. B. Smith and 44 others against same.

#### Reports of Committees

Mr. Martin from the Committee on Legal Affairs on Bill "An Act additional to Chapter 356 of the Private and Special laws of 1883 entitled 'An Act to authorize the construction of a Bridge over Tidewaters between Orr's Island and Bailey's Island' as amended by Chapter 91 of the Private and Special Laws of Maine for the year 1921, and to authorize the towns of Harpswell to hire money for the construction of said bridge and to construct the same under the provisions of Chapter 319 of the Public Laws of 1915 and acts additional thereto and amendatory thereof" reported that legislation thereon is inexpedient.

Mr. Adams from the Committee on Inland Fisheries and Game reported "Ought not to pass" on Bill "An Act to amend Section 56 of Chapter 33, of the Revised Statutes, relating to Inland Fisheries and Game."

Reports read and accepted and sent up for concurrence.

The SPEAKER: The Chair will state for the benefit of the new members, assuming that the old members know all about it, that whenever the Chair declares a vote any member is of course at liberty to doubt it. It seems to be a part of the proceedings that the Chair has to automatically declare votes, perhaps many times without an expression from the House. If there is anything going by in that manner which any member of the House objects to, it is his privilege at any time to doubt the vote. I am simply calling this to your attention so that there may be no misunderstanding at any time.

#### Reports of Committees-continued

Mr. Wood from the Committee on Education on Bill "An Act to amend Chapter 416 of the Private and Special Laws of 1907 relating to the Board of Education of the city of Augusta" reported same in a new draft under title of "An Act to amend Section 32 of the Private and Special Laws of 1919 re-

lating to the Board of Education of the city of Augusta" and that it "Ought to pass."

Mr. Clarke from the Committee on Legal Affairs on Bill "An Act to extend an Act entitled 'An Act to incorporate the Odd Fellows' Home of Maine' " reported same in a new draft under same title and that it "Ought to pass."

Mr. Ludgate from the Committee on Public Utilities on Bill "An Act to incorporate the Patten Water Company" reported same in a new draft under title of "An Act to incorporate the Patten Water and Power Company" and that it "Ought to pass."

Reports read and accepted and the new drafts ordered printed under the Joint Rules.

Mr. Adams from the Committee on Inland Fisheries and Game reported "Ought to pass" on Bill "An Act providing for Protection of White Perch in Bear Pond, situated in the town of Hartford, in the county of Oxford, and in the town of Turner, in the county of Androscoggin."

Mr. O'Connell from the same committee reported same on Bill an Act to limit the number of pounds of fish that may be taken from Cobbosseecontee Stream and connecting ponds, in the county of Kennebec.

Mr. Baker from the committee on sea and shore fisheries reported same on Bill an Act to regulate the taking of clams in the town of Sorrento.

Mr. Granville from the committee on ways and bridges reported same on Bill an Act to amend Section 2 or Chapter 319, Public Laws of 1915, as amended by Chapter 243, Public Laws of 1919, relating to State and County Aid in the construction of highway bridges.

Reports read and accepted and the bills ordered printed under the joint rules.

Mr. Kitchen from the committee on inland fisheries and game reported same on Bill an Act to amend Section 26 of Chapter 219 of the Public Laws of 1917, as amended by Chapter 244 of the Public Laws of 1917, and Chapter 196 of the Public Laws of 1919 and Chapter 218 of the Public Laws of 1921, relating to the taking of smelts in the tributaries to Sebago Lake.

Report read and accepted, and the bill having already been printed (House Document No. 90), was read twice under suspension of the rules and tomorrow assigned.

Mr. ROUNDS of Portland: Mr. Speaker and gentlemen of this House, we are paying out now a large amount of money to advertise Maine and the summer time is when people come here on their vacations. Now, if you are going to close up all the fishing and the clam digging and everything, what will we have to show these people except our good roads, of which we have only a few miles? It looks to me as though we were making a mistake to spend thousands of dollars to get people here and then say that they must pay five dollars, and I move that these several bills lie on the table-bills 109, 110, 111. 113 and 115.
