HOUSE

Monday, March 26, 1923.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Skillin of Gardiner.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Final report of the committee on Public Health.

In the House, read and accepted in concurrence.

From the Senate: Final report of the committee on Towns.

In the House, read and accepted in concurrence.

Senate Bills in First Reading

Senate 264: An Act to repeal Section 3 of Chapter 256 of the Private and Special Laws of 1907 as amended by Chapter 226 of the Private and Special Laws of 1913, in relation to Cumberland County Power and Light Company.

Senate 265: An Act to incorporate the Columbia Falls Water Company.

Senate 210: An Act to amend Section 93 of Chapter 45 of the Revised Statutes, as amended by Chapter 293 of the Public Laws of 1917, relating to settlement of violations of law, and repealing Section 87 of Chapter 219 of the Public Laws of 1917, relating to same subject.

the House March 15th. In the Senate, indefinitely postponed

in non-concurrence.

In the House, on motion by Mr. Rounds of Portland, the House voted to recede and concur with the Senate.

From the Senate: Bill, An Act to repeal Chapter 183 of the Public Laws of 1919, entitled "An Act to assist in the commercial utilization of dog fish."

This was indefinitely postponed in the House March 21st.

In the Senate, passed to be engrossed in non-concurrence.

In the House, on motion by Mr. Rogers of Rockland, the House voted to insist on its former action and ask for a committee of conference.

The SPEAKER: The Chair will announce the committee of conference later.

From the Senate: Report of the committee on Temperance reporting ought to pass on bill, an act to amend Section 45, Chapter 127, Revised Statutes, as amended by Chapter 291, Public Laws of 1921, relating to intoxicating liquor.

In the Senate report read and accepted and the bill passed to be engrossed as amended by Senate Amendment A.

In the House, report read and accepted in concurrence, and the bill received its two several readings. The House voted to adopt Senate Amendment A in concurrence, and the bill as amended by Senate Amendment A was passed to be engrossed in concurrence.

From the Senate: Resolve appropriating money for the establishment orf a Test Laboratory at Caribou in the County of Aroostook.

This was passed to be engrossed in the House March 20.

In the Senate passed to be engrossed as amended by Senate Amendment A in non-concurrence.

In the House, the vote whereby

this resolve was passed to be engrossed was reconsidered. The House voted to adopt Senate Amendment A in concurrence, and the resolve as amended by Senate Amendment A was passed to be engrossed in concurrence.

Mr. ROUNDS of Portland: Mr. Speaker, 1 understood that there was a bill referring to the directors of the Port of Portland, ought not to pass.

The SPEAKER: Was it a Senate paper?

Mr. ROUNDS: Yes, Mr. Speaker.

The SPEAKER: Report of the committee on Legal Affairs on bill, an act to amend Chapter 83, Private and Special Laws of 1919, relating to the Port of Portland.

HALE Mr. of Portland: Mr. Speaker, I think that I can enlighten the gentleman from Portland (Mr. Rounds.) That was a bill that provided that the directors of the Port of Portland should be called "Trustees of the Maine State Piers." It simply changed the title of the directors of the Port of Portland, and 1 am sure that the gentleman from Portland (Mr. Rounds) will have no opjection to it.

Message from the Governor

STATE OF MAINE

Office of the Governor

Augusta, March 26, 1923.

To the Honorable Senate and House of Representatives of the \$1st Legislature:---

I return herewith without my approval

RESOLVE, providing for aid in the payment of premiums awarded by the Houlton Agricultural Society.

This Resolve provides that there shall be "annually" appropriated \$1500 for the Houlton Agricultural Society. In the first place I object to this Resolve because it carries an ANNUAL appropriation, and thereby places a continuing appropriation upon the State. Once these continuing appropriations are incorporated in our Statute books it is almost impossible to remove them. The State now is suffering from just such Resolves as the one before you for on account of them our basic tax rate is not less than 5½ mills. Each Legislature should be free to make its own appropriations and the people should hold each Legislature responsible for the taxes imposed by them. One Legislature should not dic-

tate appropriations to those that follow.

In the second place this Resolve is unfair to the 41 other agricultural associations that now are receiving State Aid out of the regular State fund of \$15,360.28 appropriated for that purpose.

There are three so-called State Fairs, one at Bangor, another at Waterville, and a third at Lewiston. These three fairs receive \$2500 as a State stipend for they are presumed to be Statewide in their activities, and for this reason a special appropriation is given them.

All other fairs, town and county, are paid out of a general fund and each fair receives its proportionate share of the money that is available. There is no favoritism shown in these matters.

The Houlton Fair, like the other 41, is a local institution and last year received from the general fund \$946,91. The Resolve before you seeks to take the Houlton Fair out of the general list and give it special consideration by increasing its appropriation approximately 60%. In addition to this increase the Resolve before you provides that the \$1500 appropriated shall be a "continuing" stipend from year to year.

Regardless of the needs of the Houlton Fair it no doubt is in as good a financial condition as many of the other fairs in the State that are not asking special privileges. If this Resolve is passed it will be unjust to the other 41 fairs that are struggling for existence, none of which receive any State aid over and above their regular stipend.

I am opposed to all these special grants of State aid and therefore cannot approve the Resolve before me.

Mr. BAKER of Steuben: Mr. Speaker, I rise to ask unanimous consent to introduce an act out of order, to correct a clerical error. I will say that the act has been signed by the Governor and the error was not detected in the Secretary of State's office until after it was signed. It is simply correcting a clerical error in naming the Section which occurs in the bill.

Bill, An Act to amend Chapter 83 of the Public Laws of 1923, relating to close time on scallops, for the purpose of correcting a clerical error.

The unanimous consent of the House was given Mr. Baker of Steuben to introduce this act out of order. On motion by Mr. Baker of Steuben, the bill received its three several readings under suspension of the rules, without reference to a committee, and the bill was passed to be engrossed and sent up for concurrence.

On motion by Mr. Crafts of Greenville, the amendment and resolve were tabled, pending the adoption of the amendment.

Mr. Dunbar from the Committee on Ways and Bridges reported same on Bill An Act providing for the protection of roadside trees.

Mr. Dunn from same Committee reported same on Bill An Act to create a State road fund, and amending Section 2 of Chapter 154 of the Public Laws of 1917.

Reports read and accepted and sent up for concurrence.

Mr. Gillespie from the Committee on Agriculture on Bill An Act to amend Section 18 of Chapter 34 of the Revised Statutes relating to the apportionment of State aid to county and local agricultural societies, reported same in a new draft under same title and that it "Ought to pass."

Mr. Nichols from the committee on Judiciary on Resolve relating to the acquirement of certain lands in the Ogunquit Village Corporation in the town of Wells, for a public park, and making an appropriation therefor, reported same in a new draft under title of "An Act to incorporate the Ogunquit Beach District" and that it "Ought to pass."

Mr. Downing from the committee on Taxation on Message of the Gevernor on Maine's tax exemption law, reported a Resolve under title of "Resolve appropriating \$3000 for the purpose of investigating the tax exemption laws of the State of Maine as found in Section 6, Chapter 10 of the Revised Statutes,' and that it "Ought to pass."
