**SENATE**

Tuesday, January 23, 1923.

Senate called to order by the President.

Prayer by Rev. Mr. Bradford of Lowell.

Journal of previous session read and approved.

Papers from the House disposed of in concurrence.

The following bills, petitions, etc., were received and on recommendation by the committee on reference of bills were referred to the following committees:

**Judiciary**

By Mr. Ryder of Piscataquis: An Act to amend Section 10 of Chapter 137 of the Revised Statutes as amended by Chapter 203 of the Public Laws of 1917, and by Chapter 76 of the Public Laws of 1919, and by Chapter 167 of the Public Laws of 1921, relating to the appointment of probation officers.

**State Lands and Forest Preservation**

By Mr. Phillips of Hancock: An Act to provide for registration of land surveyors and their marks.

By the same senator: Resolve appropriating money for the further maintenance of the State forest nursery.

By the same senator: Resolve appropriating money for general forestry purposes.

By Mr. Buzzell of Waldo: An Act to amend Section 42 of Chapter 8 of the

Revised Statutes, relative to forest fires within woodlands.

By the same senator: An Act to amend Section 58 of the Revised Statutes, as amended by Chapter 5 of the Public Laws of 1919, relating to forest fire signs.

By the same senator: Resolve appropriating money for salaries and clerk hire in the office of land agent and forest commissioner.

By Mr. Putnam of Hancock: An Act concerning the improvement, protection and preservation of fruit, shade or ornamental trees.

By the same senator: Resolve appropriating money for the administration of public lands.

**Orders**

On motion by Mr. Adams of Kennebec, it was

Ordered, that the official reporter of the Senate receive the same compensation as the official reporter of the House.

**Orders of the Day**

On motion by Mr. Bailey of Penobscot, under suspension of the rules that senator presented An Act to control the sale and use of pistols and revolvers.

On further motion by the same senator the bill was referred to the committee on military affairs.
