Senate called to order by the President.

Mr. EREWSTER of Cumberland presented the following order and moved its passage:

## STATE OF MAINE,

In Senate, March 6, 1923.
Whereas under the pressure of litigation in various counties in this State there have been establishea
from time to time Superior Courts to supplement to some extent the work of the justices of the Supreme Judicial Court, and

Whereas there are now pending before the Legislature bills requiring the appointment of two additional Superior Court Justices, and

Whereas there exists in other sections of the State a congestion in litigation which makes it possible that the establishment of further Superior Courts may soon be necessary, and

Whereas it is desirable to make the organization of our judicial system responsive to the needs of the various localities and to secure a more equitable distribution of the time and labor of the several justices of our courts:

Now, therefore, be it
Ordered. the House concurring, that a recess committee be constituted to consider the question of reorganization of the judicial system. and to consider any bills which may be referred to $i t$, the said committee to consist of two members from the Senate appointed by the president of the Senate, and two members of the House appointed by the speaker of the House, and two members, one of whom at least shall be a member of the Maine State Bar Association, appointed by the Governor who shall not be members of the Legislature, the said committee to serve without compensation, but its expenses to be paid by the Governor and Council from funds not otherwise appropriated, the said commitfee to report by bill or otherwise to the next Lepislature.

Mr. BREWSTEP of Cumberland: Mr. President. in view of what misht seem to be the importance of such a recess committee. I wish to move that this lie upon the table in order that the senators may have an opportunity to consider whether or not it is wise to create such a recess committee: but before making that motion $T$ would like to explain briefly the reason for its presentation. The recital of the causes at the beginning of the order perhaps give us some idea of the considerations which enter into it. I would supplement that by saying that there is being introduced in the House today a bill looking alnog lines which have been under consideration for a great time in this State. I think for some twenty-five or thirty years, contemplating the possible reorganiza-
tion of our judicial system with relation to the duties of the superior court and the supreme court justices, in order to expedite the administration of the court system and to relieve and more equitably distribute the work of the various justices. That bill will be introduced in the House. I think there is existing among many members of the Bar in the State at least a feeling that the time has come to give serious consideration to this matter in the interests of securing more efficient administration of justice, and perhaps also more economical administration, which would interest not only the Bar but also the other people who have matters to present. That was the purpose of the order.

And now, in order that the Senate may have more time to consider a matter of this importance, I move that it lie upon the table and that ran copies be printed.

The motion was agreed to, and the nider was tabled.
