Tuesday, February 3, 1925.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Clark of Gardiner.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

The following bills, resolves and petitions were received and, upon recommendation of the committee on reference of bills, were referred to the following committees:

#### Education

By Mr. Bartlett of Bangor: An act to require the teaching of the Constitution of the United States in Public and Private Schools. (H. P. No 287)

By Mr. Frost of Berwick: Resolve in favor of Berwick Academy. (H. P. No. 288).

By Mr. Houghton of Lee: Resolve in favor of Lee Academy for Liquidation of Certain Indebtedness. (H. P. No. 289).

#### Inland Fisheries and Game

By Mr. Kinsman of Augusta: An act relating to the Protection of White Perch in certain waters. (H. P. No. 290)

By Mr. Houghton of Lee: An act relating to fishing in upper Taylor Brook and tributaries and in the East Branch and West Branch of Passadumkeag Stream and Brown Brook in Penobscot and Hancock Counties. (H. P. No. 291)

By Mr. Clarke of Randolph: An act to provide that a voter changing his residence from one ward or precinct to another may vote in the ward or precinct of his new residence. (H. P. No. 292)

#### Order

Mr. Oakes of Portland presented the following order and moved its passage:

#### STATE OF MAINE

House of Representatives

February 2, 1925. It appearing to the House of Representatives that the following is an important question of law and the occasion a solemn one:

Ordered, the Justices of the Supreme Judicial Court are hereby requested to give the House of Representatives, according to the provisions of the Constitution in this behalf their opinion on the following question, to wit:

Whereas, on January 8th, the opinion of the Justices of the Supreme Judicial Court was requested relative to a bill before the House of Representatives entitled, "An act relating to the limitation of buildings in specified districts of cities and towns", and the following supplemental question which may be answered with the previous question will justify a more comprehensive reply.

Question 1.

Has the Legislature the power un-

der the Constitution to authorize cities and towns to limit buildings according to their use or construction to specified districts thereof? Thereupon the order received passage.

#### Report of Committee

Mr. Sargent from the committee on Public Utilities reported "ought to pass" on bill, an .act to increase the capital stock of the Camden and Rockland Water Company. (H. P. No 20).

bill ordered printed under the joint rules.

### Report of Committee on Bills in Third Reading

H P. 10: Resolve to compile and publish data of the resources of the State.

Report accepted, and on motion by Mr. White of Bowdoinham tabled pending second reading.

On motion by Mr. Spruce of Milford.

Adjourned until tomorrow morning at ten o'clock.
