Thursday, Feb. 5, 1925. The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Lowe of Augusta.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

(Emergency Measure)

An act to incorporate the city of Brewer High School District.

The SPEAKER: This being an emergency measure, and requiring under the Constitution the affirmative vote of two-thirds the entire membership of this House on its passage to be enacted, all those who are in favor of the passage of the bill to be enacted will rise and stand in their places until counted, and the monitors will return the count.

A division being had,

One hundred and thirty-three voted, all in the affirmative, and the bill was passed to be enacted.

On motion by Mr. Curtis of Brewer it was voted to take from the table the bill tabled by that gentleman yesterday regarding the taking of smelts in Penobscot waters: and on further motion by the same gentleman the bill was referred to the committee on Sea and Shore Fisheries.

On Motion by Mr. Littlefield of Kennebunk it was voted to take from the table Senate Document No. 33, tabled by that gentleman, being an act to enlarge the powers of the State Highway Police and to authorize the Governor and Council to appoint said police and direct them in the performance of their duties; and on further motion by the same gentleman the bill was referred to the committee on Judiciary in accordance with the suggestion of the committee on reference of bills.

The SPEAKER: The House is about to take a recess of approximately one hour. This will be done for the purpose of exchanging papers with the Senate, and that the committee on reference of bills may meet, and we will respond at the sound of the gavel in about an hour and endeavor to accomplish sufficient business to justify adjournment today and save a session tomorrow. During this recess the Clerk has a notice that a Republican caucus is to be held this morning, and that caucus may well take place immediately after we recess. Will the members kindly remain within hearing approximately an hour from this time, when we will reassemble, and at that time the period of adjournment can be determined? For the purpose of holding the Republican caucus it will be necessary to re-quest, not only our visitors but quest, not only our visitors but members of the minority party to afford us the use of the hall exclusively for a brief period. The House will now recess to respond to the sound of the gavel.
