From the Senate: Resolve rejecting proposed amendment to the Constitution of the United States Congress power to granting to limit. regulate and prohibit the labor of persons under eighteen years of age. (S. P. 125).

In the House, on motion by Mr. Sturgis of Auburn, tabled pending reference in concurrence.

#### DEPARTMENT OF STATE State of Maine

To the President of the Senate and the Speaker of the House of Rep-

resentatives:

By direction of His Excellency, the Governor, I have the honor transmit herewith a communication received at the Executive Department from the Secretary of State of the United States under date of June 6, 1924, enclosing a certified copy of a resolution to Congress entitled "Joint Resolution proposing an amendment to the Constitution of the United States." The text of the resolution is as follows, to wit:

"Resolve by the Senate and House of Representatives of the United States of America in Congress assembled, two-thirds of each House concurring therein, that the following Article is proposed as an amendment to the Constitution of the United States, which, when ratified by the Legislatures of three-fourths of the several states, shall be valid to all intents and purposes as a part

of the Constitution.

Section I. The Congress shall have power to limit, regulate and prohibit the labor of persons under eighteen years of age.

Section 2. The power of the several states is unimpaired by this Article except that the operation of State laws shall be suspended to the extent necessary to give effect to legislation enacted by the Congress."

#### ORDERS OF THE DAY

The SPEAKER: Under orders of the day, the Chair presents a paper from the Senate, out of order: Ordered, the House concurring,

that the Special Legislative Committee appointed for the purpose of investigating the proposed location of a bridge over the Kennebec River in the vicinity of Bath and Woolwich, be authorized to continue its investigations and employ such en-gineering counsel as may be in their judgment required to enable them to make full report of their findings on or before March 10th, 1925, and that said committee be authorized incur the necessary expense therefor, the same to be charged to the fund appropriated by the 81st Legislature for the expense of the 82nd Legislature.

In the Senate read and passed. Mr. BISHOP of Boothbay Harbor: Mr. Speaker, relative to the order just read, a word of explanation may possibly be in order.

The Legislature, sometime ago, suggested the appointment of a committee to investigate sites for the Kennebec Bridge near Bath and Woolwich. committee This appointed, attended to its duties so far as it could, investigated the situation down there, had interviews with representatives of the Waddell Engineering Company, as well as with representatives from the War Department, the latter of whom went over the draw situation in regard to navigation. In doing this your committee came to the conclusion that it still needed more data, as some things were not brought out there that we wanted, especially in relation to the approaches.

At the suggestion of Governor Brewster this order has been introduced authorizing your committee to

proceed with its investigations, employ engineering counsel, and get all the data possible and present it to you not later than March 10th. This in a few words explains the purposes of the order.

The SPEAKER:

The gentleman from Boothbay Harbor, Mr. Bishop, moves the passage of the order in concurrence. The subject is open for discussion. Is it the pleasure of the House that this order have passage?

Thereupon the order received passage in concurrence.

On motion by Mr. Gagne of Lewiston, it was voted to take from the table H. P. 449, bill an act to establish a Finance Commission of Lewiston, tabled by that gentleman on February 10, pending reference. Mr. GAGNE: Mr. Speaker, I move

that this bill be referred to the committee on Legal Affairs, the committee on reference of bills having suggested reference to the Judiciary

committee.

Mr. HOLMES of Lewiston: Mr. Speaker, I wish to ask the House not to sustain the motion of my colleage (Mr. Gagne), but to sustain the order of reference of the committee on reference of bills.

Briefly, Mr. Speaker, I will give the two reasons that appeal to me, and I think other members of the Lewiston delegation, and I think also to the committee on reference of bills, and perhaps to the committee on Judiciary; and I hope that the members of the committee on Legal Affairs will not feel that we are wrong and will not feel that there is any matter of pride in it. Those two committees are the law committees, and either one, of course, has equal power and authority with the other; but the city of Lewiston is the second city of size in the State and surely deserves courteous treatment from the Legislature. The city of Lewiston has representation upon the Judiciary committee but rone upon the Legal Affairs committee. It has one member on the Judiciary. We feel that, as a matter of courtesy to the great city of Lewiston, the bill should be referred to the committee on Judiciary where Lewiston has representation.

Also, Mr. Speaker, one other rea-This bill is very fundamental in its nature-I do not mear to argue the question of the merits of the bill -but being serious and important I wish to call your attention to the fact that upon the Judiciary committee

there now sits a gentleman who has given special study to a similar phase of municipal government relating to the city of Auburn, the gentleman from Auburn, Mr. Wing; and also upon the Judiciary committee are three or four gentlemen who, two years ago, considered and studied similar questions concerning the city of Portland. I refer to the gentleman from Portland, Mr. Haie, the gentle-man from Portland, Mr. Nichols, the gentleman from Portland, Mr. Oakes. and the senator from Cumberland, Mr. Hinckley.

Now I think that these two reasons had weight with the committee on reference of bills. Therefore, Mr. Speaker, I respectfully urge the House not to sustain the motion of my colleague from Lewiston, Mr. Gagne, but to support the order of reference of the committee on reference of bills.

Mr. GAGNE of Lewiston: Speaker, just a few words in favor of sending it to the committee on Legal Affairs. This is not without courtesy to the Judiciary committee, but, fellow members of the House, I like to be on the same footing as my colleague from Lewiston (Mr. Holmes). He has the advantage over me of being a learned lawyer. Now the Legal Affairs committee is composed of lawyers who know the law and I think they have good judgment; and, fellow members, if it goes to the Legal Affairs committee, my colleague, Mr. Holmes, will have to go and plead before that committee the same as I will, and we will be on an equal footing. I feel that this is only justice and I hope you will sustain my motion.

The SPEAKER: The motion before the House is that of the gentleman from Lewiston, Mr. Gagne, who moves that the bill, An Act to establish a Finance Commission of Lewiston be referred to the committee on Legal Affairs. The question is on that Is the House ready for the question?

A viva voce vote being doubted, A division of the House was had.

Seventy-six voting in the affirmative and 54 in the negative, the motion that the bill be referred to the committee on Legal Affairs prevailed.

The SPEAKER: The members will find upon their desk a calendar which shows the matters lying on the table. If any of these matters can be taken from the table, it will expedite business.

On motion by Mr. Hamilton of Caribou, it was voted to take from the table, H. P. No. 418, bill, An Act relating to tax on gasoline, tabled by that gentleman on February 5th, pending reference; and on further motion by the same gentleman the bill was referred to the committee on Ways and Bridges.

On motion by Mr. Oakes of Portland, it was voted to take from the table H. P. No. 9, report of committee on Legal Affairs on bill, An Act to provide for the settlement of estates of Absentees tabled by that gentleman February 5, pending acceptance of report; and on further motion by the same gentleman the report of the committee, ought not to pass, was accepted.

The SPEAKER: The Chair at this time will suggest to the members that the time is drawing to a close for the introduction of matters of private and special legislation, and the members will bear in mind that the "close time" begins at four P. M. next Monday. While that rule that we have adopted applies only to private and special legislation, there is no reason for delay or hesitation in the introduction of matters relating to general legislation; and if members contemplate the introduction of such bills, it would facilitate our business if they should be prompt in introducing the same. The indications are at present that we will sit on Friday of this week. The Clerk will read the notices.

On motion by Mr. Morse of Oakland,

Adjourned until ten o'clock tomorrow morning.
