#### HOUSE

#### Friday, Feb. 20, 1925.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. McWhorter of Augusta.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Bill, an act to divide the town of Jonesport and incorporate the town of Beals. (S. P. 285) (S. D. 103)

In the Senate referred to the committee on Towns.

In the House, on motion by Mr. Mansfield of Jonesport tabled pending reference in concurrence.

From the Senate: The following order:

Ordered, the House concurring, that when the Senate and House adjourn, they adjourn to meet Tuesday forenoon, February 24, at ten o'clock.

In the Senate read and passed.

Mr. LITTLEFIELD of Kennebunk: MI. Speaker, what is the idea in coming in in the morning? We do not have time to get here unless we come the night before.

The SPEAKER: Does the gent'eman wish to speak to the passage of the order?

Mr. LITTLEFIELD: No, Mr. Speaker, I just wondered if we could not make it in the afternoon rather than in the fournoon.

The SPEAKER: The Chair would suggest that various hearings are to be held in the afternoon.

Thereupon the order received passage in concurrence.

From the Senate: Report of the committee on Agriculture reporting "ought to pass' on bill, an act to amend Section 4 of Chapter 134 of the Public Laws of 1923, relating to the control and suppression of the European Corn Borer. (S. P. 26) (S. D. 23)

In the Senate report read and accepted and the bill passed to be engrossed.

In the House, on motion by Mr. White of Bowdoinham, tabled pending acceptance of the report in concurrence.

From the Senate: Bill, an act requiring owners of certain motor vehicles and trailers to furnish security for their civil liability on account of personal injuries and property damage caused by their motor vehicles and trailers. (S. P. 131) (S. D. 57)

This was referred in the House on February 18 to the Committee on Mercantile Affairs and Insurance in non-concurrence.

It comes from the Senate that body insisting on its former action, whereby the bill was referred to the committee on Judiciary and asking for a committee of conference with the following members appointed on its part: Senators Cram of Cumberland, Hussey of Aroostook and Anthone of Cumberland.

On motion by Mr. Wing of Auburn, the House voted to adhere to its former action and join in the committee of conference, and the Chair appointed as conferees on the part of the House Representatives Sargent of Sedgwick, Drake of Bath and Pendleton of Islesboro.

Reports read and accepted and sent up for concurrence.

Mr. Gagne from the Committee on Federal Relations reported "Ought to pass' on Bill "An Act to authorize the Filing by the United States in the several counties of this State of Notices of Liens for Taxes" (H. P. No. 192) (H. Do. No. 34)

Report was read and accepted and the Bill having already been printed, was read twice under suspension of the rules and tomorrow assigned.

Mr. Flint from the Committee on Inland Fisheries and Game reported same on Bill "An Act to repeal the Bounty on Bears. (H. P. No. 109.)

Mr. Nichols from the Committee on Judiciary reported same on Bill "An Act authorizing the Judge of the Portland Municipal Court to fix the time for holding Criminal Sessions." (H. P. No. 453.)

Mr. Oakes from same Committee reported same on Bill "An Act ot amend the Charter of the City of South Portland. (H. P. No. 410.)

Mr. Bartlett from the Committee on Legal Affairs reported same on Bill "An Act relative to the Bangor Public Library. (H. P. No. 159.)

Mr. Seidel from same Committee reported same on Bill "An Act authorizing the Clerk of Courts of Lincoln County to act as Clerk of Lincoln Municipal Court." (H. P. No. 68.) Mr. Comins from the Committee on Public Utilities reported same on Bill "An Act to extend the Charter of the Quebec Extension Railway Company." (H. P. No. 68.)

#### Orders of the Day

On motion by Mr. Curtis of Brewer, it was voted to take from the table House  $\supset$  oc. 180, a joint order requiring railroads to file list of salaries, etc., tabled by the gentleman February 19, pending passage, and that gentleman yielded the floor to the gentleman from Windham, Mr. Boody.

The SPEAKER: The gentleman from Windham, Mr. Boody, has the floor, the matter in hand being House Doc. 180, order relative to the furnishing of information by railroads, the pending question being the motion of the gentleman from Windham that this order have passage. Debate is now in order on the question of the passage of this order.

Mr. BOODY: Mr. Speaker, do I understand that it is for me to lead on that after I made my statement yesterday?

The SPEAKER: As the gentleman wishes.

Mr. BOODY: The remarks that I made yesterday cover the matter with me unless some opposition may develop; then I would wish to say more.

The SPEAKER: The pending question is the passage of this order.

Mr. BOODY: I move its passage.

The SPEAKER: Is it the pleasure of the House that this order have passage?

The question being called for, a viva voce vote was taken, and the order failed of passage.

On motion by Mr. Fuller of Southwest Harbor it was voted to take from the table report of the committee on Sea and Shore Fisheries on bill, an act to establish closed time on lobsters west of Petit Manan Point, H. P. 126, tabled by that gentleman February 13, pending acceptance of the report; and on further motion by the same gentleman the report ought to pass was accepted.

On motion by Mr. Holmes of Lewiston, it was voted to take from the table report of committee on Salaries and Fees on an act to increase the salaries of county commissioners for Cumberland county (S. P. 44) tabled by that gentleman February 12, pending acceptance in concurrence, and that gentleman moved the acceptance of the report in concurrence.

Mr. HALE of Portland: May I ask, Mr. Speaker, what the report of the committee is?

The SPEAKER: The report of the committee is "ought to pass in new draft." The new draft has been printed as Sen. Doc. No. 46.

On motion by Mr. Hale of Portland, the report was re-tabled, pending acceptance in concurrence.

On motion by Mr. Martin of Augusta, it was voted to take from the table report of the committee on Judiciary on bill an act relating to fees for registration of motor vehicles, being Senate Doc. 36, tabled by that gentleman February 19, pending acceptance of the report.

Mr. MARTIN of Augusta: Mr. Speaker, i now offer House Amendment A and move its adoption.

The SPEAKER: The matter is not yet ready for amendment, as the report has not yet been accepted. If the gentleman desires, he can move acceptance of report, the bill take its two several readings, and then offer the amendment.

Thereupon on motion by Mr. Martin of Augusta the report was accepted and the bill being an act to amend Paragraph A of Section 47 of Chapter 211 of the Public Laws of 1921, relative to fees for registration of vehicles, had its two several readings at this time.

Mr. MARTIN of Augusta: I now offer House Amendment A and move its adoption.

#### House Amendment "A" to S. Doc. 36

An Act to Amend Paragraph "A" of Section forty-seven of Chapter two hundred and leven of the Public Laws of nineteen twenty-one, relative to fees for registration of vehicles.

Said Act is hereby amended by adding after the word "registered" in line four, section forty-seven, paragraph "A", the words "or licensed." So that said paragraph "A" shall

So that said paragraph "A" shall read as follows: "Motor vehicles regularly used for livery or hire shall pay double the above fees, provided, however, that private automobiles occasionally employed for use at funerals by a duly registered or licensed undertaker, shall not be subject to such double fees."

On motion by Mr. Littlefield of Kennebunk, the bill was tabled pending adoption of House Amendment A.

The SPEAKER: Can any further business under orders of the day be accomplished? (No response) There are several matters pending reference to committees. (Again no response). If there is no further business under orders of the day, the Clerk will read the notices.
