Wednesday, March 4, 1925.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Webber of

Hallowell.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

Senate Bills in First Reading

S. P. No. 128: An Act to amend Chapter 62 of the Public Laws of 1923, relating to the production and sale of certified seed.

S. P. No. 188: An Act to amend Section 5 of Chapter 37 of the Revised Statutes, as amended by Chapter 66 of the Public Laws of 1919, relating to the registration of milk dealers.

S. P. No. 161: Joint Resolution, favoring the acquiring and maintenance by the United States government of a suitable vessel, constructed and equipped especially as an ice breaker, to be stationed and operated solely on the Maine coast.

S. P. No. 111: An Act to prohibit ice fishing in Kennebunk Pond, in

the county of York.

S. P. No. 58: Resolve, to double stack the State Library.

From the Senate: Bill, an act relating to warning signs at grade crossings, House Paper 886, (H. D. 212) which was referred to the committee on Judiciary in the House, February 24.

Comes from the Senate, referred to the committee on Public Utilities

in non-concurrence.

In the House, on motion by Mr. Wing of Auburn, that body voted to recede and concur with the Senate in the reference of this bill to the committee on Public Utilities.

From the Senate: Resolve to reject the proposed Twentieth Amendment to the Constitution of the United States, being the Child Labor Law, so-called, H. P. 306, (H. D. 61), which was referred to the committee on Legal Affairs in the House February 19.

Comes from the Senate that body

insisting on its former action whereby the bill was referred to the committee on Labor, and asking for a committee of conference, with the following members appointed on its part, Senators Smith of Somerset, Wadsworth of Kennebec and Bond of Lincoln, the House having voted to adhere to its action on February 27.

In the House, on motion by Mr. Hale of Portland, that body voted to join in the committee of conference and the Chair appointed as conferences on the part of the House, Representatives Hale of Portland, Sturgis of Auburn, and Dudley of Woodstock.

The Chair presents Bill, "An Act Relating to Clerk Hire in the Office of Clerk of Courts, Knox County", H. P. 21 (H. D. 79), tabled on February 25th by Mr. Thompson of Rockland, pending second reading; and on motion by the same gentleman the bill was re-tabled.

The Chair presents "Resolve to Appropriate Money for Co-operative Agricultural Work between the College of Agriculture of the University of Maine and the United States Department of Agriculture", H. P. 184 (H. D. 33), tabled on February 25th by Mr. White of Bowdoinham; and en motion by the same gentleman the resolve was passed to be engrossed.

The Chair presents "Resolve in Favor of Scientific Investigation in Agriculture in Aroostook County" H. P. 89 (H. D. 23) tabled on February 25th by Mr. White of Powdoinham, pending final passage; and on motion by the same gentleman the resolve was finally passed. The Chair presents Bill, "An Act

to Prohibit Plug Fishing in Peabody Pond, in the County of Cumberland", S. P. 77 (S. D. 92) tabled on February 25th by Mr. Bragdon of Perham, pending assignment for third reading.

Mr. BRAGDON of Perham: Speaker, you will notice that on this Tabled List there are three bills similar to this one, and there are also several others of a like nature that are coming in within a very few days and they could all be handled together to the best advantage. I move, therefore, that the bill be re-tabled.

The motion prevailed.

The Chair presents Bill, "An Act Closing Heald Brook and Alder Brook, in Alder Brook Township, and in Soldier Town, so-called, in Somerset County, to All Fishing with Artificial Flies, and to Estab-lish a Daily Limit of Five Pounds of Fish Therein", H. P. 878 (H. D. 208) tabled on February 25th by Mr. Bragdon of Perham, pending assignment for third reading; and on motion by the same gentleman the bill was re-tabled.

The Chair presents Bill, "An Act to Regulate the Appointment of Guardians for Adults and the Appointment of Conservators when the Judge of Probate is Interested, and to Amend Sections Four and Ten of Chapter Seventy-two of the Revised Statutes", H. P. 329 (H. D. 68), tabled on February 25th by Mr. Nichols of Portland.

Mr. NICHOLS of Portland: Speaker, I move that the bill now

have its first reading.

Mr. DWINAL of Camden: Mr. Speaker, according to the Record of February 25th, the pending question there is given as "assignment for third reading"

The SPEAKER: The Chair will ascertain from the original. The gentleman from Camden (Mr. Dwinal) is correct. The pending question is third reading.

On motion by Mr. Nichols of Portland, the bill received its third reading and was passed to be engrossed.

The Chair presents Bill, "An Act Relating to Fishing in Certain Waters in Franklin and Oxford Counties", H. P. 317 (H. D. 219), tabled on Feb. 26th by Mr. Bragdon of Perham pending assignment for third reading; and on motion by the same gentleman the bill was retabled.

The Chair presents "Resolve Making Appropriation for the Study and Control of the Fruit or Blueberry Fly in Maine", S. P. 27 (S. D. 24), tabled on February 26th by Mr. Sturgis of Auburn, pending second reading; and on motion by the same gentleman the resolve received its second reading and was passed to be engrossed.

The Chair presents Majority Re-ort "Ought not to Pass" and port Minority Report "Ought to Pass" on Bill, "An Act to Change the Name of Bryant Pond, in Oxford County, to Lake Christopher," tabled on February 27th by Mr. Greenleaf of Auburn. pending acceptance

either report.
Mr. GREENLEAF of Auburn: Mr. Speaker, I have been asked by the proponents of this bill to re-table it as they expect a new development in this matter, and we are unable to assign it at this time.

Thereupon, on motion by Mr. Greenleaf of Auburn, the above reports were re-tabled pending acceptance of either report.

The Chair presents bill, an act relating to rate of interest on farm loans, S. P. No. 330 (S. D. 120) tabled by Mr. Leland of Sangerville, February 27, the pending question being the motion of the gentleman from Strong, Mr. Eustis, that the bill be referred to the committee on Banks and Banking.

Mr. LELAND of Sangerville: Mr. Speaker, I yield to the gentleman from Strong, Mr. Eustis.
Mr. EUSTIS of Strong: Mr.

Speaker, I now move that we concur with the Senate and refer the bill to the committee on Agriculture.

Thereupon, the motion of gentleman from Strong, Mr. Eustis, prevailed to concur with the Senate in the reference of the bill to the committee on Agriculture, taking precedence over the former motion of the same gentleman to refer to the committee on Banks and Banking.

The Chair presents resolve authorizing Michael Burns to bring a suit against the State, H. P. No. 201 (H. D. 230), tabled by the gentleman from Portland, Mr. Nichols, March 3rd, pending its second reading; and on further motion by the same gentleman the resolve was retabled, and especially assigned for tomorrow morning.

The Chair presents, bill, an act to increase the salaries of County Commissioner for Cumberland county, S. P. No. 44 (S. D. 46), tabled by the gentleman from Portland, Mr. Hale, March 3rd, pending assign-

ment for third reading.

Mr. HALE of Portland: Mr. Speaker and members: I move the indefinite postponement of this bill, and I wish to address myself as briefly as possible to this motion which I make in pursuance of conclusions reached at a meeting of the Cumberland County Delegation last evening. The Cumberland County Delegation, while it recognizes the merit of the bill, realizes the importance of our program of economy and feels that this bill should yield to that program: and I hope the motion will prevail.

Thereupon, the motion to indefinitely postpone the above bill

prevailed.

The SPEAKER: The Chair presents order for investigation of condition of labor in the textile industry, tabled by Mr. Cummings of Portland, March 3rd, pending passage. The matter has not yet been printed and will, therefore, remain on the table.

Mr. HOLMES of Lewiston: Mr. Speaker, I ask for enlightenment. Would it not be in order to assign it

at this time?

The SPEAKER: Would the gentleman from Portland, Mr. Cummings, agree to assign that matter to a day certain?

Mr. CUMMINGS of Portland: Mr. Speaker, if I had a copy of the order, I think there would be no objection to assigning it for tomorrow morning, but as I haven't it yet, I am not in position even to present an amendment to the order. I can assure the gentleman from Lewiston (Mr. Holmes) that there is no desire on my part to delay, but am merely looking for information in order to get this thing into shape. If I can get what I want in season to take it from the table tomorrow morning, I will be glad to do it.

Mr. HOLMES: Mr. Speaker, I wish to ask, through the Chair, the gentleman from Portland (Mr. Cummings) whether or not he would agree to assign it for tomorrow morning, with the understanding that if it is not then printed and on our desks, it will be tabled and re-

assigned.

The SEAKER: The gentleman from Portland (Mr. Cummings) has already stated that if he can get a copy of it soon, he will be willing to take it from the table tomorrow morning Probably this will arrive from the printer this afternoon.

Thereupon, the order was re-

tabled.

On motion by Mr. Ham of Wales, Adjourned until ten o'clock tomorrow morning.
