Mr. WING of Auburn: Mr. Speaker, is there any way by which we can expedite the public printing so we can have these various documents on

our desks as printed?

The SPEAKER: The Chair will endeavor to see the printing department this week-end. The Chair will state that from this time on there may be delay in the business of the House due largely to the matter of printing; but where the question before the House pertains solely to the reference of a bill, the matter does not seem so important if the bill is not in the possession of the members. If matters can be referred to a committee, where they will have a hearing, the business will be rushed along better.

Mr. Winn of Lisbon presented the

Ordered, that the Secretary of State have printed at once, and filed, for the use of the members of the Legislature, a list of all registrations to date in the office of the Secretary of State of Legislative Counsel and Agents, the names of the party, parties or corporations employing same, and the legislation concerning which they are employed.

Mr. WING of Auburn: Mr. Speaker, does not the law already provide that the Secretary of State shall report to the House these men? I rise to make the inquiry.

The SPEAKER: The Chair is uncertain whether that is a law or a rule. Has the gentleman consulted the Statutes?

Mr. WING: My remembrance is, Mr. Speaker, that it is a Statute, and that the Secretary of State is required to report from time to time, and the report is read into the Record and ordered printed.

On motion by Mr. Wing of Auburn, the order was tabled, pending passage.

Orders of the Day

On motion of Mr. Thompson of Rockland it was voted to take from the table Senate Paper 204, (S. D. 72) report of the committee on State Lands and Forest Preservation on Resolve authorizing the Land Agent to sell and convey a certain interest of the State in Township 1, Range 7, Penobscot county.

The SPEAKER: The pending question is the acceptance of the report of the committee, which report was "ought to pass in a new draft".

On further motion by Mr. Thompson of Rockland, the report was accepted, and on further motion by the same gentleman, the report was tabled pending first reading.

On motion by Mr. Wing of Auburn, it was voted to take from the table the order presented by the gentleman from Lisbon, Mr. Winn, tabled earlier in the session.

Mr. WING: Mr. Speaker, I have ascertained that there is no provision of law as I indicated to the House. The Secretary of State has informed me that these lists were printed in 1921 which was the reason for the inquiry which I made because I remembered that they were printed in the Record; and with this explanation I now move the passage of the order.

Thereupon, the order received passage.

Mr. WING: Mr. Speaker, there is

in the possession of the committee on Judiciary House Paper 731, an act in relation to state funds for charity patients in public and private hospitals. I have received numerous calls for copies of this document, and an examination of it shows that it was ordered printed; but, through some misunderstanding it has not been printed, I move you, sir, that the House request its return to this body for the purpose of printing, and that there be printed 500 copies.

The SPEAKER: As the Chair recalls it, the gentleman from Strong, Mr. Eustis, who is absent today, introduced that measure, and subsequently stated to the House that as he intended to prepare a new draft, he desired to economize on the printing by not ordering the original bill printed. Whether that new draft has been submitted or not the Chair does not know. Is there any member present who has information about that?

Mr. HAMILTON of Caribou: Mr. Speaker, a new draft is being prepared in the Judiciary room at the present time.

The SPEAKER: Does the new draft differ materially from the original bill?

Mr. HAMILTON: Just some additions to it.

Mr. WING: Mr. Speaker, the matter is evidently attracting a good deal of attention from public spirited citizens who are interested in the various hospitals.

The SPEAKER: The Chair would suggest that the gentleman either have the committee report it without printing, or prepare an order to recall it from the committee.

Mr. WING: What the Chair has stated with reference to the new draft may perhaps be sufficient explanation, and I will not press the motion.

The SPEAKER: The gentleman withdraws his motion.

On motion by Mr. Littlefield of Kennebunk, it was voted to take from the table Senate Paper 395, Senate Document 145, an act to amend Section 34 of Chapter 211 of the Public Laws of 1921, relative to non-resident motor vehicles; tabled by that gentleman earlier in the session; and on further motion by the

same gentleman, the bill was referred to the committee on Judiciary in concurrence with the Senate.

There being no further business under orders of the day, the Clerk read the notices.

The SPEAKER: The members will bear in mind that Tuesday is the last day for the introduction of

bills. The order is worded "Tuesday after the session." All bills or resolves introduced subsequent to the session of Tuesday next will be referred to the next legislature.

On motion by Mr. Kitchen of Presque Isle,

Adjourned until Tuesday afternoon, March 10, at 4.30 o'clock.
