Tuesday, March 10, 1925.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Skillin of Gardiner.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

No. 265), tabled by that gentleman March 6, pending second reading; and on further motion by the same gentleman the bill received its second reading and tomorrow assigned for third reading.

On motion by Mr. Thompson of Rockland, it was voted to take from the table Resolve authorizing forest commissioner to sell interest of State in Township 1, Range 7, Penobscot county (S. P. No. 371) (S. D. No. 130), tabled by that gentleman March 6, pending first reading; and on further motion by the same gentleman the resolve received its first reading and tomorrow assigned for second reading.

On motion by Mr. Eustis of Strong, it was voted that 500 additional copies be printed of bill, an act in relation to State funds for charity patients in public and private hospitals (H. P. No. 731), reported earlier in the session by the committee on judiciary in a new draft (H. P. No. 1072), making 1000 in all.
