Mr. HINCKLEY of Cumberland: Mr. President, may I ask through the Chair whether or not the child labor amendment has been referred to a committee, or whether it is on the table?

The PRESIDENT: It has been referred.

Mr. Carlton, from the Committee on Interior Waters, on bill "An Act to change the name of Long Pond to Crescent Lake" (S. P. 66), reported that the same ought not to pass.

Report was read and accepted and

sent town for concurrence.

Mr. Buzzell, from the Committee on Agriculture, on bill "An Act to amend Section 4 of Chapter 134 of the Public Laws of 1923 relating to the control and suppression of the European Corn Borer" (S. P. 26) (S D. 23) reported that the same ought to pass.

The report was accepted, and on motion by Mr. Wadsworth of Kennebec, the bill was tabled pending

first reading.

Mr. Lord, from the same committee, on "Resolve, making appropriation for the study and control of the fruit or blueberry fly in Maine" (S. P. 27) (S. D. 24) reported that the same ought to pass.

The report was read and accepted. and on motion by Mr. Hinckley of Cumberland, the rules were suspended, and the resolve given its first reading.

On motion by Mr. Wadsworth of Kennebec, the resolve was tabled pending second reading.

Mr. Carlton, from the Committee on Interior Waters, on bill "An Act to change the name of Pleasant Pond in the towns of Whitefield and Jefferson, to Clary Lake" (S. P. 16) reported that the same ought to pass.

The report was read and accepted and the bill laid upon the table for printing under the joint rules.

The PRESIDENT: The Chair lays before the Senate Resolve in favor of Lester D. Eaton, warden of the State prison, returned to the Senate pursuant to the order presented by the Senator from Somerset, Senator Hclley. The Chair recognizes the Senator from Franklin. Senator Morrison:

Mr. MORRISON: Mr. President, I see that the Senator from Somerset, who introduced the order yesterday morning is not present, but I understand he had a talk with the chairman of the committee on state prison and that it was perfectly satisfactory to him that this matter go along. I may say that this is an important matter, that is, important to one person at least, and that is the warden of the State prison, Mr. Eaton.

The resolve is to reimburse him for money paid to the prisoners during the months of October, November and December of last year. And as you all know, the Attorney General has ruled that such payment was illegal. This payment was made by the warden of the State prison under explicit orders from the Governor and Council, so that he is entirely blameless in the matter. order to have his accounts allowed he must make this up out of his own pocket, and therefore it seems to me the matter should go along as speedily as possible.

I move you, Mr. President, that the bill be recommitted to the committee on State prison.

The motion was agreed to.

Orders of the Day

Mr. SPEIRS of Cumberland: Mr. President, I move to reconsider the vote whereby we referred to committee on taxation H. D. 44, 89 and 74 and S. D. 58.

The PRESIDENT: The Chair would ask the Senator from Cumberland, Senator Speirs, if he will not make one motion at a time?

Mr. SPEIRS: I thought I would

save time, Mr. President, by bringing them all in at once.

I move we reconsider the vote whereby we referred to the committee on taxation, H. D. 44.

Mr. ALLEN of York: Mr. President, do I understand that I have permission to speak on this question?

The PRESIDENT: I do not know

any reason why not. Mr. ALLEN: Mr. Mr. President, the interest of harmony, and that there may be no misunderstanding between the committee on taxation and the committee on ways and bridges. I wish at this time to withdraw any objections that I may have made to the reference of this bill to the committee on taxation and the committee on ways and bridges in conjunction, as I understand that is the motion to be.

The motion to reconsider the vote whereby H. D. 44 was referred to the committee on taxation was agreed to, and on further motion by the same Senator the bill was referred to a joint committee on taxation

and ways and bridges.

Mr. SPEIRS of Cumberland: President, I now move that we reconsider the vote whereby we referred to the committee on taxation H. D. 89.

The motion was agreed to, and on further motion by the same Senator the bill was referred to a joint committee on taxation and ways and bridges.

Mr. SPEIRS of Cumberland: Mr. President, I now move that we reconsider the vote whereby H. D. 74 was referred to the committee on taxation.

The motion was agreed to, and on further motion by the same Senator the bill was referred to a joint committee on taxation and ways and bridges.

Mr. SPEIRS of Cumberland: Mr. President, I now move that we reconsider the vote whereby S. D. 58 was referred to the committee on taxation.

The motion was agreed to, and on further motion by the same Senator the bill was referred to a joint committee on taxation and ways and bridges.

Mr. FINCKLEY of Cumberland: Mr. President I move to take from the table S. D. 132, Resolve pertaining to Earl Holbrook, tabled by me this morning.

The motion was agreed to, and, on further motion by the same Senator, the Senate voted to recede and concur with the House in referring the resolve to the committee on claims.

Mr. HINCKLEY of Cumberland: Mr. President, I move we reconsider our vote whereby the petition refer-ring to the child labor amendment was referred to the committee on labor, (S. D. 199). You will recall I asked if this had been referred to a committee and I received an affirmative reply. I found on House calendar, according to the recollection of the matter, that both these matters are on the table in the House. For that reason, I move we reconsider our vote whereby we referred this matter to the committee on labor.

The motion was agreed to.
Mr. WADSWORTH of Kennebec Mr. President, may I have that read?

(Petition read by the Secretary.) Mr. HINCKLEY: Mr. President, I now move that this matter be tabled, and I will explain that my only reason for it is this: This was referred to the committee on labor; -- these amendments have not yet been referred to any committee and this resolution or petition should go to the committee to which these bills or resolves are referred, and I simply want it on the table pending, so that it will go to the proper committee.

Mr. WADSWORTH of Kennebec: Mr. President, I thought that these two resolutions had been referred to the committee on labor. I may be in error.

Mr. SMITH of Somerset: President, I would say to the Senator from Kennebec, Senator Wadsworth, that the matters were referred to the committee on labor in the Senate, but are held up on the table in the House.

The PRESIDENT: The pending question in the Senate is on the motion of the Senator from Cumberland, Senator Hinckley, that this petition be laid on the table.

The motion was agreed to.

Mr. CLARKE of Hancock: Mr. President, I move to take from the table S. P. 173.

The motion was agreed to, and on further motion by the same Senator, the bill was referred to the committee on Judiciary.

Mr. CARTER of Androscoggin: Mr. President, I move that we take from the table H. D. 76.

The motion was agreed to, and on further motion by the same Senator, H. D. 76, Resolve for the appointment of one or more persons to represent the State in certain proposed changes in freight rates affecting the people of the State, was referred to the committee on Public Utilities in concurrence with the House.

Mr. CARTER of Androscoggin: Mr. President, I now move that H. D. 90, An Act to prohibit boating and fishing from boats on Lake Auburn, be taken from the table.

The motion was agreed to, and on further motion by the same Senator the bill was referred to the committee on Judiciary in concurrence with the committee on Reference.

The PRESIDENT: The Chair will state that the Senate will recess subject to call.

(After Recess)

Additional papers from the House disposed of in concurrence.

From the House: Ordered, the Senate concurring, that the time for presenting special and private legislation be extended to include February 17, 1925, and that no bill, act or resolve pertaining to private legislation be received after four o'clock February 17, 1925.

In the House read and passed,

In the Senate, on motion by Mr. Hinckley of Cumberland, the Senate voted to concur with the House in the passage of the order.
