SENATE

Thursday, March 12, 1925. Senate called to order by the President.

Prayer by Rev. Langdon Quimby of Gardiner.

Journal of previous session read and approved.

Papers from the House disposed of in concurrence.

From the House: An Act giving additional powers to the Public Utilities Commission. (H. D. 316)

In the House: Referred to the Committee on interior waters.

In the Senate: On motion by Mr. Carter of Androscoggin, tabled pending reference to a committee.

From the House: The committee on salaries and fees, on an Act increasing the salary of the postmaster of the House (H. P. 791) reported that the same ought to pass.

In the House: Indefinitely post-poned.

In the Senate: On motion by Mr. Hinckley of Cumberland, the Senate non-concurred with the house on indefinite postponement, accepted the report of the committee "ought to pass" and asked for a committee of conference.

The Chair appointed as such committee of conference on the part of the Senate, the Senator from Cumberland, Senator Hinckley, the Senator from Somerset, Senator Holley, and the Senator from York, Senator Roberts.

From the House: The same committee, on an Act relating to the salary of the county attorney for York county (H. D. 299) reported that the same ought not to pass.

In the House: the report of the committee was accepted.

In the Senate: The report of the committee was accepted in concurrence.

Mr. ALLEN of York: Mr. President, I move that we reconsider the vote whereby we adopted the report of the committee, just read.

The motion was agreed to, and on further motion by the same Senator, the matter was tabled, pending acceptance of the report of the committee. From the House: The majority from the Committee on Sea and Shore Fisheries, on An Act to amend Section 35. Chapter 45 of the Revised Statutes, relating to legal size of lobsters and method of measurement (H. D. 120) reported that the same ought not to pass.

In the House: The majority report was accepted.

In the Senate: On motion by Mr. Lord of York, tabled pending acceptance of either report.

From the House: The Committee on Education, on An Act Relating to Teachers' Pensions (H. D. 135) reported that the same ought to pass.

The report was accepted in concurrence, and on motion by Mr. Allen of York, the rules were suspended and the bill was given its first reading.

From the House: The Committee on Judiciary, on An Act to Amend Sections 11, 12 and 13 of Chapter 6 of the Revised Statutes relating to Primary Elections (H. D. 48) reported the same in a new draft, under the title of An Act to Amend an Act: To Amend Sections 11, 12, 13 and 38 of Chapter 6 of the Revised Statutes, Relating to Primary Elections (H. D. 296) and that it ought to pass.

The report was accepted in concurrence, and on motion by Mr. Hussey of Aroostook, the rules were suspended and the bill was given its first reading.

From the House: The same Committee, on An Act to Incorporate the Aroostook Real Estate Title Company (H. D. 169) reported that the same ought to pass.

The report was accepted in concurrence, and on motion by Mr. Wilson of Aroostook, the rules were suspended and the bill was given its first reading. From the House: The same committee on An Act to amend the charter of the city of Hallowell to provide that the municipal year begin on the second Monday of January biennially (H. D. 182), reported that the same ought to pass.

The report was accepted in concurrence, and on motion by Mr. Allen of York, the rules were suspended and the bill was given its first reading.

From the House: The committee on Legal Affairs, on An Act to incorporate Houston Brook Driving Company (H. D. 299), reported that the same ought to pass.

The report was accepted in concurrence, and on motion by Mr. Case of Washington, the rules were suspended and the bill was given its first reading.

From the House: The committee on Public Utilities, on An Act to authorize the Caribou Water, Light and Power Company to lease and assign to the Great Northern Paper Company for a period of 30 years, its right to maintain piers and booms and to hold and sort logs and other lumber granted by Chapter 178 of the Private and Special Laws of Maine of 1907 (S. D. 61), reported that the same ought to pass.

The report was accepted in concurrence, and on motion by Mr. Crafts of Piscataquis, the rules were suspended and the bill was given its first reading.

From the House: The committee on Salaries and Fees, on An Act relating to clerk hire in the office of Clerk of Courts, Knox county (H. D. 79), reported that the same ought to pass.

The report was accepted in concurrence, and on motion by Mr. Walker of Knox, the rules were suspended and the bill was given its first reading.

From the House: The same committee, on An Act to increase the salary of the County Attorney for Knox County, reported the same in a new draft, under the same title (H. D. 292) and that it ought to pass.

The report was accepted in concurrence, and on motion by Mr. Walker of Knox, the rules were suspended and the bill was given its first reading.

From the House: The same committee, on An Act to increase the salary for clerk hire in the office of Register of Probate, Knox county, from \$572.00 to \$720.00 (H. D. 265) reported that the same ought to pass.

The report was accepted in concurrence, and on motion by Mr. Walker of Knox, the rules were suspended and the bill was given its first reading.

From the House: The same committee, on An Act relating to the County Commissioners of Waldo county (H. P. 335) reported the same in a new draft, under the same title (H. D. 290) and that it ought to pass.

The report was accepted in concurrence, and on motion by Mr. Buzzell of Oxford, the rules were suspended and the bill was given its first reading.

From the House: The same committee, on An Act relating to clerk hire in the Registry of Probate of York county (H. P. 634), reported the same in a new draft, under the same title (H. D. 295) and that it ought to pass.

The report was accepted in concurrence and on motion by Mr. Allen of York, the rules were suspended and the bill was given its first reading.

From the House: The same committee, on An Act relating to the salary of the Judge of Probate of Waldo county (H. P. 638) reported the same in a new draft, under the same title (H. D. 291) and that it ought to pass.

The report was accepted in concurrence and on motion by Mr. Buzzell of Oxford, the rules were suspended and the bill was given its first reading.

From the House: The same committee, on An Act relating to the salary of the Clerk of Courts in Washington county (H. D. 297), reported that the same ought to pass.

The report was accepted in concurrence and on motion by Mr. Case of Washington, the rules were suspended and the bill was given its first reading.

From the House: The same committee, on An Act to amend Section 15 of Chapter 15 of the Private and Special Laws of 1923, relating to the salary of the Recorder of Kennebunk Municipal Court (H. D. 298), reported that the same ought to pass.

The report was accepted in concurrence and on motion by Mr. Allen of York, the rules were suspended and the bill was given its first reading.

From the House: The same committee, on An Act to increase the salary of the clerks in the office of the register of probate for Oxford county (H. P. 796), reported the same in a new draft, under the same title (H. D. 294) and that it ought to pass.

The report was accepted in concurrence, and on motion by Mr. Buzzell of Oxford, the rules were suspended and the bill was given its first reading.

From the House: The same committee, on An Act relating to the salary of the sheriff of Sagadahoc county (H. P. 797), reported the same in a new draft, under the same title (II. D. 293), and that it ought to pass.

The report was accepted in concurrence, and on motion by Mr. Case of Washington, the rules were suspended and the bill was given its first reading.

From the House: The committee on sea and shore fisheries on An Act to extend the open time for smelt fishing in the tide waters of the Penobscot River and its tributaries (H. D. 88), reported that the same ought to pass.

The report was accepted in concurrence, and on motion by Mr. Chalmers of Penobscot, the rules were suspended and the bill was given its first reading.

On motion by Mr. Wadsworth of Kennebec, the rules were suspended and that Senator introduced out of order the report of the committee on appropriations and financial affairs, reporting "ought to pass" on resolve appropriating moneys for the payment of certain claims and department overdrafts for which no legislative appropriation has been made and to provide for the carrying on of the activities and departmental expenses for the remaining months of the fiscal year ending June 30th, 1925, and for other purposes.

On further motion by the same Senator the report was accepted.

The resolve was then tabled for printing under the joint rules.

Mr. Crafts, from the committee on Inland Fisheries and Game, on An Act to regulate fishing in the brooks and streams of the State (H. D. 143), reported the same in a new draft, under the title of An Act to regulate fishing for trout and landlocked salmon in the brooks and streams of the State (S. P. 524) and that it ought to pass.

The same Senator, from the same committee, on An Act to fix a uniform date for the filing of annual reports of hunters and trappers, camp proprietors and other licensees of the Department of Inland Fisheries and Game and to amend Section 3 of Chapter 173 of the Public Laws of 1919, as amended by Chapter 121 of the Public Laws of 1923 (S. P. 223) reported the same in a new draft, under the same title (S. P. 525) and that it ought to pass.

The same Senator, from the same committee, on An Act to prohibit the taking of firearms into unorganized townships during closed season on partridge or ruffed grouse, so-called (H. D. 140) reported the same in a new draft, under the title of An Act to prohibit the taking of fire arms into unorganized townships between September 10th and December 10th of each year (S. P. 526) and that it ought to pass.

The reports were accepted and the bills tabled for printing under the joint rules.

ORDERS OF THE DAY

Mr. CARTER of Androscoggin: Mr. President, yesterday I laid upon the table Senate Document 486, bill, An Act granting to the highway commission control of pipes. pole lines, etc., which was rather a long bill, and 500 copies were ordered printed; I would now like to make a motion that these be printed while the bill is still upon the table, in order that they may be in the hands of the Senate.

On motion by Mr. Carter this bill was taken from the table, and on further motion by the same Senator 500 copies were ordered printed, while the bill is tabled, pending its reference to a committee.

(At this point the President resumed the Chair).

On motion by Mr. Chalmers of Penobscot, House Document 273, bill, An Act to increase the salaries of the judge and recorder of the Millinocket Municipal Court, was taken from the table.

The pending question being the first reading of the bill.

On further motion by the same Senator the bill received its first reading and was assigned for tomorrow for its second reading.

On motion by Mr. Powers of Aroostook, the vote was reconsidered whereby H. D. 497, bill, An Act relating to the distribution of personal estate was passed to be engrossed this morning.

On further motion by the same Senator the bill was tabled pending its passage to be engrossed. On motion by Mr. Holley of Somerset, the rules were suspended and that gentleman introduced out of order the following order:

Ordered, That a message be sent to the House proposing a joint convention to be held forthwith in the Hall of the House for the purpose of listening to an address by Brigadier General Herbert M. Lord, Director of the Budget of the United States.

'The order received a passage.
The Secretary was then instructed to convey the message to the House.

Subsequently the Secretary reported that he had delivered the message with which he was charged.

Message From The House

The Clerk of the House: Mr. President, I am charged with a message from the House addressed to your Honorable body announcing that the House concurs in the proposition of the Senate for a joint convention of the two branches of the legislature to be held forthwith in the Hall of the House.

The PRESIDENT: The Senate

hears the message.

Thereupon the Senate proceeded to the Hall of the House for a joint convention.

(The proceedings of the joint convention will be found in the House record).

IN THE SENATE

The PRESIDENT: We now come to the matters upon the Senate calendar, and are there any matters on the calendar which can be disposed of today, if nothing more than to take them off of the table and put them on again? It is now getting on towards the last part of the session.

Mr. WALKER of Knox: Mr. President, I would like to introduce, under a suspension of the rules, an order out of order. I would suggest that the first part of the address to which we have just listened, that part relating to the State of Maine, be printed, and that at least a thousand copies be printed in order that they may be distributed among the people of the State of Maine.

The PRESIDENT: The Chair will state that he thinks the suggestion of the Senator from Knox, Senator Walker, is a very good one. However, the Chair does not understand why only the first part of the address should be printed, and neither does the Chair think that one thousand copies will be enough.

Mr. SMITH of Somerset: Mr

I resident, I would like to make an amendment to the order by suggesting that the complete address be printed and that 2500 copies be printed.

The PRESIDENT: The Chair will suggest that we should have a writ-

ten order.

Mr. HINCKLEY: Mr. President, if I might make a suggestion it would be that 5000 copies be printed, and I do not think that will be too many.

The PRESIDENT: The Chair hears he suggestion of the Senator from Cumberland, Senator Hinckley.

Mr. MAHER of Kennebec: Mr. President, in the meantime, while the order is being prepared, I think it would not be inappropriate for the Senate by a rising vote to express its appreciation of perhaps as masterly an address as has ever been heard within the walls of this State House; and I would move that a rising vote of appreciation be extended in recognition of the wonderful address of Brigadier General Lord.

The PRESIDENT: The Senate has heard the motion of the Senator from Kennebec, Senator Maher. All those in favor of the motion will rise.

A rising vote was taken, and the motion was declared carried unanimously.

On motion by Senator Walker of Knox, the rules were then suspended and that Senator introduced out of order the following order:

Ordered, That the full address of Brigadier General Lord, Director of the United States Budget, be printed and the number of copies be five thousand.

The order received a passage.

The PRESIDENT: Are there any other matters that we can take up today? If not a motion to adjourn will be in order.

On motion by Mr. Holley of Somerset.

Adjourned until tomorrow morning at ten o'clock.
