HOUSE

Thursday, January 27, 1927. The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. McAllister of Gardiner.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Resolve to appropriate money for the maintenance of the Motor Vehicle Department of the office of the Secretary of State (H. P. 36) (H. D. 12), which in the House was referred to the Committee on Appropriations and Financial Affairs on January 20.

In the Senate, referred to the committee on Ways and Bridges in nonconcurrence.

In the House on motion by Mr. Hale of Portland that body voted to insist on its former action.

Mr. KITCHEN of Presque Isle: Mr. Spcaker, I understand that these matters have to do with the highways of the State of Maine and it is my impression that they should properly be referred to the committee on Ways and Bridges.

Mr. LOWELL of Lincoln: Mr. Speaker, I heartily concur with the sentiment of the gentleman from Presque Isle, Mr. Kitchen, that they should be referred to the committee on Ways and Bridges, and I hope that his motion prveails.

The SPEAKER: The Chair will state that the motion has already been acted upon, and that the gentleman from Presque Isle (Mr. Kitchen) can properly doubt the vote. Does the gentleman so do?

Mr. KITCHEN: Yes sir.

The vote was doubted upon the motion of Mr. Hale to insist in the matter of a reference of the resolve to appropriate money for the maintenance of the Motor Vehicle Department of the office of the Secretary of State to the committee on Appropriations and Financial Affairs.

Mr. ROUNDS of Portland: Mr. Speaker, I move that that matter lie on the table.

Mr. WING of Auburn: Mr. Speaker, I respectfully ask for a division. A division of the House was had. Mr. GREENLEAF of Auburn: Mr. Speaker, it is very evident from reading this resolve that it has nothing to do with the maintenance of roads and bridges, but really has to do with the work of the office of Secretary of State. I most certainly think it should go to the committee on Judiciary.

The SPEAKER: On the motion of the gentleman from Portland, Mr. Rounds, 23 have voted in the affirmative and 76 in the negative, and the motion is lost. The question now before the House is upon the motion of the gentleman from Portland, Mr. Hale in which the vote has been doubted. The reference of the House originally in this matter was to the committee on Appropriations and Financial Affairs, and the Senate in non-concurrence referred it to the committee on Ways and Bridges. The motion of the gentleman from Portland, Mr. Hale, was to insist, and the vote that has been doubted.

Mr. KITCHEN of Presque Isle: Mr. Speaker, if in order, I move that we recede and concur with the Senate in the reference of this matter to the committee on Ways and Bridges.

Mr. WING of Auburn: Mr. Speaker, I respectfully ask for a division.

A division of the House being had, 68 voting in the affirmative and 55 in the negative, the motion to recede and concur with the action of the Senate prevailed.

Senate Order, out of order.

Ordered, the House, concurring, that when the Senate and House adjourn, they adjourn to meet Tuesday, February 1, at 4.30 o'clock in the afternoon.

In the Senate, read and passed.

In the House, read and passed in concurrence.

From the Senate: Resolve to appropriate money for the maintenance of State Highway Police, (H. P. 38) (H. D. 14) which by the House was referred to the committee on Appropriations and Financial Affairs on January 20, comes from the Senate, referred to the committee on Ways and Bridges in non-concurrence.

Mr. HALE of Portland: Mr. Speaker, I move that we insist, and I desire to address the House on the motion.

The SPEAKER: The House will hear the gentleman:

Mr. HALE: Mr. Speaker, this is a resolve proposing an appropriation of \$125,000 for the fiscal year ending June 30, 1928 and \$125,000 for the fiscal year ending June 30, 1929, for salary, compensation and clerk hire of the State Highway Police and for expenses incurred in the performance of their official duties. The whole resolve provides solely for an appropriation of an amount which you are going to give the Highway Police and the manner in which it is to be given. It should go as this House voted it should go, and that the committee on reference of bills recommended it should go, to the committee on Appropriations and Financial Affairs, and I hope the House will support me in insisting on our reference.

Mr. KITCHEN Presque Isle: of Mr. Speaker, I move that this matter lie on the table.

Mr. WING of Auburn: Mr. Speaker, I ask for a division.

Mr. FOSTER of Ellsworth: Mr. Speaker, I am not quite clear on this resolve, but it is my impression-

Mr. WING: I rise to a point of order.

The SPEAKER: The gentleman. will state his point.

Mr. WING: The motion to lay on the table is not debatable.

The SPEAKER: The Chair will state that it has not yet heard enough from the gentleman from the Ellsworth (Mr. Foster) to know whether he is debating the motion or not. If he is rising to debate the motion, of course the point of order of the gentleman from Auburn (Mr. Wing) is well taken.

Mr. FOSTER: Mr. Speaker, I am simply asking for information.

The SPEAKER: The gentleman will state his question.

Mr. WING: Mr. Speaker, I rise to a point or order.

The SPEAKER: The gentleman

will state his point of order. Mr. WING: May I have the record read as to what the gentleman from Ellsworth (Mr. Foster) said?

(Record read)

Mr. WING: In support of my point of order, the "impression" of the gentleman from Ellsworth < rtainly may be argument.tive.

The SPEAKER: The Chair sustains the point of order of " gentleman from Auburn, Mr. Wing, if there is to be any debate; but if the gentleman from Ellsworth, Mr. Foster, wishes sil ply to ask a question, the Chair rules that it is proper to so proceed.

Mr. FOSTER: Mr. Spealeer, I am not quite clear, and I wen'd like information regarding the amount of this resolve, \$125,000, my impression being that the Eighty-second Legislature passed a resolve authorizing-

Mr. WING: Mr. Speaker, I rise to point of order.

The SPEAKER: The Chair sustains the gentleman from Auburn (Mr. Wing). The gentleman from Ellsworth (Mr. Foster) can simply ask a question and in no way, directly or indirectly, debate the matter. Do I understand that the gentleman from Ellsworth wishes the resolve read?

Mr. FOSTER: Yes, Mr. Speaker.

The SPEAKER: The Chair will have the Clerk read the resolve.

(Resolve read by the Clerk)

The SPEAKER: The question before the House is upon the motion of the gentleman from Presque Isle (Mr. Kitchen) that this matter lie on the table, and a division has been requested. Those who are in favor of this question will stand and the monitors will return the count.

A division being had,

Sixty-eight voting in the affirmative and 52 in the negative, the motion to table prevailed.

Mr. WING: Mr. Speaker, may T if the gentleman inquire (Mr. Kitchen) will assign a •date upon which we can hear this matter?

Mr. KITCHEN: Wednesday of next week

The SPEAKER: The gentleman from Presque Isle (Mr. Kitchen) wishes it definitely assigned for Wednesday next.

Mr. WING: Do I understand the gentleman to so move?

Mr. KITCHEN: I do.

The SPEAKER: The gentleman from Presque Isle Mr. Kitchen) moves that this matter be definitely assigned for hearing on Wednesday next.

Mr. WING: I think, Mr. Speaker, the House should understand that unless we get down to business we will be here along in June. If this is the pleasure of the House, I have no particular objection because June is a delightful month in Augusta. But these various measures must be

advertised. They must be heard and they must be discussed, and if we delay and delay and delay from one week into the other, we certainly will regret it in the rush of business at the last of this session even if that event takes place in June, and I certainly hope, quite regardless of where these bills go, that we will approach our matters in a somewhat prompt and vigorous way and proceed to discharge the public business with some degree of speed. We have been here a month and we have held no hearings. There are no measures advertised and we are not making progress; and if we proceed to table this measure and that measure and assign it a week hence, we are simply delaying the time when we may finally adjourn. I have no fault to find no criticism to make if the and gentleman wishes to hear certain matters in committee, but I do feel that I have the right to urge the prompt dispatch of the public business. I move to amend the gentleman's motion by substituting for "Wednesday" "Tuesday afternoon."

The SPEAKER: The gentleman from Auburn, Mr. Wing, moves to amend the motion of the gentleman from Presque Isle, Mr. Kitchen, on House Paper No. 38, a resolve to appropriate money for the maintenance of State Highway Police, the original motion being to table to Wednesday, and the amendment to Tuesday.

Mr. KITCHEN: Mr. Speaker, I have no objection to the amendment.

Thereupon the amendment to table until Tuesday afternoon next received passage.

From the Senate: Resolve to appropriate money for the State Highwav Department. (H. P. 37) (H. D. 13), which in the House was referred to the committee on Appropriations and Financial Affairs, January 20

In the Senate, referred to the committee on Ways and Bridges in nonconcurrence.

Mr. KITCHEN of Presque Isle: I move that the House recede and concur with the action of the Senate in the reference of this resolve to the committee on Ways and Bridges.

(At the request of Mr. Hale of Portland, the resolve was read by the Clerk).

Mr. HALE: Mr. Speaker, the House has heard that this resolve calls for an appropriation of \$100,000 for each year, just as the resolve which we have just tabled provides for an appropriation of \$125,000 for each year. Four hundred and fifty thousand dollars is involved in these two resolves. Now if appropriations involving such large sums of money are not to be considered by the committee on Appropriations and Financial Affairs. then I think we shall have a very loose fiscal administration and we are likely to have a very large tax rate. All appropriation measures, if they are to be given proper consideration in this House, must go through one committee and be considered by one committee, and I hope that the House will not support the motion of the gentleman from Presque Isle, Mr. Kitchen.

Mr. KITCHEN of Presque Isle: Mr. Speaker, it certainly is not my intention, and I do not think it is the intention of any member of the Ways and Bridges committee, to have any measure referred to that committee which should not properly come before it; but as you have heard in the reading of the resolve, this has to do with the expenditure of money now derived from the proceeds of the registration of automobiles. It must necessarily come under the supervision of the Ways and Bridges committee in making up and formulating its program for the two years to come; and it seems to me that it is very important that these matters should be referred to that committee.

The SPEAKER: The question before the House is on the motion of the gentleman from Presque Isle, Mr. Kitchen, that the House recede and concur with the Senate in referring House Paper No. 37 to the committee on Ways and Bridges. Those in favor of this motion will say aye; those opposed will say no.

A viva voce vote being doubted,

A division of the House was had,

Thirty-nine voting in the affirmative and 76 in the negative, the motion to recede and concur was lost.

On motion by Mr. Hale of Portland, the House voted to insist upon its former action; and on further motion by the same gentleman it was voted that a committee of conference be appointed.

The SPEAKER: The Chair will announce that committee later in the session.

From the Senate: Bill, An act re-lating to the salaries of the Judge and Recorder of the Bangor Municipal Court, (H. P. 34) which in the House was referred to the committee on Judiciary, January 19.

In the Senate, referred to the committee on Salaries and Fees in nonconcurrence.

Mr. HALE of Portland: Mr. Speaker, I move that the House insist on its former action.

On motion by Mr. Bartlett of Bangor the matter was tabled to be taken up under orders of the day.

From the Senate: Bill, An act relating to appropriation of motor vehicle registration and operators' license fees (H. P. 44) (S. D. 12) which in the House was referred to the committee on Judiciary, January 20.

In the Senate, referred to the committee on Ways and Bridges in non-concurrence.

Mr. KITCHEN of Presque Isle: Mr. Speaker, I move that we recede and concur with the action of the Senate in referring this matter to the committee on Ways and Bridges.

(At the request of Mr. Hale of Portland, the Clerk read the bill)

Mr. HALE: Mr. Speaker, this also relates to the general fiscal policy of the State, and I think the House should insist upon its former reference and should not support the motion of the gentleman from Presque Isle (Mr. Kitchen).

The SPEAKER: The motion before the House is that of the gentleman from Presque Isle (Mr. Kitchen) that the House recede and concur with the action of the Senate, the matter being originally referred to the committee on Judiciary, and the action of the Senate being to refer it to the committee on Ways and Bridges in non-concurrence. Those in favor of the motion of the gentleman from Presque Isle, Mr. Etchen, will say aye; those opposed no. A viva voce vote being had, the

motion was lost. On motion by Mr. Hale of Port-

land, the House voted to insist on its former action; and on further motion by the same gentleman it was voted that a committee of conference be appointed.

The SPEAKER: The Chair announces that committee, being the same gentlemen upon both matters: Messrs. Hale of Portland, Wing of Auburn and Deering of Saco.

Mr. WING of Auburn: Mr. Speaker, I do not wish to decline any service, but I am a member of the committee that undertakes to refer these bills in the first instance. I have already expressed my judgment in trying to suggest a reference of these matters, and I do not think it would be quite fair for me to serve upon this committee of conference in justice to the conflicting interests in the House.

The SPEAKER: The Chair in placing the gentleman from Auburn upon the committee was placing him as representing the majority; but if the gentleman would prefer not to serve, the Chair will honor his wish.

Mr. WING: With your permission,

Mr. Speaker, I decline to serve. Thereupon the Chair substituted in place of the gentleman from Auburn, Mr. Wing, the gentleman from Appleton, Mr. Thurston, on both committees.

From the Senate: Bill, An act relating to appropriation of automobile fees, (H. P. 45) (S. D. 13), which in the House was referred to the committee on Judiciary on January 20.

In the Senate, referred to the committee on Ways and Bridges in nonconcurrence.

Mr. KITCHEN of Presque Isle: Mr. Speaker, I move that we recede anl concur with the action of the Senate in the reference of this bill.

Mr. HALE of Portland: Mr. Speaker, I again ask that the House support its former reference, and I oppose the motion of the gentleman from Presque Isle. If this House is going back on its own action, I think it will shortly lose its prestige; but perhaps that is not a sufficiently broad reason, and I say again that these fiscal measures ought to go to the committee on Appropriations and I hope they will.

The SPEAKER: The Chair will call the attention of the gentleman from Portland, Mr. Hale, to the fact that this House paper was referred to the Committee on Judiciary by the House.

Mr. HALE: Mr. Speaker, I think the House should insist on its former action, and I will further say that if mistakes have been made, they can best be considered in the committee of conference between the

two bodies on all these questions. When such differences of opinion arise between the two bodies, that is the only way they can properly be settled.

The SPEAKER: The question before the House is on the motion of the gentleman from Presque Isle, Mr. Kitchen, that the House recede and concur with the action of the Senate in the reference of House Paper No. 45, the House originally referring it to the committee on Judiciary, and the Senate referring it to the committee on Ways and Bridges in nonconcurrence.

A viva voce vote being had, the

motion failed of passage. On motion by Mr. Hale of Portland, the House voted to insist on its former action; and on further motion by the same gentleman it was voted that a committee of conference be appointed.

The SPEAKER: The Chair will announce the committee of conference later in the session.

From the Senate: Bill an act relating to maintenance of the State Highway Police (H. P. 46) (S. D. 14), which in the House was referred to the Committee on Judiciary, January 20.

Senate: Referred to the In the committee on Ways and Bridges in non-concurrence.

Mr. KITCHEN of Presque Isle: Mr. Speaker, I move that the House recede and concur with the Senate in referring this bill to the committee on Ways and Bridges.

Mr. HALE of Portland: Mr. Speaker, the observations which I made with relation to the other bills apply in equal measure to this bill, and I hope the action of the House will be the same.

The SPEAKER: The question before the House is upon the motion of the gentleman from Presque Işle, Mr. Kitchen, that House Paper No. 46, which was referred in the House originally to the committee on Judiciary and in the Senate to the committee on Ways and Bridges in nonconcurrence, the motion of the gentleman being to recede and concur with the action of the Senate. Those in favor of the motion of the gentleman from Presque Isle, Mr. Kitchen, will say aye; those opposed no.

A viva voce vote being doubted,

A division of the House was had, Twenty five voting in the affirmative and 70 in the negative, the motion of the gentleman from Presque Isle, Mr. Kitchen, was lost.

On motion by Mr. Hale of Portland, the House voted to insist on its former action; and on further motion by the same gentleman it was voted that a committee of conference be appointed.

The SPEAKER: The Chair will appoint as members of that committee, both upon the previous measure and this one, Messrs. Hale of Portland, Thurston of Appleton and Deering of Saco.

From the Senate: Bill, an act to revise the schedule of fees for registration of motor vehicles, H. P. 50, H. D. 17, which in the House was referred to the Committee on Judiciary,

In the Senate, referred to the committee on Ways and Bridges in non-concurrence.

Mr. KITCHEN of Presque Isle: Mr. Speaker, I move that the House recede and concur with the Senate in the reference of this bill to the Ways and Bridges Committee.

Mr. HALE of Portland: Mr. Speaker, I hope that the motion of the gentleman will be lost, and that the House will follow the excellent example which it has already set.

Mr. FOSTER of Ellsworth: Mr. Speaker, I would like to ask, through the Chair, how many more of these

bills there are around? The SPEAKER: The Chair will advise the gentleman that this is the last one it is believed. (Laughter.) The question before the House is on the motion of the gentleman from Presque Isle, Mr. Kitchen, that the House recede and concur with the Senate in the reference of this bill to the committee on Ways and Bridges.

A viva voce vote being had the motion failed of passage.

On motion by Mr. Hale of Portland, the House voted to insist upon its former action; and on further motion by the same gentleman, it was voted that a committee of conference be appointed.

The SPEAKER: And the Chair appoints upon that committee of conference, Messrs. Hale of Portland, Thurston of Appleton and Deering of Saco.

The SPEAKER: There are about 27 resolves now to come before the House which come from the Senate. They involve the claims which were included in the veto of the Governor of this year. The Senate-the Chair will simply state this to show the position of these matters—yesterday passed these matters without reference to any committee, they being simply claims upon which there is no They we all adopted or dispute. put into the blanket resolve of two years ago, approved by the committee and also by the Eighty-second Legislature, and the purpose of not referring them to any committee is simply to expedite business. It is a matter of course entirely up to the desire of the House.

Mr. FOSTER of Ellsworth: Mr. Speaker, out of order, I move that we suspend the rules for the purpose of giving these resolves their first and second readings, without reference to any committee.

Mr. WING of Auburn: Mr. Speaker, I would like to inquire if this is satisfactory to the present committee on Claims. If it is, I have no objection; but I think ze should treat the committee on Claims with courtesy.

Mr. ROUNDS of Portland: Mr. Speaker, we left this with the Senate chairman to confer with the Governor and save people coming here as well as the expense of printing these resolves all over again. We thought we would have this thing go right through so that they may be paid as everybody seems to be willing to have them paid. That is the only explanation I have to make.

Mr. WING: This is satisfactory to your committee?

Mr. ROUNDS: Yes, so far as I know.

Thereupon, on the motion of the gentleman from Ellsworth, Mr. Foster, the rules were suspended, and the following resloves were given their first and second reading, without reference to any committee, and they were passed to be engrossed in concurrence.

The SPEAKER: The Chair will inquire of the gentleman from Portland, Mr. Rounds, whether the committee would desire to have the statement of facts read to the House or if any member of the House wishes the statement of facts read. Mr. ROUNDS: As I said before, the committee left it with the Senate Chairman to fix these up There are some other claims to come in here later that are not in that blanket resolve; but as I understand it, the Senate chairman has fixed the matter up, and I would ask any member of the committee on Claims if I am not correct.

The SPEAKER: The Chair, in order that there may be no doubt on the matter, will have the Clerk read the statement of facts, but will also state that any member at any time can move to have the reading dispensed with.

Resolve in favor of Roy Wentzel for balance due for services rendered while employed by the State Highway Commission. (S. P. 35.)

Mr. FOSTER of Ellsworth: Mr. Speaker, I am wondering if it is necessary to read all these resolves. I am sure, if it would be quite satisfactory to the gentleman from Auburn (Mr. Wing), we might expedite this matter.

Mr. WING: Mr. Speaker, I have no wish in the matt whatever.

The SPEAKER: The Chair will state that unless there is some objection, the Clerk will not read the statements of facts. This will expedite matters.

I want to save the printing and reading of so many resolves here, when they come to be finally present

when they come to be finally passed. The SPEAKER: The Chair would state that it feels that the motion is not in order and that there would be very little saving of expense in any event for the reason that certain printing has to be done in connection with these resolves.
