Thursday, February 3, 1927

Orders of the Day

On motion by Mr. Brewster of Dexter, the House voted to reconsider its action of yesterday whereby House Paper 238 relative to teacher's pension for Fannie Marble was referred to the committee on Pensions. Mr. BREWSTER of Dexter: 1 will explain, Mr. Speaker, that this is a teacher's pension, and that the funds are taken from the school fund. It has been the custom to refer these matters to the Education Committee, also there is a general bill coming in to cover these matters.

On further motion by Mr. Brewster of Dexter the resolve was referred to the committee on Education.

On motion by Mr. Hale of Portland, it was voted to take from the table House Papers 183, 184 and 185, tabled by that gentleman on February 1, pending reference to a committee; and on further motion by the same gentleman, these bills were referred to the committee on Salaries and Fees in accordance with the recommendation of the committee of reference, and 500 copies of each were ordered printed.

On motion by Mr. Flint of Monson the House voted to reconsider its action on bill an act relating to the bounty on porcupines or hedgehogs, House Paper 271, which was referred to the committee on Inland Fisheries and Game this morning.

Mr. FLINT of Monson: Mr. Speaker, I move to indefinitely postpone the bill to save advertising in about fifty newspapers.

Mr. FORHAN of Canton: Mr. Speaker, it seems to me that is rather unjust. I have several petitions in favor of this bill, and it is pretty generally known throughout the State that this is a very important measure.

The SPEAKER: The question before the House is upon the indefinite postponement of this bill.

On motion by Mr. Ingraham of Bangor, the bill was tabled pending motion by Mr. Flint for indefinite postponement.

On motion by Mr. Mansfield of Jonesport,
