HOUSE

Tuesday, February 15, 1927.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Wood of Augusta.

Orders

Mr. Wing of Auburn presented the following order:

Ordered, that the Public Utilities Commission forthwith furnish to this House the following information having to do with the "electrical companies" of the State of Maine as defined in Section 15, of Chapter 55, of the Revised Statutes:

First: A statement of the physical valuation, if any, of each and all of such companies as is on file in the office of the Public Utilities Commission.

Second: A statement of the total valuation of each and all such companies as used by the Public Utilities Commission in authorizing such companies to issue securities.

Third: A statement of the total amount of securities issued by each and all of such companies, with a brief description of the securities so issued.

Fourth: A statement of the valuation of each and all such companies as fixed by the Public Utilities Commission as a reasonable value upon all the property of such companies used in their respective service as a base for the fixing of fair and reasonable rates, tolls and charges of such companies.

Fifth: A statement of the gross revenue, exclusive of electrical railways revenues, of each and all such companies for the fiscal years of 1925 and 1926 as returned to the Public Utilities Commission by said "electrical companies."

Sixth: That the Clerk of this House, upon the passage of this order, deliver a certified copy thereof to the Public Utilities Commission.

Mr. WING of Auburn: Mr. Speaker I move the passage of the order. There is pending before the Committee on Public Utilities a measure referred to them, and which is House Document No. 36, having to do with inventories and rates of electrical companies. That matter is not yet heard, but is to be heard this com-Thursday. The information ing sought by the order will be of value, I think, to the Committee on Public Utilities and will enable them to approach the matter of House Document No. 36 with some degree of intelligence and some degree of accuracy. It used to be that one could obtain this kind of information from various reports which were made by the various departments. These re-

ports are no longer printed, and one is unable to obtain information such as the order seeks by reference to any reports; and I trust the House will give this order prompt passage so that this information may be available for the benefit of the committee, and for any other member of the House interested in these matters.

Mr. ROUNDS of Portland: Mr. Speaker, I think these reports will not be out until after the first of March, and the returns for 1926 are not available at the present time.

Mr. WING: In reply to the gentleman from Portland (Mr. Rounds) if the Public Utilities have not this information all that they have to do is to say so. That is embodied in the order.

The SPEAKER: The question before the House is upon the passage of the order introduced by the gentleman from Auburn, Mr. Wing. is it the pleasure of the House that this order receive passage?

Thereupon the order received passage.

On motion by Mr. Clifford of Bath, it was

Ordered, that Senate Paper No. 6, Resolve for appropriating money for the construction and equipment for a new wing for the Bangor State Hospital, be recalled from the engrossing department.

Mr. ROUNDS of Portland: Mr. Speaker I do not think this is right unless we know what it is recalled for. Will the gentleman from Bath (Mr. Clifford) say what it is recalled for?

The SPEAKER: The gentleman from Bath may do so, if he wishes.

Mr. CLIFFORD: Mr. Speaker, I will say that the resolve is recalled merely to arrange for the financial part of the program. I will later offer an amendment providing that half of the money may be expended this year and part next year and part the following year. This is entirely in accord with the Hospital committee and the Hospital trustees.

Mr. ROUNDS: Mr. Speaker, I think it is an emergency resolve, is it not?

The SPEAKER: The Chair believes so.

Mr. ROUNDS: Mr. Speaker, these unfortunates are crowded into one room, and this ought not to be. If it is an emergency resolve, I think the great State of Maine is in a position to build it without waiting two years. Would you want your children or your friends put in a room with the insane where they are liable to be killed at any minute. I for one do not want to see this go on record to loan a little money this year, and a little money next year, and I for one am opposed to anything that will delay immediate attention to this matter. I am for building the building right off so that these unfortunates can be taken care of now.

Mr. BARTLETT of Bangor: Mr. Speaker, I appreciate the effort of the gentleman from Portland (Mr. kounds) to help us in this Bangor matter. The order of the gentleman from Bath (Mr. Clifford) which I support, is for the purpose of making an amendment, which amendment is known to the trustees of the Bangor State Hospital and approved by them. It is also known to the members of the hospital committee, and is likewise approved by them. It is entirely satistactory so far as I know to all the members of the Bangor and Penobscot delegations.

Mr. SMITH of Bangor: Mr. Speaker, I move that the order lie on the table until tomorrow morning. The SPEAKER. The Chair will

The SPEAKER. The Chair will state that the order has already been passed, and the Chair will ask the gentleman from Portland (Mr. Rounds) if he doubts the vote whereby the order was passed.

Mr. ROUNDS: I doubt the vote, Mr. Speaker.

A viva voce vote being doubted,

A division of the House was had, Forty-eight voting in the affirmative and 50 in the negative, the order failed of passage.

Ordered, that when the Clerk of the House makes up the payroll thereof he be instructed to include therein for payment to Lida Hall Berry, the wife of the late Sherman L. Berry of Waterville, the same salary and mileage to which he would have been entitled had he served through the entire session of this Legislature.

Mr. FOSTER of Ellsworth: Mr. Speaker, will the Chair kindly explain what happened to the hospital matter at Bangor?

The SPEAKER: The Chair will state that the order introduced by the gentleman from Bath, Mr. Buker, failed to receive passage. The vote being doubted, there was a division of the House and the order failed to receive passage by a vote of 48 to 50. The resolve itself is still in the engrossing department.

Orders of the Day

Mr. ROUNDS of Portland: Mr. Speaker, I move that the House reconsider its action on the order introduced by me last Friday inviting Ex-Governor Pinchot to speak before us tomorrow evening; and I now yield the floor to the gentleman from Saco, Mr. Deering.

Mr. DEERING of Saco: Mr. Speaker, the reason for that motion is to present a subsequent order which seems to take care of the situation in another way and perhaps a little more satisfactorily.

The SPEAKER: Is it the pleasure of the House that the motion of the gentleman from Portland, Mr. Rounds, to reconsider its action of last Friday receive passage.

The motion prevailed and on further motion by the same gentleman the order introduced by him last Friday was indefinitely postponed.

On motion by Mr. Deering of Saco, it was

Ordered, that a message be sent to the Senate proposing a convention of both branches of the Legislature to be held in the hall of the House of Representatives Wednesday, February 16, 1927, at eight o'clock for the following purposes:

First, to invite the Honorable Ralph O. Brewster, Governor of Maine, to introduce to the joint convention the Honorable Gifford Pinchot of Pennsylvania, and

Second, to invite the Honorable Gifford Pinchot to address the Joint Convention.

On motion by Mr. Eustis of Strong, the House voted to reconsider its action whereby it referred to the committee on Labor House Paper 603, an act in relation to employment agencies; and on further motion by the same gentleman, this bill was tabled pending reference, and 500 copies ordered printed.

On motion by Mr. Eustis of Strong, it was voted to take from the table Senate Document 10, relative to State of Maine Associates, tabled by that gentleman, January 25, pending passage in concurrence.

Mr. EUSTIS of Strong: Mr. Speaker, the order provides that the president and treasurer of the State റ് Maine Associates be requested by the Secretary of the Senate to prepare for the information of the Eighty-Third Legislature a statement of moneys including the names of the persons or organizations contributing same and how and where said money was expended. All the information asked for is now before the members of the House and Senate in the statement prepared by the treasurer of the State of Maine Associates. The Chairman of the Associates was here some time ago at a public hearing, at which all members of the House and Senate had an opportunity to ask any questions which they desired. I now move the indefinite postponement of the order.

On motion by Mr. Lait of Old Town, the order was re-tabled and assigned for tomorrow morning.

On motion by Mr. Davitt of Millinocket, it was voted to take from the table House Document No. 96, an act for the protection of life from the peril of fire in public buildings, used for purposes of education, mercy, correction and theatres, tabled by that gentleman on February 9, pending reference to a committee; and on further motion by the same gentleman the bill was referred to the committee on Education.

On motion by Mr. Wing of Auburn, it was voted to take from the table House Paper 438, tabled by that gentleman Feburary 10, pending reference to a committee; and on further motion by the same gentleman, the bill was referred to the committee on Agriculture.

On motion by Mr. Bartlett of Bangor, it was voted to take from the table House Document No. 70, an act relating to fees for registration of vehicles, tabled by that gentleman. February 10, pending re-consideration; and on further motion by the same gentleman the House voted to recede and concur with the Senate in the reference of this bill, the Senate having referred the bill to the committee on Ways and Bridges.

On motion by Mr. Page of Skowhegan, it was voted to take from the table House Paper 464, an act relating to fly fishing in the tributaries to the South Branch and West Branch of the Penobscot river; in the tributaries to the East Branch of the Penobscot river; and in the tributaries to the Allagash and St. John rivers, tabled by that gentleman, February 10, pending reference to a committee; and on further motion by the same gentleman, the bill was referred to the committee on Inland Fisheries and Game.

On motion by Mr. Foster of Ellsworth, it was voted to take from the table House Paper 463, remonstrance of Edward W. Brann and 70 others against any change in the pickerel the fishing law relating to Grahams a. d Leonard's Lakes, the Union river and its tributaries, in Hancock county, tabled by that gentleman February 10, pending reference to a committee; and on further motion by the same gentleman it was referred to the committee on Inland Fisheries and Game.

On motion by Mr. Rounds of Portland, it was voted to take from the table House Paper 531, an act to authorize the city of Portland to provide, by ordinance, for the retirement, pension and annuity to dependents of members of the police and fire departments, tabled by that gentleman, February 11, pending reference to a committee; and on further motion by the same gentleman the bill was referred to the committee on legal affairs.

On motion by Mr. Robie of Westbrook, it was voted to take from the table House Paper 499, an act defining storage or processed eggs and regulating the distribution thereof, tabled by that gentleman, February 11, pending reference to a committee; and on further motion by the same gentleman, the bill was referred to the committee on agriculture and 500 copies ordered printed.

On motion by Mr. Piper or Jackman, it was voted to take from the table Senate Paper 149, Senate Document 62, tabled by that gentleman carlier in the day, being an act to amend Section one of Chapter 97 of the Revised Statutes, relative to right to erect and maintain mill dams and to divert water by a canal for mills; and on further motion by the same gentleman, it was voted to refer this bill to the committees on interior waters, public utilities and judiciary in nonconcurrence with the Senate. On motion by Mr. Piper of Jackman, it was voted to take from the table communication from the forest commissioner regarding the Hardwood Association, tabled by that gentleman, February 11, pending consideration; and on further motion by the same gentleman the communication was referred to the committee on State lands and forest preservation and 500 copies ordered printed.
