Thursday, February 17, 1927.

The House met according to adjournment and was called to order by the Speaker.

Mr. ROUNDS: I would like, Mr. Speaker, to state my reason for this. This money was supposed to come out of a fund not appropriated, but somebody did not want to have it taken that way; so they have taken \$25,000 from the fiscal year ending June 30, 1927, \$220,000 from the fiscal year ending June 30, 1928, and \$50,000 from the fiscal year ending June 30, 1929. This is an emergency matter and I yield to the gentleman from Bath, Mr. Clifford.

Mr. CLIFFORD of Bath: Mr Speaker, I would like to present amendment "A" to the resolve.

The SPEAKER: Would the gentleman from Bath, Mr. Clifford, present the amendment after the motion of the gentleman from Portland (Mr. Rounds) is put to the House?

Thereupon on motion of the gentheman from Portland, Mr. Rounds, the rules were suspended and the action of the House whereby this resolve was passed to be engrossed was reconsidered.

Mr. CLIFFORD: Mr. Speaker, I now offer amendment "A" to the resolve and move its adoption.

#### House Amendment "A"

Moved that this resolve be amended by striking out the last paragraph reading as follows: 'In view of the emergency cited in the preamble this act shall take effect when approved,' and inserting in place thereof the following:

"The foregoing amount is to be made available as follows:

In view of the emergency cited in the preamble this resolve shall take effect when approved."

The amendment was adopted, and the resolve as amended by House Amendment "A" was passed to be engrossed, and sent up for concurrence.

#### Orders of the Day

On motion by Mr. Williams of Falmouth an act relating to the excise tax on railroads, H. P. 65, H. D. 23, which had its first two readings this morning, was tabled pending assignment for third reading.

Mr. WING of Auburn: Mr. Speaker, the House passed under date of the 15th of February an order having to do with electrical companies. My attention has been called by certain members of the committee on Public Utilities to certain features of that order, that information therein contained perhaps could not be obtained within the time that would be of benefit to the House. The business

of the House yesterday was in such condition and under such circumstances that motion for reconsideration could not be made; and now in order to amend this order under the rules, we shall have to have consent of the House that the rules may be suspended in order that I may offer an amendment which will tend to the better wording of the order itself, and, if the House will permit I will move that the rules be suspended and that we reconsider the vote whereby we passed the order of February 15 relating to electrical companies, and I will then offer an amendment.

Thereupon the rules were suspended and the House reconsidered its action whereby it passed on February 15 the order relating to electrical companies.

Mr. WING: I now offer this amendment and move its adoption and that the order as amended receive passage.

"Amendment A to House order of February 15, having to do with the electrical companies of the State of Maine as defined in Sec. 15 of Chap. 55 of the Revised Statutes.

House order dated February 15th. 1927, is hereby amended by adding thereto section seven as follows:

Section 7. This order shall apply only to electrical companies having gross revenue of more than \$100,000 in the year 1925.

Ordered, that the Clerk of the House communicate this amendment to the Public Utilities Commission by delivering a certified copy there-of to said commission."

The House adopted the amendment, and on further motion by the same gentleman the order as amended received passage.

On further motion by the same gentleman, the Clerk was directed to communicate the amended order forthwith to the Public Utilities Commission.

On motion by Mr. Kitchen of Presque Isle it was voted to take from the table, House Paper No. 748, an act relating to a mill tax tabled by that gentleman earlier in the day; and on further motion by the same gentleman, the bill was referred to the joint committees on Taxation and Ways and Bridges and 500 copies ordered printed.

of the Workmen's Compensation Law of this State, and all elements and phases of the cost of Workmen's Compensation in this State; and make full report in writing to the Governor on or before October 1, 1928.

Such Committee is hereby given full power to summon witnesses and require the production of papers and documents and records, such witnesses to receive the same attendance fees as obtains in the Supreme Judicial Court.

Such Committee is to serve without pay other than actual expenses and is authorized to employ at the expense of the State all necessary expert or other assistance.

To enable such Committee to perform its duties the Governor and Council are hereby authorized to pay the expenses of this investigation and report, out of any moneys available to the Governor and Council therefor;

By Mr. Marden of Waldo: Resolve in favor of the town of Waldo. (H. P. 804)

By the same gentleman: Resolve in favor of the town of Monroe. (H. P. 805)

By the same gentleman: Resolve in favor of the town of Jackson. (H. P. 806)

By the same gentleman: Resolve in favor of the town of Troy. (H. P. 807)

By Mr. Anderson of New Sweden: Resolve in favor of the town of Washburn. (H. P. 808)

By Mr. MacKinnon of Mexico: Resolve in favor of the Mexico-Peru bridge over Androscoggin River connecting Dixfield, Mexico and Peru, Oxford County. (H. P. 809)

Mr. PIPER of Jackman: Mr. Speaker, I move that the House now adjourn.

Mr. GREENLEAF of Auburn: Mr. Speaker, I would like to ask if that communication from the Secretary of State had to do with the county estimates.

The SPEAKER: The Chair will state that it was referred to the committee on Counties.

On motion by Mr. Greenleaf of Auburn, the House voted to reconsider its action whereby it referred the communication to the committee on Counties in concurrence with the the Senate.

Mr. GREENLEAF: Mr. Speaker, i move that it be referred to the committee on County Estimates in nonconcurrence with the Senate, and I will say that this is a matter which should be referred to the committee on County Estimates, and the Senate has dropped into error in referring it to the committee on Counties.

The motion prevailed, and the communication was referred to the committee on County Estimates in non-concurrence with the Senate.

On motion by Mr. Page of Skowhegan, the House voted to reconsider its action whereby Senate Paper 258, an act to increase the salary of the Judge of Western Somerset Municipal Court, was referred to the committee on Salaries and Fees, in concurrence; and on further motion by the same gentleman the bill was tabled pending reference in concurrence.

On motion by Mr. Page of Skowhegan, it was voted to take from the table House Paper 834, an act to prohibit the teaching of evolution, tabled by that gentleman earlier in the session.

Mr. PAGE of Skowhegan: Mr. Speaker, I yield to the gentleman from Portland, Mr. Hale.

Mr. HALE of Portland; Mr. Speaker, I move the indefinite post-ponement of this bill.

Mr. PIPER of Jackman: Mr. Speaker, I move that we adjourn.

A viva voce vote being doubted,

A division of the House was had,

Forty-nine voting in the affirmative and 43 in the negative, the motion to adjourn prevailed, and the House adjourned until ten o'clock tomorrow morning.
