## HOUSE

Friday, March 4, 1927.
The House met according to adjournment and was called to order by the speaker.

Prayer by the Rev. Mr. Moyle of Hallowell.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Resolve in favor of the Cobbosseecontee Fish and Game Association, H. P. 42, H. D. 144, which was finally passed in the House March 2nd and passed to be engrossed February 18th,

Comes from the Senate passed to be engrossed as amended by Senate Amendment $A$ in non-concurrence.

In the Heuse, on motion by Mr. Kinsman of Augusta the House voted to reconsider its action whereby this resolve was finally passed; on further motion by the same gentleman the House voted to reconsider its action whereby this resolve was passed to be engrossed; on further motion by the same gentleman the House voted to adopt Senate Amendment A in concurrence; and on further motion by the same gentleman the resolve as amended by Senate Amendment A was passed to be engrossed in concurrence.

From the senate: Bill an act granting to the Cumberland County Power and Light Company the right to exercise the power of eminent domain for certain purposes. H. $P$. 17 , S. D. 17, which was recommitted to the Committee on Legal Affairs together with House Amendment A in the House February 25th,

Comes from the Senate with a report of the Committee on Legal Affairs, reporting "ought not to pass" accepted in non-concurrence.

In the House, on motion by ${ }^{\text {Mr. }}$ Chase of Cape Elizabeth, the House roted to recede and concur with the Senate in the acceptance of the report of the committee on Legal Affairs, ought not to pass.

From the Senate: Ordered, the House concurring, that when the Senate and House adjourn, they ad-
journ to meet Tuesday afternoon, March 8, at 4.30 o'clock.

On motion by Mr. Wing of Auburn it was voted that the communication and accompanying resolution be referred to the commitiee on Judiciary, and that 500 copies of each be printed.

The SI'LAKER: We are proceeding under orders of the day.

Mr. KITCHEN of Presque Isle: Mr. Speaker at the suggestion of Representative Rawley, who is unable to be present this morning, I wish to take from the table the act relative to the tax on gasoline H. P. 981 assigned for next Wednesday. March 9. His reason is that he wishes it to go with the other bills to the joint committees on Taxation and Ways and Bridges.

Thereupon, on motion by Mr. Kitchen of Presque Isle the House voted to reconsider its assignment of this matter for March 9 ; and on further motion by the same gentleman the bill was referred to the joint committees on Taxation and Ways and Bridges.

Mr. ROUNDS of Portland: Mr. Speaker, I would like under orders of the day to have the unanimous consent of the Legislature to present certain views relative to the charter of the city of Portland.

Cnanimous consent was granted the gentleman hom Portland, Ar. Rounds, and that gentleman said as follows:

Mr. speaker and radics and gentlemen of the House: I was accused yesterday, in a commitiee room, of being a grafter, by a gentleman from l'ortland. i resent that. 1 want it distinctly understood that what he said was untrut. 1 never wats in the City Government with that gentlematl, in the tirst place. I did build a sewer on D'eaks island. 1 offered to give it to the city of Portand. They would not accept it, but they would buy it from me. I said "No, they will say 1 am grafting on the city." And that sewer today stands in my name, eight hundred feet through a iedge. I did it to protect the watorworks on Peaks Island. I say it is a disgrace that anybody sent here with the largest voie that anybody recoived in the city of Fortland should be called a grafter just vecause he does not agree with "The Four Hundred" who came up here yesterday.

I want it distinclly understood; and 1 think the man should be called to account for making such a statement as he made in the room of the conimittee on Legal Affair's yesterday. I want to say here that it was so bad that the newspaper reporter would not print those remarks so that it would go out to the cily of Portland that I was such a man. And it is time for this House to take some action to slop such business when anybody comes here and belittles any of its members. They have had the books looked over for years. They have tried to find where I have grafted, but they could not do it, and I never before bad such a vote as I received at the last election. I sup-
pose it was the grafters who gave it to me, according to his understanding! I think the gentleman voted for me but $I$ am an awful grafter in his estimation! I think it is time that this House takes some recognition of that slur that he put on a member of this House.

The SPEAKER: The House is procecding undor orders of the day.

Mr. MLRRILL of Dover-Foxcroft: Mi: Speakcr, if in order to make a motion, i would move that it go on record that the gentleman from Portland, Mr. Rounds, says he is not a grafter.

The SIEAKEF: The Chair will state that that is not in order.

Mr. ALDIICH of Topsham: Mr. Speaker, I would move that this llouse go on record as extending to the gentleman from Portland, Mr. Rounds, a vote of the confidence of this House in his entire integrity.

Mr. STURGIS of Auburn: Mr. Speaker, I second that motion.

The SPEAKER: It is moved and seconded that the House go on record as voicing its confidence in the absolute integrity of the gentleman from lortland, Mr. Rounds, and that it be by a rising vote.

Thereupon the motion prevailed by a unanimous rote, the members applauding.

The SPDAKER: Is there any further business under orders of the day?

There being no response, the Clerk read the notices.

On motion by Mr. Booker of Rumford,

Adjourned until Tuesday afternoon, March 8, at 4.30 o'clock.
