Wednesday, March 9, 1927.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Manning of Augusta.

Journal of the previous session read and approved.

On motion by Mr. Griffin of Biddeford, the rules were suspended for the purpose of permitting that gentleman to present the credentials of William H. Stone of Biddeford, the newly-elected member of the House from that city.

The credentials were received and

ordered placed on file.

On further motion by Mr. Griffin of a committee was appointed by the Chair to escort Mr. Stone to the Governor and Council for the purpose of having the oath of office administered to him.

Thereupon the Chair appointed as such committee, Messrs. Griffin of Biddeford, Gagne of Biddeford, Hale of Portland, Lait of Old Town, Deering of Saco and Staples of Eliot.

The committee escorted Mr. Stone to the presence of the Governor and Council for the above purpose amid the applause of the House, the members rising.

Subsequently the committee reported, through Mr. Griffin of Biddeford, that the oath of office had been administered to Mr. Stone.

Mr. GRIFFIN: Mr. Speaker, I have the honor to present to the House my colleague, the gardeford, Mr. Stone. gentleman from

The SPEAKER: The House hears the report of the committee, the committee is discharged with thanks, and the Chair will ask the gentleman from Biddeford, Mr. Griffin, to escort his colleague, Mr. Stone to his seat, and the Chair assigns as his seat, Seat No. 119. (Applause)

Mr. Speaker, I would move croft: that this act be tabled.

Mr. HOLMAN of Bangor: Mr. Speaker, we cannot hear very well on this side of the hall. May I inquire the reason for the tabling of this act.

The gentleman The SPEAKER: may answer if he cares to.

Mr. MERRILL: Mr. Speaker, I would say that it is no move inimical to the eventual passage of this act. It is simply for the reason that if a bill introduced by me and on its way through the Legislature should receive passage, it may make a material difference in the allocation of the funds for this bridge, and I simply wish time to take that matter up.

Mr. HOLMAN: Mr. Speaker, I would like to inquire if the gentleman would have sufficient time if we assigned the matter for special consideration 'omorrow morning.

The SPEAKER: The gentleman

may answer if he chooses.

Mr. MERRILL: Mr. Speaker, I doubt very much if that would afford sufficient time. I would like very much the courtesy of allowing it to remain on the table until I withdraw it.

Thereupon the motion to table prevailed.

Orders of the Day

The SPEAKER: The Chair lays before the House, House Paper 889, an act relative to the salary of the Mayor of the City of Augusta, it being recalled in pursuance to a joint order.

On motion by Mr. Kinsman Augusta the bill was referred to the committee on Legal Affairs.

The SPEAKER: The Chair lays before the House, House Paper 830, an act relative to the Kennebec Agricultural Society at Readfield, which was recalled from the committee, and the Chair awaits a motion.

Mr. CRAM of Mt. Vernon: Mr. Speaker, that bill was recalled because it was sent to the wrong committee. We would like to have it sent to the committee on Legal Affairs.

Thereupon on motion bv Cram, the bill was referred to the committee on Legal Affairs.

The SPEAKER: Under tabled and today assigned, as appears on the House Calendar, the Chair lays before the House an act in relation to the bridge built across the Kennebec river between Bath Woolwich, S. P. 315, tabled by Mr. Merrill of Dover-Foxcroft, March 2, pending reference to a committee.

On motion by Mr. Merrill the bill was returned to the Senate with-

out action by the House.

The SPEAKER: The Chair lays before the House an act to incorporate the City of Augusta Cony High School District, H. P. 871, tabled by Mr. Kinsman of Augusta, March 2, the pending question being reference to a committee.

On motion by Mr. Kinsman, bill was referred to the committee

on Legal Affairs.

The SPEAKER: The Chair lays before the House an act to authorize the issuance of bonds for construction of State highways conditioned upon an amendment of the Constitution increasing the amount of bonds issued for State highways and bridges, S. P. 407, S. D. 177, tabled by Mr. Merrill of Dover-Fox-croft, March 8, the pending question being reference in concurrence.

Mr. MERRILL: Mr. Speaker, inasmuch as it seems to me that this bill should be considered by the Highway Commission in reference to its general policy of highways, I would move that this be referred to the committees on Judiciary and Ways and Bridges jointly in nonconcurrence.

Mr. WING of Auburn: Mr. Speaker, I move that the word "Judiciary" be striken out from the gentleman's motion.

The SPEAKER: Possibly the gentleman from Dover-Foxcroft (Mr. Merrill) would amend his motion.

Mr. MERRILL: Mr. Speaker, I would wish to amend my motion and thank the gentleman from Auburn (Mr. Wing). I move that it be referred to the committee on Wavs and Bridges.

The motion prevailed and the bill was referred to the committee on Ways and Bridges in non-concurrence, and sent up for concurrence.

The SPEAKER: The Chair lays before the House an act relating to the fees of jurors, H. P. 761, tabled by Mr. Piper of Jackman, March 8, pending further consideration.

On motion by Mr. Piper House voted to recede and concur with the Senate in the reference of this bill to the committee on Judiciary.

The SPEAKER: The Chair before the House, an act to provide an excise tax upon tobacco products and to make the proceeds available for the development of Maine and for general and rural education, H. P. 932, H. D. 274, tabled by Mr. Hammond of Van Buren, March 8, pending the motion of Mr. Brewster of Dexter to recede and concur.

Mr. HAMMOND of Van Buren: Mr. Speaker, I can see no argument to refer the tobacco tax bill to the joint committees on Taxation and Education. A tax committee is only concerned with the raising of revenue; it has nothing to do with the expenditure of money. If a bill is to be acted upon by a committee a department of which has the expenditure money, you might as well abolish the Tayation committee because there is no need of such committee.

For instance our law provides that one-half of the Savings Banks tax goes to education but no legislation effecting a tax of those institutions should ever be and never has been referred to any committee other than Taxation. If the theory of those advocating the joint reference of this bill be carried through the cigarette tax bill now pending before this Legislature and now referred to the committee on Taxation alone might properly be referred to the committee Appropriation. and on Financial Affairs because the revenue derived from that source goes into the general treasury.

As I have stated there are two bills -one a tax on cigarettes, another a tax on tobacco. These two matters should be heard together, but if the cigarette tax bill is to be heard by the committee on Taxation alone and the tobacco tax by the joint commit-

tees on Education and Taxation, there will have to be two separate advertisings and two separate hearings. So, Mr. Speaker, I hope that the motion of the gentleman from Dexter, Mr. Brewster, will not prevail

The SPEAKER: The question before the House is on the motion of the gentleman from Dexter, Mr. Brewster, to recede and concur with the Senate in the reference of this bill. The original reference was to the committee on Taxation. The Senate then referred it to the committees on Taxation and Education, and the motion of the gentleman from Dexter, Mr. Brewster, is that the House recede and concur in the reference of this matter to the committees on Taxation and Education.

Thereupon Mr. Brewster of Dexter, was given leave to withdraw his motion.

On motion by Mr. Hammond of Van Buren, the House voted to insist on its former action whereby this bill was referred to the committee on Taxation.

The SPEAKER: The Chair lays before the House, H. P. 1017, an act relating to dog licenses, tabled by Mr. Greenleaf, of Auburn, March 8, the pending question being reference to a committee, and the Chair recognizes the gentleman from Auburn Mr. Greenleaf.

On motion by Mr. Greenleaf, the bill was referred to the committee on Agriculture, that being the committee suggested.

On motion by Mr. Flint of Monson. 500 copies ordered printed.

SPEAKER: In accordance with the House order, the Chair will now lay before the House unassigned matters previously tabled during the past week, and the first is report "ought not to pass" of the committee on Judiciary on H. D. 51, an act to create the office of Commissioner of Motor Vehicles, place the administration of several motor_vehicle provisions of law under his jurisdiction and administration and to place the State Highway Police, the appointment of highway police officers, and the administration of the State Highway Police law, under the jurisdiction and control of said Commissioner of Motor Vehicles, H. D. 178, tabled by Mr. Morrill of Gray March 1, pending acceptance of the report.

The SPEAKER: The Chair notes

that the gentleman (Mr. Morrill) is not in his seat.

Mr. VARNUM of Westbrook: Mr. Speaker, I move that this matter be re-tabled.

Mr. WING of Auburn: Mr. Speaker, I ask for a division, and that in the meantime Mr. Morrill be sent for.

A division of the House being had, Thirteen voting in the affirmative and 73 in the negative the motion to retable failed of passage.

The SPEAKER: The question before the House is on the acceptance of the report of the committee on Judiciary, and the Chair notes that the gentleman from Gray (Mr. Morrill) is approaching his seat.

Mr. MORRILL: Mr. Speaker, I would like to have it retabled.

The SPEAKER: The Chair will state that that motion has just been lost, a division of the House being taken.

Mr. MORRILL: Then I will

abide by it, Mr. Speaker.
On motion by Mr. Morrill the
House voted to accept the report
of the committee on Judiciary,
"Ought not to pass."

The SPEAKER: The Chair lays before the House an act to create and to define the powers and duties of a State Commission to represent the State in arranging and carrying out a program for the celebration of the bicentennial of the birth of George Washington, H. P. 945, H. D. 288, tabled by Mr. Wing of Auburn, March 1, pending assignment for third reading.

On motion by Mr. Wing the rules were suspended and the act was given its third reading and passed to be engrossed.

The SPEAKER: The Chair lays before the House "ought not to pass" report of the committee on Insane Hospitals on Resolve appropriating money for an addition to the third female wing of the Augusta State Hospital, S. P. 25, tabled by Mr. Rounds of Portland, March 2, the pending question being the acceptance of the report in concurrence.

On motion by Mr. Rounds, for the reason that this report has to do with the next one on the calendar, this matter was re-tabled. The SPEAKER: The Chair lays before the House, ought to pass report of the committee on Insane Hospitals on resolve making an appropriation for a Nurses' Home at the Augusta State Hospital, S. P. 27. S. D. 134, tabled by Mr. Rounds, March 2, the pending question being the acceptance of the report in concurrence; and the Chair recognizes the gentleman from Portland, Mr. Rounds.

On motion by Mr. Rounds the report was accepted in concurrence.

Mr. ROUNDS: Mr. Speaker, I move that the rules be suspended and the bill have its several readings at this time, so that an amendment can be offered.

The SPEAKER: The Chair will state that this is a resolve and the first reading should be given now.

Thereupon the resolve received

its first reading.

Mr. ROUNDS: Mr. Speaker, I have an amendment that I would like to offer and I move its adoption.

The SPEAKER: The gentleman from Portland, Mr. Rounds, offers House Amendment A to Senate Document 134 in favor of the Augusta State Hospital, and the Clerk will read the amendment.

House Amendment A to Senate Document No. 134.

WHEREAS, at the present time the nurses at the Augusta State Hospital are housed in the same buildings as are the patients, and,

WHEREAS, as the room for the proper care of the patients and the nurses has become inadequate, and,

WHEREAS, the crowded conditions render impossible proper treatment of residents and citizens of this State who may be confined therein, and,

WHEREAS, it is immediately necessary for the preservation of the public peace health and safety that the appropriations specified in this resolve be made available for the new construction and equipment of a nurses' home in connection with said hospital, which in the mind of the Legislature constitutes an emergency within the meaning of the constitution.

RESOLVED: That there be, and hereby is, appropriated for the construction and equipment of a nurses' home for the Augusta State

Hospital, the sum of one hundred thirty-five thousand dollars, the same to be expended under the direction of the State Board of Hospital Trustees, subject to the approval of the Governor and Council. The foregoing amount is to be made available as follows:

a. \$20,000 during the fiscal year ending June 30, 1927, which sum is to be taken from the funds in the treasury not otherwise appropriated. b. \$115,000 during the fiscal year ending June 30, 1928.

In view of the emergency cited in the preamble, this resolve shall

take effect when approved.

Mr. ROUNDS of Portland: Mr. Speaker, it has been stated here that the Insane Hospital is over-crowded. There are now in there hundred and fifty-three patients above the accommodations that are This new nurses' home provided. will take care of sixty-five, and it seems to me, as the tendency to insanity increases in this State owing to conditions that have been put on us by the Volstead Act, that it is time to do something for the unfortunate people of the State of Maine, and not wait until 1929. As I understand, the original bill provides for thirty-five thousand dollars in 1928 and one hundred thousand dollars in 1929.

Now if we have to wait two years (and, and as I understand, in this other resolve the Bangor Hospital is going to take from forty to fifty patients out of this hospital and carry them down to Bangor) I think it is time that this House look after the unfortunate and go right ahead and build a home right off. I think it is time to take some action now. If you pass this under "Emergency," on the first day of January, 1928, those sixty-five patients can be housed, but if you let it go ninety days and then take the original bill, it will be some time in December, 1929. I think it is time that we hurry up these things and not wait a year to get them in because in another year they may have so many more that they will want two, one for the female wing and one for the male wing.

Mr. BLAISDELL of Franklin: Mr. Speaker, I merely want to give you just a few figures relative to the over-crowded conditions over there, not necessarily speaking for or

against the situation as it now exists. I have what I consider the accurate figures today of the conditions at your hospital. On the women's side of the hospital there are available four hundred and twenty-nine beds; the hospital has six hundred and two female patients, which makes an excess on the women's side of the hospital of one hundred and seventy-three patients. On the men's side they have beds for four hundred and nineteen patients, and they have six hundred and three patients, an excess of one hundred and eighty-four men patients in the hospital, making a total capacity at that hospital, in beds, of eight hundred and forty-eight, and there are twelve hundred and five patients there. That is three hundred and fiftyseven more patients than the hospital can properly care for.

It is further interesting to note that your nurses' home, as Rounds has said, will relieve from fifty to sixty, and you still have three hundred overload. It is very interesting to note that the pest house of the Augusta Insane Hospital is housing employees, and there is no opportunity, in case of an emergency of contagious disease, for the immediate caring for that. If scarlet fever or diphtheria, etc., break out, there is no opportunity for caring for them at present. Those are the correct figures as to the situ-

ation at that hospital.

The SPEAKER: Is it the pleasure of the House that Amendment A presented by the gentleman from Portland, Mr. Rounds, be adopted?

Thereupon Amendment A was adopted and tomorrow morning at ten o'clock assigned for the second reading of this resolve as amended.

On motion by Mr. Rounds the House voted to reconsider its action whereby the second reading was assigned for tomorrow morning at ten o'clock and on further motion by the same gentleman the resolve was tabled pending assignment for second reading.

The SPEAKER: The Chair lays before the House an act to authorize the Portland Railroad Company to operate motor busses, H. P. 26, S. D. 8. tabled by Mr. Rounds of Portland, March 2, pending assignment for third reading; and the Chair recognizes the gentleman from Portland, Mr. Rounds.

Mr. ROUNDS: I yield to the gentleman from Westbrook, Mr. Robie.

On motion by Mr. Robie of Westbrook the bill was retabled and specially assigned for Friday of this week

The SPEAKER: The Chair lays before the House "ought to pass" report of the committee on Library on resolve to appropriate money for the erection of a new State Library, H. P. 470, H. D. 121, tabled by Mr. Deering of Saco. March 2, pending acceptance of the report.

Mr. DEERING of Saco: Mr. Speaker, I move that the report of the committee be accepted.

On motion by Mrs. Folsom of Norridgewock, the matter was retabled pending the motion of Mr. Deering of Saco to accept the report,

The SPEAKER: The Chair lays before the House an act relating to expenditures and returns of candidates for public office, H. P. 92, H. D. 31, tabled by Mr. Holman of Bangor, March 2, the pending question being assignment for third reading; and the Chair recognizes the gentleman from Bangor, Mr. Holman.

Mr. HOLMAN of Bangor: Speaker and members of the House: This bill, H. D. 31, an act relating to expenditures and returns of candidates for public office, I laid on the table March 2 for the purpose of of-fering an amendment. It seems to me that to have the bill in its present form would do a great injustice to a poor man who is running for public office, and ultimately to our Primary System as a whole, It would simply confer on the rich man the opportunity of going ahead and advertising himself without any restrictions whatsoever, while the poor man who might be a candidate the same office would find it impossible to avail himself of this great power simply because he cannot afford it. For this reason I have prepared an amendment to the bill, aftinterviewing the Governor several members of both the House and the Senate.

This bill, while covering some three or four typewritten pages, really makes only two changes in our present primary system. In the first place, it requires all candidates for public office to file with the Secretary of State, under oath, a true ac-

count of all expenses they have incurred, including printing, postage, newspaper advertising, in fact everything. And in the second place, it holds those expenses within certain definite limits. These limits, after careful consideration, have been fixed in the following manner: State-wide offices, including United States Senators, \$5,000; for members of Congress, \$2,000: for State Senators and County Officials, \$500 for each ten thousand votes cast for the candidates at the previous gubernatorial election; for representative districts with three or more representatives. \$300: and for all other representative districts, \$150. These maximum amounts really represent approximately three times the allowances now permitted under our present primary law. While some, possibly, might feel that these amounts are a little too high, and others that they may be too low, there is this to be said, that they will use all candidates alike.

And so I am appealing to the members of this House who believe that the poor man should have the same opportunity in politics as the rich man-I am appealing to the members of this House who believe in equal rights for all and special privileges for none, to support this amendment. Its favorable consideration will do much to strengthen our present primary system, a system that is free almost entirely from the old time Fourth of July Convention spirit, with its self-appointed political bosses, a system that has given to us, with very few exceptions, some of the best, ablest, and cleanest public officials in the history of the State. And, so, Mr. Speaker, I move at this time the adoption of Amendment A to House Document 31. (Applause.)

Mr. HALE of Portland: Mr. Speaker, I move that the amendment lie on the table and that 1,000 copies be printed.

The SPEAKER: The gentleman from Bangor (Mr. Holman) presents House Amendment A to H. D. 31, and the gentleman from Portland, Mr. Hale, moves that it lie on the table and that 1,000 copies be printed.

Mr. HOLMAN: Mr. Speaker, I would like to have the amendment adopted, if we can, at this time, and then I would be glad to move,—in fact I had planned to move myself

that it lie upon the table pending printing. It seems to me that we just as well adopt the amendment at this time.

The SPEAKER: The Chair will state that the gentleman is proaching argument in the opinion of the Chair which, of course, is not in order.

Mr. HOLMAN: Mr. Speaker, I insist upon my former motion that we adopt the amendment at this time.

The SPEAKER: The Chair will state that the motion of the gentleman from Portland, Mr. Hale, has precedence.

Mr. HOLMAN: Then I beg the par-

don of the House.

The SPEAKER: The question before the House is upon the motion of the gentleman from Portland, Mr. Hale, that this amendment lie on the table and that 1,000 copies be printed. As many as are in favor of this motion will say aye; those opposed

A viva voce vote being taken, the motion to table and print prevailed.

The SPEAKER: The Chair lavs before the House "ought to pass" report of the committee on Agriculture on an act to provide for the payment of a bounty on bears killed in the State, H. P. 234, tabled by Mr. Wing Auburn, March 3, he pending question being the acceptance of the report; and the Chair recognizes the gentleman from Auburn. Mr. Wing.

On motion by Mr. Wing, the report of the committee was accepted, the rules were suspended, and the bill received its first reading.

Mr. WING: Mr. Speaker, I yield to the gentleman from Patten, Mr. Wood, who desires, I understand, to offer an amendment.

Mr. WOOD of Patten: Mr. Speaker and members of the House: I have an amendment which I would like to offer.

The SPEAKER: If the Chair may interrupt, it will state that the amendment should be offered after the second reading of the bill.

Mr. WING: Mr. Speaker, do I understand that the bill is not in amendable order now?

The SPEAKER: The Chair will that the bill has state not been printed.

WING: 1 understand, Speaker, that the rules have been suspended.

The SPEAKER: For the giving of the first reading.

Mr. WING: Do I understand the Chair to rule that a bill cannot be amended at the time of its first reading?

SPEAKER: The Chair so The House, of course, can The rules suspend the rules and amend the bill at any time. If the gentleman wishes to have the rules suspended, an amendment can be offered at this time.

Mr. WING: The point I am wishing to make is to have the bill read once, the amendment offered, then the entire matter can be printed so that we can all see it.

The SPEAKER: The Chair will state that if the amendment is offered under suspension of the rules it can be done at this time.

On motion by Mr. Wing of Auburn the rules were suspended in order that the gentleman from Patten, Mr. Wood, may be permitted to offer an amendment at this time.

Mr. Wood of Patten offered House Amendment A and moved its adop-

tion as follows:

House Amendment A to House Paper 234.

Amend Section one by inserting after the word "in" in the second line thereof the words "any town or plantation in this State, or in any unorganized township adjacent to any town or plantation."

Amend Section two of said House Paper 234 by inserting after the word "county" in the ninth line thereof, the words, "if the bear is killed within the limits of an adjacent unorganized township claim for bounty shall be made before the treasurer of an adjacent town or plantation.

The SPEAKER: Is it the pleasure of the House that this amendment be

adopted?

Mr. FLINT of Monson: Mr. Speaker, r am against this amendment, and will try and explain why I am against it. This divides the State into two territories, the northern part, or the unorganized towns, and the southern part, or the organized The bill calls for a bounty towns. of ten dollars and this amendment cuts out the paying of the bounty in the northern part of the State in the unorganized towns. You should have a bounty on the whole state or none at all, and I move the indefinite postponement of the amendment.

On motion by Mr. Wing of Auburn,

the bill and amendment were tabled and ordered printed, and specially assigned for Thursday, March 10.

The SPEAKER: The Chair lays before the House an act to provide for the purchase of books for the Penobscot County Law Library, H. P. 369, H. D. 311, tabled by Mr. Bartlett of Bangor, March 4, pending assignment for third reading; and the Chair recognizes the gentleman from Bangor, Mr. Bartlett.

Mr. BARTLETT: Mr. Speaker, I have an amendment which I would like to offer and move its adoption. It is very short and merely corrects the title of the act as well as the act itself.

House Amendment A to H. D. 311 Substitute name "Penobscot Bar Library Association" for the name "Penobscot County Law Library" as appears in act and title to the same.

The amendment was adopted and tomorrow assigned for the third read-

ing of the bill as amended by House Amendment A.

The SPEAKER: This appears to dispose of the calendar. Is there any further business under orders of the day?

Mr. LITTLEFIELD of Kennebunk: Mr. Speaker, may I ask what committee has now got the bill, an act relating to the fees of jurors, H. P. 761?

The SPEAKER: The Chair will state that that was referred this morning to the committee on Judiciary. Is there any further business under orders of the day?

There being no response the notices were read by the Clerk.

On motion by Mr. Snow of Brunswick.

Adjourned until ten o'clock tomorrow morning.
