Orders of the Day

The SPEAKER: Under orders of the day tabled and today assigned, the Chair lays before the House H. P. 1147, H. D. 368, bill an act relating to taxation of insurance companies, tabled March 16 by Mr. Hammond of Van Buren, pending the motion of Mr. Wing of Kingfield to refer to committee on Mercantile Affairs and Insurance, and specially assigned for today; and the Chair recognizes the gentleman from Van Buren, Mr. Hammond.

Mr. HAMMOND: Mr. Speaker, this is purely a taxation measure and the committee on taxation is in good, healthy condition and functioning perfectly; so that I hope that the motion of the gentleman from Kingfield, Mr. Wing will not prevail.

Mr. WING of Kingfield: Mr. Speaker, this matter is a matter of pure taxation, as stated. At the re-

quest of some people interested, or who would be mostly affected by this tax, — insurance companies, — they thought that the matter might be more accurately dealt with, possibly by a committee of insurance men,—men who are skilled in the affairs of insurance. I think that these people have no serious objection to this bill going to the committee on taxation, and as that committee seems specially interested in the matter, I am willing to withdraw my motion at the pleasure of the House.

Thereupon Mr. Wing of Kingfield was given permission to withdraw his motion whereby he moved to refer this bill to the committee on Mercantile Affairs and Insurance.

On motion by Mr. Hammond of Van Buren the bill was referred to the committee on Taxation.

The SPEAKER: The Chair lays before the House resolve in favor of B. F. Marley, H. P. 1050, H. D. 346, tabled by Mr. Hale of Portland, March 16, pending passage to be engrossed and specially assigned for today; and the Chair recognizes the gentleman from Portland, Mr. Hale.

Mr. HALE: Mr. Speaker, I ask the indulgence of the House to have these next three resolves reassigned for Wednesday next. I will say that I am making this request in behalf of the committee on Claims, and this, as I said before, I think will ultimately expedite matters.

Mr. ROUNDS of Portland: Speaker, we are getting well along in the session. We have some seventyfive more claims to be brought in here, and it seems to me that if we do not want to get a lot of pocket vetoes, we have got to do something ouickly. We have tabled this and ouickly. We have tabled this and tabled it, and I think we ought to dispose of it one way or the other. Although I am House Chairman of the committee on Claims, I never knew before that there was any fault to find, and I would ask any other member of the claims committee whether they have heard any fault found.

Mr. HALE: Mr. Speaker, I will say that I had a talk yesterday afternoon with the Chairman of the committee on Claims, Senator Smith, and he was particularly anxious to confer with some people, not only about these but about some other claims of a similar character, and it was in

deference to his request that I ask the House to retable these resolves.

Mr. ROUNDS: Mr. Speaker I do think that if we want to get through, we have got to clean this thing up, because there has been a veto on claims every time that I have been in the Legislature. I remember one time when we passed a claim here over the Governor's veto with a vote of 138 to one, and I for one do not want to see any more pocket vetoes two years from now. I want every man who has a just claim to get his pay now.

Mr. HALE: Mr. Speaker, I ask unanimous consent of the House to

address it a third time.

Unanimous consent was given.

Mr. HALE: Mr. Speaker, I want simply to say that if the House will allow time for conference on some of these measures, it will do more in that way than it can possibly do in any other way to obviate vetoes; and it is for that reason that we want further time on these claims.

The SPEAKER: The question before the House is on the motion of the gentleman from Portland, Mr. Hale, that H. D. 346, resolve in favor of B. F. Marley, H. D. 348, resolve in favor of Hanson A. Barney of Guilford, and H. D. 349, resolve in favor of A. H. Wadleigh, compensating him for damage done his orchard by deer, be retabled and specially assigned for Wednesday, March 23.

A viva voce vote being taken, the motion to so retable prevailed.

The SPEAKER: The Chair lays before the House H. D. 335, an act to authorize the city of Portland to provide, by ordinance, for the retirement, pension and annuity to dependents, of members of the police and fire departments, tabled March 16 by Mr. Rounds of Portland, pending third reading and specially assigned for today.

Mr. ROUNDS of Portland: Mr. Speaker, I should like the consent of the House to present House Amendment A and move its adoption.

The SPEAKER: The gentleman from Portland, Mr. Rounds, presents House Amendment A and moves its adoption.

House Amendment A to House Document 335, "an act to authorize the city of Portland to provide, by ordinance, for the retirement, pension and annuity to dependents, of members of the police and fire departments".

Amend Section 1 by striking out after the word "including", the words "the chief of police".

The SPEAKER: Is it the pleasure of the House that Amendment A be adopted?"

Mr. ROUNDS of Portland: Mr. Speaker, the mayor of the city of Portland in the past was always the chief of police; but later that was changed and they called another man "acting chief of police", but he is really a patrolman. This has caused a good deal of dissension in the police department of the city of Portland. If there ever should be adopted another charter and he was put on half pay on retiring, he could not get as much as would a patrolman. Therefore it looks to me as though the mayor should still hold office as chief of police.

Miss LAUGHLIN of Portland: Mr. Speaker, I regret to be obliged to again oppose the gentleman from Portland, Mr. Rounds. This is a bill to give the city of Portland authority to pension members of the police and fire departments, including all the officers of the fire department and including the chief and all other officers of the police department. Hitherto the city government has not been allowed to provide pensions for either the chief of the fire department or the chief of the police department, with the result that it has been impossible to elevate from the ranks men who would take that position, and we have been appointing men from civil life as chief of police. The man now acting as "acting chief" is doing so because if he were chief at the time of arriving at the pension age ne would miss the opportunity of getting a pension. No man from the ranks is willing to become chief of police in the city of Portland unless he comes within the pension provision, and this bill makes provision for the fire department chief also in that way. We lost a perfectly satisfactory chief of the fire department in Portland just for the lack of this provision for pensioning the chief. There seems to be no reason why, in authorizing the city of Portland to pension the police and fire department forces, we should exempt one man, the chief of police, and thereby make it impossible to elevate to that position from the ranks of the police department a chief because he would immediately lose his pension rights. That is the reason why the person who is acting is only an acting chief of police in Portland, because he would not accept that position. I believe, also that this bill has the approval of practically everybody in the city of Portland, and I think it has the approval of the members of the Portland delegation in this House, and I trust, if necessary, that we hear from them.

Mr. CARLETON of Portland: Mr. Speaker, I heartily approve of all that Miss Laughlin has said. It is an absolute fact, and I think if it were not that there is some prejudice against our present chief of police, this bill would have gone through long ago. I think personalities has been brought into it.

The SPEAKER: The Chair will state that it does not feel that any imputing of improper motives is proper in debate.

Mr. DECKER from Portland: Mr. Speaker, I feel that the chief should be included in this bill.

The SPEAKER: The question before the House is on the motion of the gentleman from Portland, Mr. Rounds, that House Amendment A be adopted. As many are in favor of the adoption of House Amendment A will say aye; those opposed will say no.

A viva voice being taken, the motion to adopt House Amendment A was lost.

Thereupon the bill was given its third reading and was passed to be engrossed.

The SPEAKER: The Chair lays before the House, H. P. 949, an act to amend the city charter of the city of Augusta relative to the appointment of city officials, this paper having been recalled for its committee by the gentleman from Augusta, Mr. Kinsman. On motion by Mr. Kinsman of Augusta, the bill was indefinitely postponed.

The SPEAKER: There is nothing else on the calendar specially assigned for today. Is there any matter that any member can take from the calendar?

There being no response the Clerk read the notices.

On motion by Mr. Carleton of Portland.

Adjourned until Tuesday afternoon, March 23, at 4.30 o'clock.
