HOUSE

Tuesday, March 29, 1927.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Dr. Purves of Augusta.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate:

Resolve to appropriate money for compiling and advertising the Agricultural, Industrial and Recreational Resources of the State (S. P. 2) (S. D. 1)

on which the House voted to accept the report of the Committee on Maine Publicity reporting "Ought not to pass," in non-concurrence.

Comes from the Senate, that body insisting on its former action whereby the bill and report were referred to the Committee on Appropriations and Financial Affairs, and asking for a Committee of Conference, with the following conferees appointed on its part:

In the House on motion by Mr. Eustis of Strong that body voted to adhere.

Mr. ROBIE of Gorham: Mr. Speaker, I would like to move the acceptance of the minority report. I feel in this regard that this Legislature should settle its own affairs. There is nothing to be gained by deferring action. I realize that it is an easy matter to refer in this way but 1 think in regard to the erection of memorials in France for individual companies we are setting up a dangerous precedent. If we start in to do this with one company from Maine other companies in the future will wish to avail themselves of the same privilege. I think if memorials are to be placed in France, they should be national; and if here, they should be local and should be of some utility. I, therefore, move the acceptance of the minority report.

The SPEAKER: The Chair lays before the House majority report of the committee on Judiciary, ought not to pass, on bill an act conferring jurisdiction in matters of divorce, annulment of marriage, care and custody of children and support of children and wives on the Probate Courts, (S. P. 89, S. D. 31) and minority report, same committee on same bill in a new draft, S. P. 519, S. D. 260 under title of an act conferring concurrent jurisdiction in matters of divorce. annulment of marriage. care and custody of children and support of children and wives on the Probate Courts, tabled by Mr. Aldrich of Topsham, March 28, pending the motion of Mr. Patterson of Castine to accept the minority report; and the chair recognizes the gentleman from Topsham, Mr. Aldrich.

Mr. ALDRICH: Mr. Speaker, unless it is desired by someone to discuss this matter further I would move the previous question.

Mr. MaČART of Eastport: Mr. Speaker, I feel that I would like to discuss the question, since there are several members of the committee who signed the majority report who were not present at the previous discussion.

The SPEAKER: Does the gentleman from Topsham, Mr. Aldrich, withdraw his motion?

Mr. ALDRICH: I do, Mr. Speaker.

Mr. McCART: The motion now is to accept the minority report. Am I not correct, Mr. Speaker?

The SPEAKER: The gentleman is correct.

Mr. McCART: Mr. Speaker, 1 wish to oppose that motion, and, although I was not present at the hearing, 1 have several reasons to state in opposition to it.

We have a bill going through to increase the salaries of the Chief Justice and the Justices of the Supreme Judicial Court. Now if their salaries are increased. I think they will be quite agreeable to hearing divorce cases which appears to be the apparent object of this bill. If we grant this jurisdiction to Probate Courts, we are going to have every Judge of Probate and every Register of Probate in here at the next session asking for an increase in salary. Although I make that statement as a fact. I feel quite confident it is true in view of the fact that when this bill was first introduced, before it was even assigned for a hearing, I received a letter from a Register of Probate asking if it contained any provision for an increase in salary, and if so, how much. If not, would I not please use my efforts to have such provision inserted. I immediately wrote back that I was not in favor of the measure and did not think it would be treated seriously enough to bothe" with it; but I find a divided report.

There were not many of us present last Friday when Mr. Patterson discussed this matter. He brought up the fact that there were many divorces tried now which have certain unsavory details which might be concealed from the public if tried in the Probate Courts in view of the fact that the attendance at the Probate Court is not very large. Well, I think that these unsavory details generally come out in contested cases, and under the bill as drawn the most of our contested cases will still be tried in the upper courts, as most of them contain questions of fact to be decided by a jury, and all jury trials will still be held in the upper courts.

There is one more feature of the case to which I wish to call your attention, and that is the ability of some of the Judges of Probate to hear contested cases. I think many of you know that some of the Judges of Probate are men who are beyond the prime of life and who take this position because the active men do not want it; and I seriously question the ability of some of them to try a contested case. If they have not the ability to try it, they certainly have not the ability to hear it.

One more feature is that this bill is intended to relieve the Judges of the upper courts. I believe that the divorces that would be heard in the Probate Courts would be all uncontested cases, and at the present time those are all heard in the spare time of the Judges in the upper courts; and I cannot see how it is going to relieve them from the press of business to take away things that are heard in their spare time.

I have no more reasons that I can think of for opposing it. I trust the minority report will not be accepted.

Mr. PATTERSON of Castine: Mr. Speaker, I did not intend to say anything more about this bill, having spoken Friday upon it, and the legislative record shows that I took more space than I had supposed I was doing. My good friend from Eastport (Mr. McCart, has raised one or two questions which, as I did not cover them in my remarks Friday, I feel 1 should attempt to answer here. He says that undoubtedly if this bill becomes a law, the Judges and Registers of Probate will come in at the next legislative session and ask for an increase of salary. That may be so. But in considering these court bills-and there are some other court bills coming in in a few days-I do not think that we should consider the matters of salaries too much in improving our judiciary. I do not blame these gentlemen, if their work is increased, for asking for an increase in salaries. I even understand that there is a bill before the House asking for an increase in salaries for members of the Legislature; and as I hope to be here next session-and perhaps this is as good a time to announce my candidacy to my constituency as any-(laughter) I will say that I am heartily in favor of that bill! I will be perfectly frank about it! But, coming back from the ridiculous to the sublime, I do not feel that we should pay too much attention to that argument about salaries when we are considering these court bills.

The gentleman from Eastport (Mr. McCart) raised the question. He said that the Judges of the Probate Court (if I heard him correctly) were old men beyond the prime of life, and took this position, as 1 understood him-that it is a sort of easy position in which to pass their declining vears. I do not think that is altogether so. I am not questioning, of course, the word of my good friend, because very likely he knows some Judge who has passed the prime of The Judges that I know are life. lawyers, men active in their profession. But even if they were old men. there used to be an adage somthing like this-"Old Men for Wisdom" and I believe that an elderly man would perhaps be very much better fitted to pass on questions of divorce than would some younger men. Along that line I would also call your attention to the fact that it is seldom that Judges of the Supreme and Superior Courts are appointed to that position when they are young men. They are generally men after the prime of life. That is one reason why they are appointed to the bench. I do not know whether, in the opinion of the House, these answers are sufficient reply to my friend's argument or not.

In closing, I will simply say this, that the Chief Justice of the Supreme Court of Maine, and practically all the Judges of the Supreme and the Superior Courts came before the Judiciary Committee and recommended, among other bills, this one which is before us today. They recommended the original bill, giving jurisdiction to the Probate Court alone in these matters. Now this is a bill in a new draft, giving concurrent jurisdiction. If any lawyer does not wish to try his case in the Probate Court, he has a perfect right to go into the Superior or Supreme Courts with his case. I believe we should pay some attention to the recommendation of these Judges who know more about these matters than the rest of us possibly can: and for that reason I hope my motion to accept the minority report will prevail.

The SPEAKER: The question before the House is on motion of the gentleman from Castine, Mr. Patterson, that the minority report ought to pass be accepted.

A viva voce vote being doubted,

A division of the House was had,

Forty having voted in the affirmative and 62 in the negative, the motion to accept the minority report ought to pass was lost.

Thereupon, on motion by Mr. Wing of Kingfield, the majority report ought not to pass was accepted.

Mr. HALE of Portland: Mr. Speaker, I ask leave to present an order out of order, and move its passage. Permission being given, the order

was presented as follows: Ordered, that when the House rises this morning, it be to recess until 4:30 o'clock in the afternoon.

Thereupon, the order received passage.

On motion by Mr. Piper of Jackman, it was voted to take from the table S. D. 253, an act to provide for an approach to the Kennebec Bridge and to acquire the same by purchase or eminent domain; and on further motion by the same gentleman it was voted to reconsider the vote whereby the bill was passed to be engrossed.

Thereupon, Mr. Piper offered House Amendment A to this act and moved its adoption.

The amendment was read as follows:

House Amendment A to Senate Document 253, an act to provide for an approach to the Kennebec Bridge and to acquire the same by purchase or eminent domain.

Amend by striking out all of said section after the word "paid", in the twelfth line, and insert in place thereof the following: "out of any funds remaining from the sale of the bonds issued by the State of Maine in accordance wit. section nine of said chapter eighty-nine of the Private and Special Laws of 1925, after the completion of the bridge and approaches, as contemplated by said act, same to be subject to the approval of the governor and council."

Thereupon, the motion to adopt the amendment prevailed, and the act as amended by House Amendment A was passed to be engrossed.

Mr. WHEELER of South Paris: Mr. Speaker, I move to take from the table the resolve providing for the purchase of "Music and Musicians of Maine", H. P. 788, H. D. 169, tabled

by myself March 23rd pending final passage.

The motion prevailed.

Mr. WHEELER: Mr. Speaker, I now yield to the gentleman from Lewiston, Mr. Roy.

Thereupon, on motion by Mr. Roy, the resolve was finally passed.

On motion by Mr. Flint of Monson, it was voted to take from the table House Document 456, tabled by that gentleman earlier in the session, resolve to reimburse the town of Prentiss for poultry killed by dogs and wild animals in the years 1917 and 1918.

Mr. FLINT: Mr. Speaker, I would like to inquire if the bill has had its third reading?

The SPEAKER: The Chair will state that it has had its third reading and the pending question is passage to be engrossed.

Thereupon, on motion by Mr. Flint, it was passed to be engrossed.

On motion by Mr. Clifford of Bath, it was voted to take from the table H. P. 357, H. D. 89, House Report ought not to pass of committee on Inland Fisheries and Game on resolve for the purchase and propagation of pheasants and Hungarian partridges, tabled by that gentleman March 25, pending acceptance of report.

Mr. CLIFFORD: Mr. Speaker, I move that it be recommitted to the committee on Inland Fisheries and Game for further consideration; and this is perfectly satisfactory to the committee.

Thereupon, the motion to recommit prevailed.

On motion by Mr. Clifford of Bath it was voted to take from the table House Report ought to pass in new draft, of committee on Inland Fisheries and Game, on bill an act relating to regulating hunting wild birds in the waters of Merrymeeting Bay, H. P. 616, H. D. 162, (new di ft H. P. 1215) under title of an act to regulate the hunting of wild birds on the waters of Merrymeeting Bay, tabled by that gentleman March 25 pending acceptance of the report; and on further motion by that gentleman the report was recommitted to the committee on Inland Fisheries and Game.

On motion by Mr. Littlefield of

Kennebunk, it was voted to take from the table House Report—referred to the next Legislature—of the committee on Legal Affairs, on bill an act to make certain the legal boundaries of the town of Old Orchard and set off to the town of Old Orchard from the city of Saco, any right, title or interest which the city of Sa.o may have within said boundaries, H. P. 873, H. D. 230, tabled by that gentleman on March 28, pending acceptance of the report.

Mr. LITTLEFIELD of Kennebunk: Mr. Speaker, I now yield the floor to the gentleman from Franklin, Mr. Blaisdell.

Mr. BLAISDELL of Franklin: Mr. Speaker, I was assigned by the Chairman of the committee on Legal Affairs to report this matter to the House; but it seems that before the report should come to the House, the committee was to have the opportunity to examine certain maps and plans relative to the town lines of Old Orchard and Saco; but the report got into the House before they had the opportunity to do that. Therefore I move that this matter be recommitted to the committee on Legal Affairs.

Thereupon, the motion to recommit to the committee on Legal Affairs prevailed.

On motion by Mr. Hale of Portland, it was voted to take from the table bill an act relating to pensions for the blind, H. P. 1140, H. D. 387, reported in a new draft, H. P. 1226, under the same title, report being ought to pass, the same having been tabled by that gentleman earlier in the session, pending acceptance of the report; and or further motion by the same gentleman the report was accepted and the new draft was ordered printed under the joint rules.

The SPEAKER: Is there any other matter which any member can take from the table? If not, the Clerk will read the notices.

Thereupon, the notices were read, and on motion by Mr. Hale of Portland, the House recessed until 4:30 this afternoon.

Mr. FLINT: Mr. Speaker, I yield to the gentleman from Detroit, Mr. Brackett.

Mr. BRACKETT of Detroit: Mr. Speaker, as I understand it the law already provides how foxes shall be dug out in close season, and I would move the indefinite postponement of this bill.

Mr. HAWKES of Standish: Mr. Speaker, there have been a number of bills introduced this winter for the protection of fur-bearing animals, and especially for the protection of foxes.

Now, in several of the counties foxes are becoming scarce. The trappers get what they can by that method. Then they go after him with a gun and dog, and if the fox goes into a den, they proceed to dig him out. Now by this method we are gradually exterminating the foxes and more than that it does not seem to me like a good sporting proposition, and I hope the bill will receive a passage.

The SPEAKER: The question before the House is the motion of the gentleman from Detroit, Mr. Brackett, that this bill be indefinitely postponed. As many as are in favor of this motion will say aye; those opposed no.

A viva voce vote being taken, the motion to indefinitely postpone failed of passage.

On motion by Mr. Flint the bill was passed to be enacted.

On motion by Mr. Lait of Old Town it was voted to take from the table S. P. 365, S. D. 142, an act relating to the schools at Pleasant Point and Peter Dana's Point, tabled by that gentleman, March 23, pending passage to be enacted; and on further motion by the same gentleman the bill was passed to be enacted.

The SPEAKER: The report of the committee is ought not to pass.

Mr. WING: Mr. Speaker, I have a similar House Amendment to offer.

House Amendment A to House Paper 1216, House Document 473, an act to amend Section 142 of Chapter 16 of the Revised statutes relating to diplomas to be issued by State Normal Schools.

Amend by striking out after the enacting clause and inserting in place thereof the following:

Section 142, Chapter 16 of the Revised Statutes is hereby amended by adding at the end of the paragraph:

"Provided further that the State Board of Trustees for Normal Schools may confer appropriate educational degrees based upon four years of academic and professional instruction with such equipment and faculties as will safeguard the integrity and standardization of the degrees conferred." so that said section 28 amended shall read as follows:

On motion by Mr. Page of Skowhegan, the bill and amendment were tabled pending printing of the amendment.

On motion by Mr. Wing of Kingfield it was voted to take from the table H. D. 465, an act relating to the fees of sheriffs and their deputies, and that gentleman presented House Amendment A and moved its adoption.

On motion by Mr. Kinsman of Augusta, the bill and amendment were tabled, pending printing of the latter.

Mr. ROUNDS of Portland: Mr. Speaker, I would like unanimous consent to take from the table H. D. 135, an act relating to Active Retired Justices of the Supreme Judicial Court, tabled by me March 28 and specially assigned for March 30, as I thought it was another matter.

Unanimous consent was given and on motion by Mr. Rounds the bill was passed to be enacted.
