Mr. INGRAHAM of Bangor: As signer of the minority report, I am going to move acceptance of the majority report in concurrence with the

Senate and simply state that I will not take up time now to carry this fight on. I know when I am licked and I am willing to accept it temporarily.

Thereupon the majority report was accepted in concurrence.

Fifty-five voting in the affirmative and 27 in the negative the motion to table prevailed, and the matter was specially assigned for tomorrow morning.

pended while working as constable in smallpox quarantine.

Resolve in favor of the town of Surry.

Resolve in favor of the town of Sherman to assist in support of a pauper.

(Emergency Measures)

Resolve in favor of the Western Maine Sanatorium for the construction of an annex to reception room.
