SENATE

Thursday, Jan. 3, 1929. The Senate was called to order by the President.

Prayer was offered by the Rev. W. R. Wood of Augusta.

Journal of yesterday read and approved.

From the House: The following order:

Ordered, the House concurring, that a joint committee consisting of two members on the part of the Senate, with such as the House may join, be appointed with full authority to make a contract with the New England Telephone and Telegraph Company for telephone service for the members of the Eighty-fourth Legislature with matters connected with their official duties. Was read and passed in the Senate on Jan. 2nd.

In the House, read and passed in concurrence, and the Speaker having appointed as members of such a committee on the part of the House.

Committee Report

Mr. Bond of Lincoln for the Committee on Gubernatorial Vote submitted the fo'lowing report:

The Joint Select Committee to which was referred the returns on votes cast for governor in the several cities, towns and plantations in this State for the political years 1928 and 1929 reports that it has attended to its duties and that the whole number of votes returned for governor was 213,625. William Tudor Gardiner had 148,053. Edward C. Moran, Jr. had 65.572.

The report was read and accepted and placed on file.

Order

On motion by Mr. Greenleaf of Androscoggin, it was

Ordered, that a committee of three on the part of the Senate, with such as the House may join be appointed to wait on the Hon. William Tudor Gardiner and inform him he has been duly elected Governor of the State of Maine.

The President appointed on the part of the Senate, Mr. Greenleaf of Androscoggin, Mrs. Pinkham of Aroostook, Mr. Crosby of Penobscot.

Sent down for concurrence.

Subsequently the foregoing order came back from the House read and passed in concurrence, the Speaker having joined on the part of that branch the following members:

Committee Report

Mr. Greenleaf of Androscoggin for the Joint Committee appointed to wait upon the Hon. William Tudor Gardiner and inform him that he had been duly elected Governor of the State of Maine for the current political years of 1929-1930 reported that the committee had waited upon the Hon. William Gardiner, Governor-elect, Tudor and that he was pleased to reply that he accepted the office and would attend on the Legislature at such time as may be designated for the purpose of taking and subscribing the oaths required by the Constitution to qualify him for the discharge of his official duties.

Order

On motion by Mr. Weatherbee of Penobscot, it was

Ordered, that a message be sent to the House of Representatives proposing a Convention of both branches of the Legislature to be held forthwith in the Hall of the House for the purpose of administering to the Honorable Orman L. Stanley, Frederick Robie, Charles S. Cummings, Blaine S. Viles, Raymond E. Thurston, Lewis O. Barrows and Allen C. T. Wilson the oaths required by the Consti-

tution to qualify them to enter upon the discharge of their official duties, and for the further purpose of administering to the Hon. William Tudor Gardiner, Governorelect, the oaths required by the Constitution to qualify him to enter upon the discharge of his official duties.

Which was read and passed.

The Secretary delivered the message and subsequently reported that he had performed the duty assigned to him.

Subsequently a message was received from the House, by Mr. Chapman, its Clerk, concurring in the proposition for a joint convention for the purpose of administering the oaths to the Executive Councilors and to the Governor-elect.

The Senate retired to the Hall of the House of Representatives, where a joint convention was formed.
