#### SENATE

#### Thursday, January 24, 1929

Senate called to order by the President.

Prayer by the Rev. W. F. Greenman of Augusta.

Journal of previous session read and approved.

On motion by Mr. Bond of Lincoln, out of order and under suspension of the rules, it was

Ordered, the House concurring, that when the Senate and House adjourn, they adjourn to meet Tuesday, January 29, at four o'clock in the afternoon.

To the Honorable House of Representatives:

Revised figures subsequent to the date of sending the proof to the printer on the budget report indicate the following corrections:

FIRST: Balance in the Sinking Fund Reserve on December 31, 1928, is \$672,216.46. The addition of \$196-920.00 in the State Contingent Fund makes a total of \$869,137.06 in these reserve Funds of the State.

SECOND: The Auditor estimates that on July 1, 1929, there should be available and unencumbered in the Sinking Fund Reserve and the State Contingent Fund the sum of \$992,-646.50 after service of bonds and provision for contingencies that may be reasonably anticipated during the remainder of the fiscal year

On motion by Mrs. Pinkham of Aroostook, it was

Ordered, the House concurring, that one hundred and fifty (150) copies of the Legislative Record be printed in pamphlet form from day to day, in addition to the three hundred and fifty (350) copies now being printed, for distribution to members of the Legislature and the departments, under the direction of the document clerk.

Ordered, that the profound sympathy of the Senate of the State of Maine be extended to our faithful Doorkeeper, Charles F. Tibbetts, in the hour of his bereavement; and be it further

Ordered, that a copy of this ex-

pression of sympathy be forwarded to Mr. Tibbetts.

The PRESIDENT: This is a very appropriate order to introduce. The Chair learned with regret yesterday of the death of the wife of our esteemed Doorkeeper, Charles F. Tibbetts, and the Senate will signify its assent to the passage of the order by rising.

On motion by Mr. Slocum of Cumberland, it was

Ordered, that a message be sent to the House proposing a joint convention to be held forthwith in the Hall of the House of Representatives for the purpose of listening to an address by Col. Paul V. Mc-Nutt, National Commander of the American Legion.

The Secretary conveyed the message.

Subsequently a message was received from the House, by Mr. Chapman, its Clerk, concurring in the foregoing proposition for a Joint Convention.

#### Orders of the Day

On motion by Mr. Boulter of York, the Senate voted to take from the table An Act to create York Water District, (S. P. No. 42) tabled by that senator on January 23rd; and on further motion by the same senator, the bill was referred to the Committee on Public Utilities and 500 copies ordered printed.

On motion by Mr. Nickerson of Waldo, the Senate voted to take from the table, Resolve in favor of the Pownal State School (S. P. 70) and Resolve in favor of the Pownal State School for maintenance (S. P. 71) tabled by that senator earlier in today's session; and on further motion by the same senator the two resolves were referred to the Committee on Pownal State School and 500 copies of each ordered printed.

The Senate then proceeded to the House of Pepresentatives where a Joint Convention was formed.
