ERRORS IN LEGISLATIVE RECORD 1929

Which Might Confuse One Consulting the Index

- Page 25 The name of the joint committee on School for Feeble Minded was changed in 1927 to Pownal State School. The old name appears on this page, but no other in 1929 Record.
- Page 114 Mr. Aldrich of Topsham introduced the last two acts in column two.
- Page 108 Mr. Littlefield of York introduced the resolve in first paragraph, column one, and Mr. Mitchell of Aroostook the last resolve in column one. In column two the words "Judiciary Committee" should be inserted before S. P. 143.
- Page 115 An act to incorporate the town of Rumford School District (H. P. 422) should appear as being referred to Committee on Legal Affairs instead of Pensions, column one.
- Page 128 Mr. Burkett of Union introduced last resolve in column one (H. P. 577).
- Page 133 Petitions in favor of Barber bill (S. Papers 218-226) should be referred to Judiciary instead of Legal Affairs, column two.
- Page 139 H. P. 709 by Mr. Merrill of Dover-Foxcroft is a resolve in favor of Dover-Foxcroft.
- Page 165 Remonstrance introduced by Mrs. Allen in first paragraph, column two, does not state against what bill remonstrance is made.
- Page 189 Remonstrance in column two against Basic Science Bill should be under Judiciary instead of Education.
- Page 568 Second column says Act to provide for inspection of gasoline was reported in new draft under same title. Title was changed (see page 586, S. P. 718).
- Page 667 Order that Senator Carlton's remarks before committee be printed in Record. They never were so printed.
- Page 756 Last paragraph, first column, Androscoggin should read Aroostook.
- Resolves in favor of following academies were introduced at various times, but do not appear in Record again. Senate Journal shows they were all reported ought not to pass:—Aroostook Central Institute, Higgins Classical Institute, Lee Academy, Monson Academy, Monmouth Academy, Oak Grove Academy, Patten Academy, Pennell Institute, Ricker Classical Institute, Washington Academy, Berwick Academy, Bridgewater Classical Academy, Wiscasset Academy, Cherryfield Academy, Robert W. Traip Academy.
- Resolve in favor of town of Stonington (H. P. 1601) introduced on page 322, column one, does not appear again. Senate Journal shows it was reported ought not to pass.
- Record does not show that report of Budget Committee was submitted to legislature, although corrections to it were.
- Act relative to close time on moose (H. P. 1279 and H. P. 1657) introduced page 244 does not make final appearance. This is not an error of Record, but of Committee on Revision of Statutes, which did not report it out.

To the President of the Senate and the Speaker of the House of the 84th Legislature:

At my request the Auditor has prepared a comprehensive history of the various trust funds of the State together with a financial statement of those funds as of December 31, 1928. Attached is his report which contains much valuable information as well as a statement that should be borne in mind in connection with other matters of State finance. I commend to your consideration the question of such a policy as will permit the gradual restoration of these trust funds.

By Mr. Weatherbee of Penobscot: remonstrance of Nathan Cohen and 37 others (S. P. 365); remonstrance of Geo. W. Smith and 37 others. (S. P. 366) against the enactment of Senate Document No. 3, relative to basic sciences.

Sent down for concurrence.

Bill in First Reading

An act relating to the expenses of the Justices of the Supreme Judicial Court. (S. D. 144)

Reports Of Committees

Mr. Bragdon from the Committee on Agriculture, on Resolve in favor of scientific investigation in agriculture in Aroostook County. (S. D. 15) reported that the same ought to pass.

The report was read and accepted and the resolve read once. Thereupon, on motion by Mr. Leland of Piscataquis, the Senate voted to reconsider its action whereby this resolve received its first reading; and on further motion by the same senator the resolve was tabled pending first reading.

The same Senator, from the same Committee, on Resolve making appropriation for the support and maintenance of the Maine Agricultural experiment Station. (S. D. 14) reported that the same ought to pass.

The report was read and accepted.

Thereupon on motion by Mr. Leland of Piscataquis the resolve was tabled pending first reading.

The same Senator, from the same Committee, on resolve in favor of animal husbandry (S. D. 13) reported that the same ought to pass.

The report was read and accepted.

Thereupon on motion by Mr. Leland of Piscataquis the resolve was tabled pending first reading.

The same Senator, from the same Committee, on resolve in favor of Highmoor Farm, in the town of Monmouth. (S. D. 12) reported that the same ought to pass.

The report was read and accepted.

Thereupon on motion by Mr. Leland of Piscataquis the resolve was tabled pending first reading.

The same Senator, from the same Committee, on resolve to appropriate money for cooperative agricultural work between the College of Agri-

culture of the University of Maine and the United States Department of Agriculture. (S. D. 16) reported that the same ought to pass.

The report was read and accepted.

Thereupon on motion by Mr. Leland of Piscataquis the resolve was tabled pending first reading.

Mr. Noyes, from the Committee on Pensions, on Resolve providing for a state pension for Fred F. Harris of Lewiston (S. D. 22) reported that the same ought to pass.

The report was read and accepted, the resolve read once, and next Tuesday assigned for second reading.

Mr. Nickerson, from the same Committee, on Resolve providing for a state pension for Kate D. Talbot of Machias (S. P. 59) reported that the same ought to pass.

Mr. Noyes, from the same Committee, on Resolve providing for a state pension for Alberta Wadsworth of Belfast (S. P. 60) reported that the same ought to pass.

Mr. Wheeler, from the Committee on Salaries and Fees, on An act to increase the salary of the Register of Deeds in the county of Androscoggin (S. P. 8) reported that the same ought to pass.

Which reports were severally read and accepted, and the bill and resolves laid upon the table for printing under the joint rules.

An act to incorporate the Paris Village Corporation. (H. D. 155)

An act to amend section 39 of chapter 67 of the Revised Statutes relating to the fees to be paid by executor or administrator. (S. D. 33)

An act to create York Water District. (S. D. 25)

Sent down for concurrence.

Passed to be Enacted

An act amendatory of chapter 98 of the Private and Special Laws of 1927 entitled An act to incorporate the Casco Title Guaranty Company. (H. D. 4)

On motion by Mr. Greenleaf of Androscoggin the bill was laid upon the table pending passage to be enacted.

Additional papers from the House disposed of in concurrence.

Orders of the Day

Mr. PAGE of Somerset: Mr. President, I would like to ask the unanimous consent of the Senate to introduce a bill and my reason is that this bill, which I received yesterday, was sent to me, the people who sent it not being aware of the fact that February 5th was the last day on which private resolutions could be filed. If this cannot be presented it will work a hardship upon the people interested. They want the right to build a dam on their own land for the purpose of log driving.

The PRESIDENT pro tem: The Senator from Somerset, Senator Page, asks the unanimous consent of the Senate to introduce a bill. Is this the pleasure of the Senate?

Unanimous consent to introduce the bill was granted, and Mr. Page of Somerset introduced bill, An act to incorporate the Big Black River Dam; and on motion by the same Senator the bill was referred to the Committee on Interior Waters.

Mr. PAGE of Somerset: Mr. President, I would like to move that five hundred additional copies of An act to incorporate the Maine Foundation (S. D. 113) be printed. This is at the request of the Librarian.
