#### SENATE

Tuesday, February 19, 1929 Senate called to order by the President.

Prayer by the Rev. R. H. Moyle of Hallowell.

Journal of previous session read and approved.

From the House: An act to provide better government for the town of Mount Desert and correct an error. (S. P. 439) (In Senate, February 14, referred

to the Committee on Legal Affairs)

In the House, referred to the 85th Legislature in non-concurrence. In the Senate:

Mr. DOUGLAS of Hancock: Mr. President, a word of explanation in regard to this bill. The bill was given to me and I asked unanimous consent that it be introduced, understanding at that time that it was to correct an error. It corrected that error and added four sections of which I did not approve. I move that the Senate recede and concur with the House.

The PRESIDENT: The Senator from Hancock, Senator Douglas, moves that the Senate recede and concur with the House in the reference of this bill to the 85th Legislature. Is this the pleasure of the Senate?

The motion prevailed.

#### Orders

Mr. Slocum of Cumberland presented the following order and moved its passage:

Ordered, the House concurring, An act relating to the that bill Portland Water District (S. P. 321) (S. D. 116) be recalled from the Committee on Public Utilities; and that bill An act relating to a filtering plant or system for the Portland Water District (S. P. 237) (S. D. 102) be recalled from the Committee on Public Health; and that bill An act to amend the charter of the Portland Water District (S P. 246) (S. D. 105) be recalled from the Committee on Taxation; and be it further

Ordered, the House concurring, that these three bills be referred to the Committee on Legal Affairs, to be heard in Portland. Friday, February 22.

Mr. SLOCUM of Cumberland: Mr. President, in support of my motion—there are three bills of particular interest, these three bills to the residents of Portland and the near vicinity. The Legislature last week passed an order referring a bill, with reference to the Portland City Charter, to the Legal Affairs Committee for hearing in Portland this coming Friday. It would seem only in the inefficiency terests of economy and and service to the people, where they are to have a hearing in the city of Portland and the people there being the only ones particularly interested in these measures, that these bills could be quite rightly referred to the Committee on Legal Affairs for hearing in Portland at that time, and I hope my motion will prevail.

Mr. CARLTON of Sagadahoc: Mr. President, I would like to ask the Senator through the chair if he thinks the people would be satisfied with the notice they get where the hearing will be next Friday.

The PRESIDENT: The Senator from Sagadahoc, Senator Carlton, asks a question of the Senator from Cumberland, Senator Slocum, through the Chair which he may answer if he desires.

Mr. SLOCUM: I took this matter up with the proponents of the measures and they believed in every instance that three and a half days notice would be sufficient because the papers will, of course, give wide publicity to an order of this kind bringing it quite vividly to the attention of everyone that there will be a hearing on these measures other than the city charter if this order passes.

Mr. PAGE of Somerset: Mr. President, I move that the order lie on the table and be assigned for Thursday morning.

Mr. SLOCUM: Is a motion-

The PRESIDENT: The Chair will state that a motion to table is not debatable. The date of assignment is debatable.

Mr. SLOCUM: With reference to the date of assignment—if this is held over, even until tomorrow, it will be impossible to give the people sufficient notice to appear at the hearing and I appreciate that it is short notice to the members of this body to act upon this measure and I am sorry that any member should feel that this should be delayed and thereby make it impossible to have these hearings at the same time as the Portland City Charter.

Mr. PAGE: I will frankly state that I don't know anything about this. I will withdraw my day for assignment and make it tomorrow morning if that would meet with the approval of the Senator from Cumberland (Senator Slocum).

Mr. SLOCUM: In order to give a reasonable time of notice through publishing this change of hearing in the papers it would be necessary for both houses to act upon this, this afternoon. If both houses act this afternon favorably it will be possible to telephone to the newspapers in Portland and the advertisements can ' appear tomorrow morning, tomorrow night, Thursday morning, Thursday night and Friday morning, and make it possible for the people to have reasonable time to be assured that there will be a hearing at that time. Tomorrow morning I fear would defeat the whole purpose of the order.

Mr. PAGE: Mr. President, 1 will withdraw my motion altogether and not vote on it.

The PRESIDENT: The Senator from Somerset, Senator Page, asks permission to withdraw his motion. Is this the pleasure of the Senate?

The permission was granted.

Mr. OAKES of Cumberland: Mr. President, I am going to ask that the order be reread in order that we may get the sense of it

The PRESIDENT: The Secretary will again read the order.

The Secretary reread the order. The PRESIDENT: The question is on the passage of the order. Is it the pleasure of the Senate that the order have passage?

The order received a passage. Sent down for concurrence.

On motion by Mr. Spea**r of** Cumberland, it was

Ordered, the House concurring, that five thousand copies of the Report of the Agricultural Survey Committee of the Maine Development Commission on Progress and Maine Agriculture, 1850 to 1920, be purchased under the direction of the State Superintendent of Public Printing and the cost thereof be made a part of the contingent expenses of the 84th Legislature.

Mrs. Pinkham, from the Committee on Public Health, on Resolve for aid to typhoid carriers to be expended under the State Department of Health (S. D. 59) reported that the same ought to pass.

Mr. Carlton, from the Committee on State Lands and Forest Preservation, on bill An Act relative to the salary of the Forest Commissioner (S. D. 39) reported that the same ought to pass.

The reports were severally read and accepted, the bill and resolve each read once and tomorrow assigned for second reading.
