# Orders of the Day

The PRESIDENT: Under orders of the day, this being Wednesday, everything comes off the table automatically in the same order in which it appears on the calendar.

The President laid before the Senate, An Act relating to trapping of fur-bearing animals (H. D. 59) 13th by tabled on February 13th by Mr. Bragdon of Aroostook pending second reading, and on motion by that senator the bill was retabled.

Mr. MURCHIE of Washington: Mr. President, this is an act introduced by the Senator from Somerset, Senator Weeks, who is not now in the Senate and who is not feeling very well this week. Therefore, at his request, I move that this bill be retabled.

D. 16), tabled on February 13th by Mr. Leland of Piscataquis pending first reading, and on motion by that Senator the five resolves were retabled.
