SENATE

Thursday, February 28, 1929 Senate called to order by the President.

Prayer by the Rev. Edna L. Knowlton of Augusta.

Journal of previous session read and approved.

Orders

Mr. Martin of Kennebec, presented the following order:

ORDERED, the House concurring, that the Commissioner of Laber, and the Insurance Commissioner of the State of Maine, two members of the Senate to be appointed by the President of the Senate and three members of the House to be appointed by the Poeaker of the House, are hereby authorized to make an investigation of the operation of the Workmen's Compensation Law of the State, and make full report in writing to the Governor on or before October 1, 1930.

Authority is hereby given to summons witnesses and require the production of papers, documents and reports, any witnesses so summoned to receive the same attendance fees as are paid in the Supreme Judicial Court.

Among the matters which are to be inquired into are the following:

(1) Are the present rates adequate and fully compensatory to the insurance carriers, or are they too high or too low?

(2) What are the reasons why mutual insurance companies at regular manual rates can return to their clients 20% or more of premiums paid, while stock companies claim to be losing money?

(3) What has been the experience of self-insurers?

(4) Is the so called "loading charge" of 40% justified or not

(5) Are the insurance carriers properly or improperly expending money in audit, inspection, investigation and adjustment?

(6) What is the experience in

those States which have either a monopolistic state fund in its plan, or a competitive State fund and carrier plan?

The investigators herein provided for are to serve without compensation except actual expenses, but they may employ, at the expense of the State, such necessary expert, or other assistance as they require.

To enable the Commissioners herein named to perform their duties the Governor and Council are authorized to pay the expenses incurred up to, but not exceeding, the sum of twenty-five thousand dollars (\$25,000), such payment to be out of any funds available to the Governor and Council therefor.

Mr. MARTIN of Kennebec: Mr. President, in presenting this order I will say that I do so at the request of several citizens of the State and that the matter involved in it meets with the approval of the various people interested, at least I am so advised, and I move that five hundred copies of this order be printed and that it lie upon the table pending passage.

The motion prevailed.

This resolve, carrying the emergency clause, required the affirmative vote of two-thirds of the membership of the Senate on its final passage.

Twenty-eight Senators having voted in the affirmative and none opposed, the resolve was finally passed.

P. 576), tabled on February 27th by that Senator pending reference; and upon further motion by that Senator the bill was referred to the Judiciary Committee and 500 copies ordered printed.

Upon motion by Mr. Oakes of Cumberland, the Senate voted to take from the table Resolve in favor of Children's Heart Work Society of Maine (S. P. 456) tabled on February 27th by that Senator pending reference; and upon further motion by that Senator the resolve was referred to the Committee on Appropriations and Financial Affairs.

Upon motion by Mr. Greenleaf of Androscoggin, the Senate voted to take from the table An act to incorporate Sabattus Water and Sewer District (S. D. 206) tabled on February 27th by that Senator pending passage to be engrossed.

Mr. GREENLEAF of Androscoggin: Mr. President, I now offer Senate Amendment A and move its adoption.

The Secretary read Senate Amendment A:

Senate Amendment A to Senate Document 206. "Amend Senate Document 206. An act to incorporate Sabatus Water and Sewer District by inserting after the word "the' in the fifth line of the first paragraph of section seven of said document the words, 'persons therein' and by striking out the word 'voters' in the sixth line of said paragraph and inserting in place thereof the words 'to vote.'"

Senate Amendment A was adopted; and upon further motion by the same Senator the bill as amended by Senate Amendment A was passed to be engrossed.

The PRESIDENT: Pending arrival of papers from the House the Chair will declare a short recess.

After Recess

The Senate was called to order by the President.

Passed to Be Enacted

An act to provide for the support of the University of Maine. (H. D. 87)

On motion by Mr. Wheeler of Oxford the bill was sent forthwith to the Governor for his approval.

On motion by Mr. Oakes of Cumberland, the Senate voted to take from the table An act to amend the banking laws of the State (S. D. 61) tabled earlier in today's session by that Senator pending passage to be enacted; and on further motion by the same Senator the bill was passed to be enacted.

On motion by Mr. Douglas of Hancock, the Senate voted to reconsider its action whereby An act to extend the charter granted to the Union Terminal Company (H. D. 183) was passed to be enacted; and on further motion by the same Senator the bill was laid upon the table pending passage to be enacted.

On motion by Mr. Boulter of York, Adjourned until tomorrow morning at ten o'clock.
