This resolve, carrying the emergency clause, required the affirmative vote of two-thirds of the membership of the Senate on its final passage.

Twenty-five Senators having voted in the affirmative and none opposed, the resolve was finally passed.

On motion by Mr. Greenleaf of Androscoggin, the Senate voted to take from the table House Report from the Committee on Legal Affairs, Majority report "ought to pass in new draft", minority report, "ought not to pass" on bill, an act to create the department of finance and insurance (H. D. 735), tabled by that Senator earlier in today's session pending acceptance of either report; and on further motion by the same Senator the majority report "ought to pass" was accepted in non-concurrence, the bill received its first reading and assigned for second reading next Monday afternoon, April 1st.

On motion by Mr. Littlefield of York, the Senate voted to take from the table bill, an act relating to the acquisition of title to lands of railroad corporations by adverse possession (S. D. 162), tabled by that Senator earlier in today's session pending passage to be engrossed; and on further motion by the same Senator the bill was passed to be engrossed.

On motion by Mr. Greenleaf of Androscoggin, the Senate voted to take from the table, resolve in favor of Lena F. Cummings, widow of Henry F. Cummings, (H. D. 239), tabled by that Senator earlier in today's session pending final passage, in concurrence; and on further motion by the same Senator, the resolve was finally passed in concurrence.

On motion by Mr. Dwinal of Knox, the Senate voted to reconsider its action whereby the report of the Committee on Taxation, "Ought not to Pass" on an act to amend Chapter 184 of the Public Laws of 1921 as amended, to Make the Provisions of said Chapter Applicable to Carriers of Freight by Motor Vehicles and to Impose an Excise Tax on Motor Vehicles Subject to the Public Utilities Commission, (H. D. 428) was accepted in concurrence; and on further motion by the same Senator, the bill and report were tabled pending acceptance of the report in concurrence.

On motion by Mr. Oakes of Cumberland, the Senate voted to take from the table bill an act fixing trial terms of the Superior Court, (S. D. 329), tabled by that Senator on March 27th pending passage to be engrossed as amended by Sen-

ate Amendment A. The same Senator then offered Senate Amendment B and moved its adoption:

"Senate Amendment B to Senate Paper 667, Senate Document 329, entitled 'An Act Fixing the Terms of the Superior Court'. Senate Document 329 is further amended by adding thereto the following section, numbered Five, 'Section Five. When Act Effective. This

Act shall take effect on January 1st, 1930."

Senate Amendment B was adopted and the bill as amended by Senate Amendment A and Senate Amendment B was passed to be engrossed.
