### HOUSE

Wednesday, January 14, 1931. The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Moyle of Hallowell.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

The following bills were received, and, upon recommendation of the committee on reference of bills, were referred to the following committees:

**Inland Fisheries and Game** 

By Mr. Holbrook of Vanceboro: An act to open Little Trout Lake, in Kossuth, Washington County, to fishing. (H. P. 1)

By the same gentleman: An act to open Upper and Lower Flood Lakes, in Washington County to fishing. (H. P. 2)

#### Judiciary

By Mr. Burkett of Portland: An relating to offences against act habitations and other buildings. (H. P. 3)

panied by a statement of facts. Yesterday it was suggested that the Chair had made a slight error in not announcing the hour to which we adjourned. I will simply say that a perusal of the rules will inform you of the fact that unless some other hour than ten is stated, ten o'clock is the time we meet each morning. Are there any other matters of business?

Mr. ROUNDS of Portland: Mr. Speaker, the Telephone Committee have completed their duties and the cards are in the Secretary of State's office for any member of the House to get so that he may telephone wherever he wishes in the State of Maine.

The SPEAKER: Does any other member have any matter of business to bring before us? If not, the House will stand adjourned

after the reading of the notices. Mr. WHITE of Dyer Brook: Mr. Speaker, I would like to ask Mr. Rounds, through the Chair, if these telephone cards are the same as at the last session, permitting us to be called up on a reverse ticket.

The SPEAKER: The gentleman from Dyer Brook (Mr. White) asks through the Chair of the gentle-man from Portland, Mr. Rounds, if

the same arrangement has been made as at the last session whereby calls from one's home or con-stituency may be sent here with the ticket reversed; and the gentleman may answer.
