HOUSE

Thursday, February 5, 1931.
The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Bessom of Hallowell.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Memorial to the Department of the Interior urging the Secretary to request Mr. John D. Rockefeller, Jr., to continue with his road program on Mount Desert Island, (S. P. 346),

Comes from the Senate read and adopted.

In the House:

Mr. SCATES of Westbrook: Mr. Speaker, it is indeed a pleasure to approve and support this Memorial. Mr. Rockefeller is a man of high ideals and he has devoted, and is devoting, not only his income but his life to the welfare of humanity. No one can read the annual report "Rockefeller Foundation" the without being impressed with the wonderful work that that institu-tion is doing. It has investigated and provided the means whereby the hook worm disease, which was sapping the very life of the moun-taineers and the white labor of the South, has been practically stamped out. It has built and is maintaining hospitals and medical schools in China as an example to the Chinese of what modern sanitation and modern medicine and surgery can do.

Mr. Rockefeller came here to Maine and made Maine his summer home. He realized the possibilities of the National Park there and he has offered to spend four millions of dollars for the completion of the road in his estate and in the Park, not for his own advantage and pleasure but for the people as a whole. A certain number of people in Bar Harbor, or Mount Desert, have objected to it, and as a result of that he has asked the Department of the Interior at Washington to be relieved of it. The Department has asked him to hold the matter in abeyance for a

while. Now, whatever may happen to that episode, surely this Legislature can render no better service to the State than to adopt that Memorial unanimously; not particularly on account of the offer of four million dollars—that is only material, that is only money—but as an additional testimony of appreciation of his high ideals and for what he has done and is doing for the welfare of humanity. I move that the Memorial be adopted by a rising vote.

The SPEAKER: The House hears the motion of the gentleman from Westbrook, Mr. Scates, that the Memorial be adopted in concurrence with the Senate by a ris-

ing vote.

Mr. SHAW of Bar Harbor: Mr. Speaker, perhaps a word of explanation in regard to this will not be out of place. In the first place, Mr. Rockefeller has expended millions of dollars for roads on Mount Desert and he has four million more that he has offered to spend on roads on that island. He has acquired the land over which this road would go and at the present time, with the exception of a small strip of less than a mile, he owns all the land over which this road would go. There has, however, arisen a small sentiment in objection to this road, as we believe from a handful of people down there who object to everything and anything for the benefit or advantage of Mount Desert island. Those objections have reached Mr. Rockefeller, having been published in the newspapers. We did not think they really amounted to anything, but the final result has been that Mr. Rockefeller, in order not to hurt anybody's feelings, has suggested to the Department of the Interior that he would like to withdraw his offer. Up to that stage of the game, those in favor of this road had done nothing. The town of Bar Harbor, through its Board of Trade, had a meeting and elected a committee, or a citizen's committee, with the view of taking this into consideration. sent telegrams to the various parties and have followed it up, and the Department of the Interior has suggested to Mr. Rockefeller that they would like to have him withhold his request to withdraw until they could get a more full sentiment. The idea is that Mr. Rockefeller is still in control of his own land, and we believe in view of the roads he has built and the millions of dollars he has expended that it is not only a benefit to Bar Harbor, Mount Desert Island, and Hancock county, but that it is of vital interest to the whole State; and I therefore move the unanimous passage of this Memorial.

Mr. GRAVES of Mount Desert: Mr. Speaker as representing the town of Mount Desert, which is one of the towns on this island, I approve of all that Mr. Shaw has said and heartily agree with him in en-

dorsing this Memorial.

The SPEAKER: The motion before the House is that of the gentleman from Westbrook, Mr. Scates, that the House concur with the Senate and adopt the Memorial by a rising vote. If that is the pleasure of the House you will so vote. Thereupon the Memorial was

adopted by a unanimous rising

vote.

From the Senate: Bill an act relating to State Administrative Code, S. P. 60, L. D. 20.

Comes from the Senate referred to the Committee on Administrative Code.

In the House, on motion by Mr. Hathaway of Milo, tabled pending reference in concurrence.

From the Senate:

ORDERED, the House concurring, that a joint committee be appointed, three on the part of the Senate to be appointed by the President thereof, and seven on the part of the House, to be appointed by the Speaker thereof, with power to investigate the methods now employed in the State Assessors' Department in apportioning and equalizing the State taxes, and to study and report on the statues and laws of the State appertaining to the above; (L. D. No. 107).

Comes from the Senate read and passed as amended by Senate Amendment "A" as follows:

"And they shall have the power and right to hold hearings, summon and swear witnesses and report their findings and recommendations to this Legislature." (L. D. 274)

In the House the order and amendment were read and on motion by Mr. Allen of Sanford, tabled pending adoption of Senate Amendment A in concurrence.
