#### Orders of the Day

Mr. MORRILL of Gray: Mr. Speaker, I rise to a point of personal privilege.

The SPEAKER: The gentleman may state his point. Mr. MORRILL: Mr. Speaker, I

Mr. MORRILL: Mr. Speaker, I would like to know about the printing of notices of hearings on bills. They are advertised in the Kennebec Journal and I would like to know why they are not advertised in three or four of the leading papers. I am asking simply for my own information in order that I may not be misled.

The SPEAKER: The Chair is informed that matters of general importance are printed in the Kennebec Journal because that is the official State paper; that the disposition of other advertising matter for hearings in other papers lies wholly within the discretion of the clerks of the various committees.

Mr. MORRILL: Mr. Speaker, my point is this: If we were looking for anything that interested Androscoggin county for example, it would be perhaps advertised in the Lewiston Journal. Other State-wide subjects would be advertised in the Kennebec Journal, I suppose. I am not criticising anybody but am only seeking information. The SPEAKER: The Chair has

The SPEAKER: The Chair has no information other than as stated that all hearings are supposed to be advertised in the official State paper, while regional hearings, or hearings pertaining to regional matters, are allocated by the several committees through their clerks.

Mr. MORRILL: Mr. Speaker, my only object in mentioning it is, as I have said, that it might mislead some people who would be looking in the Kennebec Journal for matters that might interest their counties.

The SPEAKER: Under existing rules there seems to be no way of alleviating that condition.

Mr. MORSE of Oakland: Mr. Speaker, I may be able to clarify this somewhat. This present week some hearings on Ways and Bridges, through someone's mistake, were not advertised in our official paper, the Kennebec Journal.

The SPEAKER: Are there any

other matters to be taken up under orders of the day?

On motion by Mr. Rogers of Yarmouth, it was voted to take from the table the 14th unassigned matter, bill an act to authorize the Treasurer of State to receive a portion of the residue of the estate of Joseph C. Greene, bequeathed to the Pownal State School, S. P. 336, tabled by that gentleman on February 5th, pending reference in concurrence; and on further motion by the same gentleman the bill was referred to the committee on Pownal State School in non-concurrence.

On motion by Mr. Brewster of Wells, it was voted to take from the table the 6th unassigned matter, bill an act relating to the control of the State Department of Health over plumbing, H. P. 958, tabled by that gentleman on February 4, pending reference to a committee, and on further motion by the same gentleman the bill was referred to the committee on Public Health and 500 copies ordered printed.

Mr. CHURCH of Hallowell: Mr. Speaker, I understand that that bill is off the table for printing, and I would like to retable it until the first of the week, although I do not care to assign any particular day. I move that the bill be retabled pending printing.

The SPEAKER: Chair The rules that the motion of the gentleman from Hallowell, Mr. Church, is not in order inasmuch as the motion to refer and print had been carried, and the only way to reach the matter would be by a reconsideration of the action of the House on that vote. The action has already been carried to refer to the committee on Public Health and to print 500 copies.

Memorial to the Congress of the United States urging them to assist in excluding certain pulpwood from this country, S. P. 373.

RESOLVED, that whereas large quantities of Russian pulpwood, produced by convict and conscript labor, have recently been imported

into the United States from Russia, depriving the people of the State of Maine of a market for their Maine produced pulpwood, to the great injury of the citizens of Maine;

AND WHEREAS if this importation continues further great harm will be done to a large number of the citizens of the State of Maine and vitally affect the prosperity of our people:

BE IT RESOLVED by the Senate and House of Representatives of the State of Maine in Legislature assembled that we urge the senators and representatives of the Congress of the United States to do everything in their power to promptly exclude all Russian pulpwood or pulpwood products so produced from importation into this country.

AND BE IT FURTHER RE-SOLVED that copies of this resolution, duly certified by the Secretary of State, be forwarded to the President of the Senate and to the Speaker of the House of Representatives at Washington and to the several senators and representatives from the State of Maine in the Congress of the United States.

Comes from the Senate read and adopted.
