Mr. ROBIE of Westbrook: Mr. Speaker, I understand the Clerk has a bill returned from the committee on Legal Affairs which has to do with amending the charter of the city of Westbrook. I now move that 500 copies of that bill be printed and the bill returned to the committee.

The motion prevailed.

Mr. BURKETT of Portland: Mr. Speaker, I move to take from the table the second unassigned matter on the calendar, being House order relative to inviting Charles J. Bullock to address the House of Representatives, tabled by me January 29, pending passage.

The motion prevailed.

Mr. BURKETT: Mr Speaker, I should not have left that order on the table so long had it not been for the request of several members of the Penobscot delegation who wished to speak on it in one way or another but who had to be in Bangor last week attending a hearing.

The order was introduced by the gentleman from Winterport, Mr. Fernald, and I now yield to him so that he may explain the purposes of the order.

Mr. FERNALD of Winterport: Members of the House: The purpose of the order is to bring before this body a man who is an outstanding authority on taxation in the United States, a man who is authority by the quoted as an Taxation Commission of Maine 1908, the Vermont Taxation Commission of 1930, the Kansas Taxation Commission of 1929 and many other legislative bodies and commissions, which have been interested in improving our tax laws. It is the desire of many members of the House that this man be permitted to speak before us on Feb-ruary 27th, and he is coming here without any motive or for any particular purpose. He is coming here entirely upon his own time, so to speak, and the order provides for fifty dollars for pay-ment of his fare and Mrs. Bullock's fare from Boston and return. I think here is an opportunity for the State of Maine to spend fifty dollars for information correlated by a man of sixty years' experience in tax matters which can be put before this body in a very brief time.

I do not want to bother you with any extended remarks, but I will say that this man is at present president of the Harvard Economic I might say that some Society. fourteen years ago this man spoke before that Legislature (and I think there are several members here present who will remember it) on similar tax questions when Governor Milliken presided in the Executive Chamber.

It seems to me that this would be beneficial, not only to the newer members of the House, but as an educational matter, with a view of bringing about some change in our tax burden. I think we all agree that the tax burden in the State of Maine is unequalled. I think he will speak upon matters suggested by the Board of State Assessors in their annual report, presented to this body several weeks ago, and that he will speak on certain tax matters that have been suggested by our Governor; and if there are any questions that the members of this body would be interested in having answered, this man will be glad to give his opinion and the experience of other states in regard to it.

I thank you very much for your attention, and I am very sorry to have bothered you so long.

The SPEAKER: The question before the House is on the passage of the order. All those in favor of its passage will say aye; those opposed no.

A viva voce vote being taken, the order failed of passage.

On motion by Mr. Jack of Lisbon, it was voted to take from the table the seventh unassigned matter, Joint Order relative to appointments of a Joint Select Committee on Apportionment, tabled by that gentleman, February 5, pending the motion of Mr. Blaisdell of Franklin that the order receive a passage in concurrence.

Mr. Jack offered Amendment A to the order, as follows:

the order, as follows: House Amendment "A" to Joint Order relative to appointment of a Joint Select Committee on Apportionment.

Amend said order by striking out the word "seven" in the second line thereof, and inserting in place thereof the word "nine."

Further amend said order by striking out the words "with such members as the House may join" in the third and fourth lines, and inserting in place thereof the words "and of sixteen members on the part of the House to be appointed by the Speaker of the House" so that said order as amended shall read as follows:

Ordered, The House concurring, that a joint select committee consisting of nine members on the part of the Senate, to be appointed by the President of the Senate, and of sixteen members on the part of the House to be appointed by the Speaker of the House, be appointed to consider the apportionment and assignment of councillor districts, senatorial districts and districts for representatives to the legislature, as well as such matters as relate to the apportionment and assignment of congressional districts, and report to this Legislature by bill or otherwise.

Mr. JACK: Mr. Speaker, I now move the passage of the order as amended.

The SPEAKER: The question is on the adoption of the amendment.

Mr. SCATES of Westbrook: Mr. Speaker, I do not really understand that amendment in view of the vote recently passed by this House on the order, and I would move that it be tabled until I can consider it and the rest of us can consider it.

Thereupon the amendment was tabled, pending adoption.

On motion by Mrs. Day of Gornam, it was voted to take from the table the third unassigned matter, S. P. 31, L. D. 3, being Senate report, committee on Legal Affairs, ought not to pass on bill an act to provide for the examination, registration, regulation and licensing of chiropodists and podiatrists and penalthes for violation of this act, tabled February 3rd, by that member, pending acceptance in concurrence; and on further motion by the same member the report ought not to pass was accepted in concurrence.
