Friday, February 20, 1931.

The House met according adjournment and was called

order by the Speaker.

Prayer by Chaplain Hershey of the National Soldiers Home.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Bill an act relative to the construction of pole and wire lines upon and along State and State aid highways. (S. P. 485) (L. D. 646)

Comes from the Senate, referred to the committee on Ways and Bridges.

In the House on motion by Mr. Goudy of South Portland, tabled pending reference in concurrence.

From the Senate: Joint Order relative to investigating Insane Hospitals, which was referred to the committee on Insane Hospitals in the House January 29th,

Comes from the Senate indefinitely postponed in non-concur-

rence.

In the House on motion by Mr. Rounds of Portland tabled pending re-consideration.

From the Senate: Joint Order relative to preparing a Register of Documents: which was passed in the House February 17th.

Comes from the Senate passed as amended by Senate Amendment "A" in non-concurrence, Senate Amendment "A" reading as follows:

Amend the joint order relative to preparing a register of documents by striking out of the second paragraph the words "with the approval of the Appropriations and Financial Affairs Committee."

And further amend said order by striking out the date "February 18th" and replacing therefor the date "February 20th."

Ordered that 500 copies of an editorial taken from a Maine daily paper, be printed, to be distributed among the members of the House and Senate, the editorial being an editorial appearing in the Bangor Daily News on January 18, 1931 on

"Pensions, or the Poorhouse?

"Would it be better for all concrned for the State of Maine to grant pensions to its needy aged rather than send them to the poorhouse or leave them to suffer in silent pride as now? This subject, which was discussed at some length in The News some months ago, is again brought to attention by the introduction in the House of Reprepresentatives by Mr. Benjamin S. Stern of Biddeford of An Act to Provide for a System of Non-con-tributory Old Age Pensions.

"Mr. Sterns pleads powerfully for his measure. 'Is it not,' he asks, 'a disgraceful thing that in this prosperous country of ours when a man has reached the age where he man has reached the age where he is no longer of use to the industrialist there should be nothing facing him but the poorfarm? Nowadays, with the terrific struggle there is for the ordinary man to make ends meet, let alone make any provision for his old age, is it not right and proper that the State should do something to alleviate the should do something to alleviate the suffering which is caused by no fault of his own? Is it not a sad and shameful thing that a man who has probably struggled hard all his life to do his duty to society and the State should be reduced to the condition where he becomes a pauper, thereby losing his civil and human rights? The expense would not be considerable and it would eventually abolish the poorfarm, which seems to me to be one of the evils of our present system of government. Run as they very often are by some political hireling who has no one's interest at heart but his own, is it not a wonder that a great many of our poor old people die of starvation in some hovel rather than be the recipient of charity in such place?'

"The News heartily agrees with Representative Stern in all that he says, and sympathizes with him in his effort to abolish a social condi-tion that is nothing short of barbarous. In many countries of the world over which America assumes high superiority pensions are paid to the poverty-stricken aged, and many forms of help for the poor that do not involve their pauperism have been in vogue for years. Τf Maine's motto means anything let this thing be attended to. Let us hear no more the echoes of 'Over the hills to the poorhouse'."
