#### HOUSE

Wednesday, February 25, 1931. The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Brown of Gardiner.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Ordered, the House concurring, that a committee appointed consisting be of one member from the Senate with as many as the House may join to examine into the natural beauty and historical spots of the State with a view of purchasing same and creating a system of State Parks. Said Committee to have authority to add to its membership other interested citizens of the Said committee to report State. their findings to the next Legislature.

Comes from the Senate, read and passed.

In the House:

The SPEAKER: The Chair will announce the members of the committee later.

In carrying out the provisions of this order just passed by the House, it will be necessary for the House to fix the number of members who shall be appointed by the Chair on said committee. The Chair awaits said committee. The Chair awaits a motion from the House as to the number of persons so to be appointed.

#### **Emergency Measure**

S. P. 254, L. D. 269: An act to authorize the Treasurer of State under the direction of the Governor and Council to issue bonds for State highway construction and reconstruction for the calendar year 1931.

The SPEAKER: This being an emergency measure, it is necessary that it have the affirmative vote of two-thirds of the entire member-ship of this body. All those in favor-

Mr. SCATES of Westbrook: Mr. Speaker, I would like to call the attention of the members to the importance of voting on this meas-ure. It carries the emergency clause and to pass it must have 101 votes in its favor. So far on a division we never have had 101 votes. Therefore it is important that curve member of the Human that every member of the House, if we are not to have a yea and nay vote, vote one way or the other on the measure.

SPEAKER: All The thosein favor of the passage of the bill to be enacted will rise and stand until counted and the monitors have returned the count. A division being had,

One hundred and thirty-nine voting in the affirmative, the bill was passed to be enacted.

#### Orders Of The Day

The SPEAKER: Under orders of the day the Chair lays before the House the first tabled and unas-signed matter, being report of the committee on ludidary or bill on committee on Judiciary on bill an act relating to County Law Li-braries (H. P. 588) reporting same in a new draft. (H. P. 1069) under same title and that it ought to pass, tabled by Mr. Snow of Bluehill February 17, pending acceptance of the report.

SNOW of Bluehill: Mr. Mr. Speaker, I move that this bill be again laid on the table, and in explanation I will say that four bills amending the same section of the Statute relating to law libraries have been introduced, of which two were referred to the committee on Judiciary and two to the commit-tee on Legal Affairs. The reason for leaving this bill on the table is that in my opinion the committee on Legal Affairs will eventually rethat it will avoid all confusion. Therefore, I move that it lie on the table.

Thereupon the bill was re-tabled pending acceptance of report.

The SPEAKER: The Chair lays before the House the second unassigned matter, an act relating to payments to county law libraries S. P. 40, L. D. 237, tabled by Mr. Mc-Cart of Eastport, February 18, pending passage to be enacted; and the Chair recognizes the gentle-

man from Eastport, Mr. McCart. Mr. McCART: For the same rea-son, Mr. Speaker, as stated by the gentleman from Bluehill, Mr. Snow, I move that this matter be retabled.

The motion prevailed and the bill was retabled pending passage to be enacted.

The SPEAKER: The Chair lays before the House the third unas-signed matter bill an act relating to public health nursing in the schools, S. P. 443, L. D. 602, tabled by Mr. Rounds of Portland Feb-ruary 19 pending reference in con-currence to the committee or Edu currence to the committee on Education.

On motion by Mr. Williams of Falmouth, the bill was retabled pending reference in concurrence by the reason of the absence of Mr. Rounds of Portland.

The SPEAKER: The Chair lays before the House the fourth unas-signed matter, being House report ought not to pass of the committee on Judiciary on bill an act relating to patients to insane hospitals (H. P. 705) tabled by Mr. Rounds of Portland, February 19, pending

acceptance of report. On motion by Mr. Williams of Falmouth, the report was retabled pending acceptance by the reason of the absence of Mr. Rounds of Portland.

The SPEAKER: The Chair lays before the House the fifth unas-signed matter, House report legislation inexpedient, of the committee on Public Health on bill an act to regulate the practice of the system, method or science of healing known as naturopathy, and to create a Board of Examination and Registration for those desiring to practice the same and providing penalties for violation of this act, H. P. 126, L. D. 51, tabled by Mr. Goudy of South Portland February 19, pending acceptance of the re-port; and the Chair recognizes the gentleman from South Portland. Mr. Goudy

Mr. GOUDY: Mr. Speaker, I am perfectly in accord with having this bill taken from the table, and I move to substitute the bill for the report.

The motion prevailed. Mr. GOUDY: Mr. Speaker and members of the 85th Legislature: It is not my good fortune to possess-

The SPEAKER: The Chair would ask the gentleman to make a motion. There is nothing before the House at the present time as a motion on which to speak.

Mr. GOUDY: Mr. Speaker, as I understand the motion is before the House to substitute the bill for the report

The SPEAKER: The Chair will inform the gentleman that that motion has been carried. Mr. GOUDY: Then that is my

error.

The SPEAKER: The bill now stands substituted for the report. Does the gentleman move that the bill have its first reading at this time?

Mr. GOUDY: I do, Mr. Speaker. Thereupon under suspension of the rules it was voted that the bill

Mr. BENNETT of Presque Isle: Mr. Speaker, I move the indefinite postponement of this bill.

The SPEAKER: The motion is not in order inasmuch as the motion that the bill have its first reading has just been carried. Mr. BENNETT: Mr. Speaker,

The SPEAKER: The Chair lays before the House the sixth unas-signed matter, being Joint Order relative to amending Joint Rule to create a Joint Standing Committee on Motor Vehicles, tabled by Mr. Burkett of Portland, February 20, pending passage; and the Chair recongizes the gentleman from

Portland. Mr. Burkett. On motion by Mr. Burkett of Portland the Joint Order was re-ferred to the committee on Rules and Procedure.

The SPEAKER: The Chair lays before the House the seventh un-assigned matter Joint Order relative to investigating insane hospi-tals, which in the House on Jan-uary 29, was referred to the committee on Insane Hospitals, and which came from the Senate indefinitely postponed in non-concurrence, was tabled February 20 by Mr. Rounds of Portland, pending reconsideration.

On motion by Mr. Williams of Falmouth, the Joint Order was retabled pending reconsideration by reason of the absence of Mr. Rounds of Portland.

The SPEAKER: Are there any further matters to come under orders of the day?

On motion by Mr. Allen of Sanford it was voted to take from the table S. P. 63, report of the committee on Education on bill an act relating to State aid to academies, tabled by that gentleman earlier in the session, pending acceptance of the report in concurrence; and on further motion by the same gentleman the House voted to concur with the Senate in its report to indefinitely postpone the bill. The SPEAKER: The Chair will state that in carrying out the provisions of the order providing a committee on Rules and Procedure, which has passed both branches, and upon which the Senate has appointed its members, the Chair will now announce the House members of that committee, as follows: Messrs. Burkett of Portland, Farris of Augusta and Jacobs of Auburn.
