Tuesday, March 10, 1931.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Milligan of Randolph.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

Orders of the Day

The SPEAKER: The Chair pre-sents, tabled and today assigned, Senate Report, ought to pass, from the Committee on Public Health on bill an act to prevent the polluting of the water of the West Basin of China Lake, S. P. 96, L. D. 115, which came from the Senate report accepted and the bill passed to be engrossed, and which in the House was tabled on March 6, pending ac-ceptance of the report in concur-rence; and the Chair recognizes the gentleman from Vassalboro, Mr. Ōwen.

On motion by Mr. Owen that gentleman was given unanimous con-sent to have inserted in the records, without reading, a letter written and signed by the proponents of the Kennebec Water District, by their trustees, to the attorney of the op-ponents at the hearing, which letter is as follows:

"Augusta, February 17th, 1931. To Carroll N. Perkins, Atty. for Opponents to Leg. Doc. No. 116, 85th Legislature:

The trustees of the Kennebec Water District in the performance of our duties in insuring the protection of the purity of the water supply of the district have caused to be introduced a bill prohibiting bathing in the West Basin of China Lake.

Certain owners of property on the shore of the East Basin of China Lake while desirous of insuring the purity of the water supply, are fearful that this legislation is only an entering wedge and that in the future the Water District will en-deavor to extend this prohibition against bathing to the East Basin, and further attempt to secure the passage of an act to prevent fishing

or boating in both basins. In order that there may be no misunderstanding in this matter, therefore we wish to definitely assure all of these parties in interest, that there is no desire or intent on our part, or the part of the District to ask for any legislative act to prevent fishing or boating in the lake or to prevent bathing in the East Basin under present conditions.

D. 602, which came from the Senate referred to the committee on Education, and which in the House on March 4 was tabled by the gentleman from Augusta, Mr. Farris, pending reference in concurrence.

On motion by Mr. Farris, the bill was referred to the Committee on Education in concurrence.

On motion by Mr. Hamel of Lewiston it was voted to take from the table the second unassigned matter, House Report ought not to pass of the Committee on Judiciary on bill an act to reduce the salary of the Fire Commissioner of Lewiston, H. P. 657, L. D. 588, tabled by that gentleman March 1st, pending accept-ance of the report.

Mr. HAMEL: Mr. Speaker, I move the substitution of the bill for the report.

VARNEY of Berwick: Mr. Mr. not Speaker, the gentleman has given any reason why he wishes to substitute the bill for the report. This matter was heard by the committee and had to do with abol-ishing in the city of Lewiston the

office of Fire Commissioner and creating a new Fire Commission and consisting of three members, as I remember, although I have not the documents before me at the present time. The committee heard the proponents of the bill and the only reason given for abolishing the of-fice of Fire Commissioner was because the gentleman who intro-duced the bill, with several citizens of Lewiston, thought it ought to be done. It seemed to the committee and to me that we should hesitate before doing away with the Com-missioner they now have. It appeared at the hearing that Lewiston has a very efficient fire department headed by their present Commis-sioner, and there were letters introduced from a considerable number of citizens, really a good part of the taxpayers in the city of Lewiston, saying that they were satisfied with their fire protection and were opposed to any change.

I want the House to understand that personally I am not interested, and the vote of the House will be my vote, but it does seem to me that the consideration which the committee gave to this matter should have some weight in this House, and I certainly hope that the gentleman's motion will not prevail.

Mrs. MOREY of Lewiston: Mr. Speaker, I fully agree with the last speaker. The Fire Commissioner in Lewiston is a marvelous one and many of us know of no sufficient reason for removing him.

FARRIS of Augusta: Mr. Mr. Speaker, I, too, want to go on rec-ord as being against the motion of the gentleman from Lewiston, Mr. Hamel, to substitute the bill for the report, one reason being that this reduces the Fire Commissioner's salary from twelve hundred dollars to two hundred dollars a year, and also creates a Commission. That matter was threshed out before the Judiciary committee and it took nearly half of an afternoon. I can see no reason why at this time it should be done. The majority of the Lewiston people who appeared at the hearing were against the bill, and those people in Lewiston who sent in letters to the Judiciary committee were heavy taxpayers, some of the heaviest there, protest-ing against the passage of this bill. Therefore I trust and hope that

the House will not vote to substi-tute the bill for the report. Mr. BREEN of Lewiston: Mr. Speaker and members of the House: I see no reason at this time why there should be any change in the Fire Commissioner of the city of Lewiston. The position has been handled very satisfactorily by the present incumbent. This matter This was very ably presented before the committee and letters were received from citizens of Lewiston, corporations and individuals, representing \$250,000 in Lewiston's taxes, or about one quarter of the taxes as-sessed. I certainly hope that the motion made by the gentleman from Lewiston (Mr. Hamel) will not prevail.

Mr. HAMEL: Mr. Speaker. Т have an amendment to offer.

The SPEAKER: An amendment at the present time is not in order.

The pending question is the substitution of the bill for the report,

Is the House ready for the ques-tion? Those in favor of the motion to substitute the bill for the report will say aye; those opposed no.

A viva voce vote being taken, the motion to substitute the bill for the report, failed of passage. On motion by Mr. Farris of Augusta, the report was accepted.

Permission was given Mr. Blaisdell of Franklin to make the following announcement not pertaining to legislative matters.

Mr. BLAISDELL: I have been requested to announce on behalf of the committee which is arranging for the banquet tomorrow night that, while it is possible for the committee to take care of as many members of the Legislature, their wives, sweethearts and friends, as care to attend, it is very essential that the committee should know how many intend to be present in order that the caterer who has been chosen to do the work may know just how many to provide for. So I have been requested to say that you may obtain your tickets for the banquet tomorrow night in this building at the legislative postoffice, and that all those holding tickets purchased up until tomorrow noon will be taken care of. After that they will take their chances.

There was some confusion the other day as to whether the new members of the Legislature who are not members of the Legislature Association, were invited. Every member of the Legislature is invited, whether of this Legislature or of past ones, with all their friends, with the lobby, and with the executive heads of the several departments, and we trust you will all come. But buy your tickets early at the legislative postoffice, by tomorrow noon anyway, so that the committee may prepare for you a lobster stew and all the fixings.

On motion by Mr. Carleton of Portland, it was voted to take from the table House paper 1279 in new draft, an act relative to the salary of the Commissioner of Inland Fisheries and Game, ought to pass report of the committee on Salaries and Fees, tabled by that gentleman earlier in the session; and on further motion by the same gentleman the report was accepted, and the new draft tabled for printing under the Joint Rules.

On motion by Mr. Briggs of Caribou, it was voted to take from the table House paper 1278 in new draft, an act relative to the salary of the State Librarian, ought to pass report of the committee on Salaries and Fees, tabled by that gentleman earlier in the session; and on further motion by the same gentleman the report was accepted, and the new draft tabled for printing under the Joint Rules.
