Mr. SPEAR: I desire to ask permission to retable this order for the reason the State Assessors will come before the Committee on Appropriations tomorrow, of which I am Chairman, for a hearing on the financial requirements of their department for each of the next two years, and in order to avoid embarrassment and be fair to everyone, it seems best to retable this order for the present. The hearing for the State Assessors on the matters of their financial requirements is an entirely separate matter from this order of inquiry regarding certain other matters within the State Assessors Department. I therefore move this order be retabled.
