On motion by Mr. Weatherbee of Penobscot, the Senate voted to take from the table, An Act relative to State Administrative Code (L. D. 20), tabled by the senator on January 21st, pending reference; and on further motion by the same senator the bill was referred to the Committee on State Administrative Code.

On motion by Mr. Foster of Hancock, the Senate voted to take from the table, An Act relating to the Harbor Commissioners for Harbor of Portland (H. P. 607, L. D. 208), tabled by that senator on February 3rd, pending reference in concurrence; and on further motion by the same senator the bill was referred to the Committee on Legal Affairs in concurrence.

On motion by Mr. Foster of Hancock, the rules were suspended and unanimous consent was given that senator to introduce the following resolution:

"MEMORIAL TO THE DEPART-MENT OF THE INTERIOR, urging the Secretary to request Mr. John D. Rockefeller, Jr., to continue with his road program on Mt. Desert Island.

"WHEREAS, Mr. John D. Rockefeller, Jr., has offered to do certain development and road construction work on Mt. Desert Island and to pay therefor the sum of four million dollars, and

"WHEREAS, said development and road construction work has been carefully planned by his engineers under the supervision and with the entire approval of Mr. Fred Olmstead, one of America's leading landscape architects, and

"WHEREAS, said road, while principally on lands owned by Mr. Rockefeller, extends for a short distance across lands of the National government in the Arcadia National Park and said entire system of roads both on Mr. Rockefeller's own lands and upon the lands of the Department of the Interior in Washington and

"WHEREAS, a few of the many summer residents of Mt. Desert Island have in many ways voiced their opposition to said construction work thereby moving Mr. Rockefeller to ask to be relieved of his offer to have said work done and

"WHEREAS. Mr. John D. Rockefeller, Jr., has shown a deep and lasting interest in the State of Maine and its development which is thoroughly appreciated by the citizens of the State and

"WHEREAS, the State of Maine, by reason of the great benefits derived by the whole State from such a development as is planned by Mr. Rockefeller on Mt. Desert Island; is deeply and vitally interested both as a state and in behalf of the citizens of the State. NOW THEREFORE, "BE IT RESOLVED, that

the Legislature of Eighty-fifth the State of Maine respectfully urge the Secretary of the Department of the Interior to request Mr. Rockefeller to continue with and com-plete the program as outlined, and "BE IT FURTHER RESOLVED,

that a copy of these resolutions be sent to the Secretary of the Department of the Interior and to Mr. John D. Rockefeller, Jr., by the Secretary of State." Mr. FOSTER of Hancock: Mr.

President, I move the adoption of this resolution.

Mr. WEEKS of Somerset: Mr. President, if I am correctly informed this resolution gives to John D. Rockefeller, Jr., the moral sup-

port of the Legislature of the State of Maine, if it finally passes in the House. I am informed that he has made all plans for the development of this land and the roads, that he has offered the United States Government the sum of four million dollars, that the opposition is very slight and comes from people out-side of the state, that the benefit which the state would derive would be scattered all over its bounds and there will be benefits also to people who come into the state of Maine during the summer season; and I wish to second the motion of the Hancock, Senator Senator from this resolution be that Foster, adopted and that it be adopted without reference to any committee.

Thereupon, the resolution was unanimously adopted by a rising vote.
