Friday, February 13, 1931. Senate called to order by the President.

Prayer by Rev. W. S. Eaton of Augusta.

Journal of yesterday read and approved.

On motion by Mr. Spear of Cumberland out of order and under suspension of the rules, it was

Ordered, the House concurring, that when the Senate and House adjourn, they adjourn to meet February 17. at Tuesday, o'clock in the afternoon.

Sent down for concurrence.

Subsequently the foregoing order came back from the House, read and passed in concurrence.
