#### SENATE

Tuesday, February, 17, 1931.

Senate called to order by the President.

Prayer by the Rev. W. P. Bradford of Hallowell.

Journal of Friday, February 13th, read and approved.

Mr. Southard of Kennebec, out of order and under suspension of the rules, presented the following resolution and moved its adoption:

"Be it resolved by the Legislature of Maine, that it extends to Mrs. Charles O. Otis, sister of the late Major General Clarence R. Edwards, their profound sympathy.

"In the passing of Major General Edwards, the people of Maine have suffered a severe loss. His love for Maine people, particularly the soldiers of the late war, and their relatives, was more than re-ciprocated by them.

"His memory as a gallant soldier, a splendid companion and a fine gentleman, is a cherished one, and in his death the people of Maine pause a moment reflecting on those manly qualities possessed by Major General Edwards, whom they so dearly regarded.

"And, be it further resolved, that a copy of this resolution after passage by the Senate and House of Representatives, be signed by the Governor, and sent to Mrs. Charles O. Otis."

SLOCUM of Cumberland: Mr. Mr. President, as a personal friend of the late General Edwards I wish to second the adoption of that resolution.

D. 264), tabled by that senator on February 5th pending reference in concurrence; and on further motion by the same senator the bill was referred to the Com-Inland Fisheries and mittee on Game in concurrence.

On motion by Mr. Spear of Cumberland, the Senate voted to take from the table, Resolve in favor of the Augusta State Hospital for new construction (H. P. 943), tabled by that senator on February 12th pending reference.

Mr SPEAR of Cumberland: Mr. President, the original reference, I think, was to be to the Commit-

tee on Appropriations and Financial Affairs, but some member of the Senate has suggested that it be referred to the Committee on Insane Hospitals. In looking over the make-up of that committee I should think it was a safer place to send it than to Appropriations, and I move that this resolve be referred to the Committee on Insane Hospitals.

On motion by Mr. Littlefield of York, the Senate voted to take from the table, An act requiring managers or owners of dance pavilions to be licensed. (H. P. 915) (L. D. 368), tabled by that senator on February 10th pending reference in concurrence; and on further motion by the same senator the bill was referred to the Committee on Legal Affairs in concurrence.
