SENATE

Wednesday, February 18, 1931. Senate called to order by the President.

Prayer by the Rev. W. R. Wood of Augusta.

Journal of yesterday read and approved.

On motion by Mr. Weeks of Somerset, that Senator was given unanimous consent to introduce out of order and under suspension of the rules the following order,

Ordered, the House, concurring, that the time for the introduction of all new legislation be extended to Friday, February 20th, at four P. M.

Mr. WEEKS of Somerset: Mr. President, it seems better at this time to extend the time for the introduction of legislation for this period in order to accommodate members of both the House and the Senate who have held back bills which they undoubtedly could have introduced by unanimous consent. This order will give those members who have tried to obey the rules of both branches the opportunity to come under the wire with the others who have introduced bills by unanimous consent and I hope that the order receives passage, and so move.

The order received passage. Sent down for concurrence.

From the House, the following order:

Ordered, the Senate concurring, that the Clerk of the House prepare a register of all bills and resolves introduced into both branches of the legislature to and including February 18th showing titles, paper numbers, document numbers, names of members introducing the same and committees to which referred, and that there be printed 750 copies of same.

The Clerk of the House is hereby authorized, with the approval of the Appropriations and Financial Affairs Committee, to employ the necessary clerical assistance to prepare such register.

In the House, read and passed.

Mr. SPEAR of Cumberland: Mr. President, I am informed by the Clerk of the Appropriations Committee that five hundred copies will be ample.

Mr. MURCHIE of Washington: Mr. President, I do not want to offer any objection to the passage of the order, but I do want to go on record as saying that so far as I am concerned I do not willingly subscribe to the view that this Legislature should pass any order with the approval of any committee. I think the Legislature has sufficient autonomy to speak for itself without providing in its order that it must be subject to the approval of the Committee on Appropriations and Financial Affairs, or the Committee on Governor's Message, or any other committee.

Mr. ALDRICH of Sagadahoc: May I enquire whether that order refers to all bills introduced in both the House and Senate?

The Secretary re-read the order. Mr. SLOCUM of Cumberland: Mr. President, in view of the order of the Senator from Somerset, Senator Weeks, to extend the time to February 20th and pending its passage by the House, I move that this order lie upon the table for amendment if that previous order has passage.

The PRESIDENT: The Senator from Cumberland, Senator Slocum, moves that this order lie upon the table. Is this the pleasure of the Senate?

The motion to table prevailed.

Mr. SLOCUM of Cumberland: Mr. President, I would request that the order recently introduced by the Senator from Somerset, Senator Weeks, be sent immediately to the House for action by that body so that we may expedite this other order.

The PRESIDENT: The Chair will state that the order has already been sent to the House.

Orders of the Day

On motion by Mrs. Carter of Androscoggin, the Senate voted to take from the table, Joint Order relating to Old Age Compensation, tabled by that Senator on February 6th pending passage.

Whereupon, the same Senator offered the following amendment and moved its adoption.

"Senate Amendment 'A' to House Order of February 3, relating to Old Age Compensation.

'Said order is hereby amended by inserting in the first line be-fore the word 'committee' the word 'recess'; and by striking out the third paragraph of said order and inserting in place thereof the fol-lowing: 'The messenger to the Governor and Council shall be a member of said committee in addition to the five to be appointed and shall act as secretary to the committee', so that said order as amended shall read as follows:

'Ordered, the Senate concurring: 'That a recess committee of five be appointed, two from the Senate, to be named by the President of the Senate, and three from the House, to be named by the Speaker of the House: whose duty it shall be to study the problem of Old Age Com-pensation, the acts now in operation in other states, and any other

matter pertinent thereto. 'Such committee shall consider the necessity and feasibility of such legislation in this state, and shall report their conclusions in the draft of such act pertaining to Old Age Compensation as may seem to them best applicable to The State of Maine. Said act to be introduced in January Nineteen Hundred Thirty Three, for the consideration of the Eighty Sixth Maine Legislature. 'The messenger to the Governor

and Council shall be a member of said committee in addition to the five to be appointed and shall act as secretary to the committee.

'Said committee shall receive such per-diem compensation, allowance for travel etc. as may be approved by the Governor Council.'" and

Thereupon, on motion by Mr. Kitchen of Aroostook, the order and the amendment were laid upon the table.

Mr. SLOCUM of Cumberland: Mr. President, may I inquire if the Joint Order relative to registry of documents has been returned from the House?

The PRESIDENT: The Chair will state that it has not.
