#### SENATE

Wednesday, March 4, 1931. Senate called to order by the President.

Prayer by the Rev. A. W. Brown of Gardiner.

Journal of yesterday read and approved.

Mr. PAGE of Somerset: Mr. President, there are in the possession of the Secretary of the Senate certain papers with a communication from the Governor which in my opinion, should be acted on at once, and I move that the rules be suspended and that the communication be read at this time

Thereupon, the rules were suspended and the Secretary read the following communication out of order:

STATE OF MAINE
Office of the Governor
Augusta, March 3, 1931
To the Honorable Senate and
House of Representatives:

It gives me great pleasure to transmit herewith a communication from an ex-Governor. The substance of his letter is generous proof of his devotion to the State and his thoughtfulness for mankind of this generation and of those to follow throughout the ages.

I have expressed to him such appreciation as was within my power and I know that you will take the opportunity to perfect that expression by prompt action.

Hon. William Tudor Gardiner, Governor,

and the Senate and House of Representatives of the State of Maine:

It long has been my ambition to have the State of Maine own Mt. Katahdin, for to my mind that mountain is the grandest and most beautiful of all the natural attractions of our State.

Beginning as a member of the House of Representatives, continuing through my service as Senator and Governor, and later as a private citizen I have consistently maintained my interest in this region and expect some day to see my ambition realized. It has been necessary to overcome many obstacles and some are yet to be surmounted, but time and patience aid a good cause and I am confident of the outcome.

Some time ago I acquired an undivided three-eighths (3-8) interest in an area comprising sixteen (16) square miles in Township three(3), Range nine (9), Piscataquis County, within which lies Mt. Katahdin, having purchased the same from the Great Northern Paper Company, whose officials showed a fine public spirit in their willingness to aid me in carrying out my plans.

It was my hope by this time to have acquired the remaining undivided five-eights (5-8) of this area, but this has not yet been accomplished. I, however, shall continue my efforts to obtain the outstanding interest in order to give it to the State at some future date.

The problem that thus confronted me was whether at once to donate to the State my three-eighths (3-8) interest, or wait until the remaining portion is acquired. Owing to the uncertainty of life, and being apprehensive lest something might happen to thwart my plans, I have decided to offer at this time to convey my interest in this mountain area as a gift to the State of Maine, and ask that it be accepted by Act of the Eighty-Fifth Legislature in accordance with the terms of the Act of Acceptance submitted herewith.

The only requests that I have to make in connection with this gift are that, in so far as can legally be done with an undivided interest, the donated area forever be used for public park and recreational purposes, forever be left in the natural wild state, forever be kept as a sanctuary for wild beasts and birds, that no roads or ways for motor vehicles shall hereafter be constructed thereon or therein, and that I be allowed to retain, during my lifetime, the right to determine, and to place whatever markers or inscriptions shall be maintained or erected on or within the donated area herein offered to the State.

In making this gift I desire to show to the people of my native

State my appreciation of the honors they conferred upon me in the years gone by.

Percival Proctor Baxter

Mr. PAGE: Mr. President, within the confines of Township 3, Range 9. Piscataquis County, lies what is probably one of the missing sections of our State. Within this area is Mt. Katahdin, Chimney Pond, Abol Stream, several ponds mountain trails. This large Township, tract of land in this which has been purchased by one of our most distinguished citizens who now wishes to convey the same to the State of Maine, is to be forever kept in its natural state as a bird sanctuary and game preserve for the benefit and use of this and future generations, and therefore, I ask unanimous consent under suspension of the rules, that the bill an act permitting the State of Maine to accept the gift of our for-mer Governor, Percival P. Baxter, be received and without reference to a committee, be given its several readings and passed to be engrossed.

Thereupon, under suspension the rules, the communications were accepted and placed on file.
Sent down for concurrence.

On motion by Mr. Page of Somerset, out of order and under suspension of the rules, unanimous consent was given to that senator to introduce bill, "An act accepting from Percival Proctor Baxter a deed of gift of a portion of Mount Katahdin" (S. P. 528); and on further motion by the same senator the bill was given its two several readings and passed to be engrossed.

Mr. BISSETT of Cumberland: Mr. President, may I ask whether it is in order that a few words may be said in regard to this matter at this time?

The PRESIDENT: The Senator may so proceed.

Mr. BISSETT: Mr. President, as a Senator from Cumberland County I certainly think that this is one of the greatest things that has happened for a long time and I believe that if we had more such public spirited men who would take a like pride in our fair would be a grand thing. pride in our fair State it I know that I am heartily in accord, and undoubtedly so is every citizen in this state, with this gift that the ex-Governor has given, and we all

hope that this will become one of the greatest scenic and most picin the State turesque places Maine.

Mr. PAGE: Mr. President, I would like to inquire whether or not the communications just read have been sent to the House? If not, I would move that they be trans-mitted to the House by special messenger.

The PRESIDENT: The Chair will state that both communications and the bill have been sent to the

House.
