**SENATE**

Thursday, March 12, 1931  
Senate called to order by the President.

Prayer by the Rev. Stanley Manning of Augusta.

Journal of yesterday read and approved.

The President announced the appointment of Mr. Leland of Piscataquis of the Senate as called for in the Joint order relative to examining into the natural beauties and historical spots with a view of purchasing same and creating a system of State Parks.

Mr. SPEAR of Cumberland: Mr. President, I move that all the bills pertaining to fish and game matters and hunting lie upon the table.

The PRESIDENT: For the matter of the legislative record the Chair will put the motions separately for each bill if satisfactory to the Senator from Cumberland, Senator Spear.

Mr. SPEAR: Certainly, Mr. President.

Mr. MURCHIE of Washington: Mr. President, may I inquire of the Senator from Cumberland (Senator Spear) through the Chair, if he will assign a time for the consideration of these matters.

The PRESIDENT: The Senator from Washington, Senator Murchie, inquires through the Chair whether any time can be assigned for the consideration of these matters and the Senator from Cumberland, Senator Spear, may answer if he desires.

Mr. SPEAR: Mr. President, I would like to inquire of the Senator from Washington (Senator Murchie) through the Chair what time will be satisfactory to him.

The PRESIDENT: The Senator from Washington, (Senator Murchie) hears the inquiry.

Mr. MURCHIE: I will make the reply, Mr. President, that my only reason for making the request is the wholesale nature of the motion. We have a great many matters on the table now. Unfortunately they are coming from the table very slowly and, as one member of the Senate, I am looking forward hopefully to some date when we may adjourn. Any date that the Senator from Cumberland (Senator

Spear) may assign, provided it is in the month of March, will be satisfactory to me.

Mr. SPEAR: Well, Mr. President, I don't know as the Senator from Washington (Senator Murchie) has answered my question very definitely.

He says that any time in March would be satisfactory to him. I will assign tomorrow morning or sooner.

The PRESIDENT: The Senator from Cumberland (Senator Spear) assigns tomorrow morning. There appear to be only two bills relative to fishing. Does the motion of the Senator from Cumberland, Senator Spear, also include hunting?

Mr. SPEAR: Yes, Mr. President; fishing and hunting.

Mr. MURCHIE: Mr. President, if there are only two I will revoke my "wholesale" statement and withdraw my request for a special assignment. If there are a multitude, however, I think a time should be assigned.

The PRESIDENT: The Chair will state that there appear to be, so far, three such matters and it might be well to let the matter of assignment stand until tomorrow morning. The Secretary will read the bills that appear to be affected by the motion of the Senator from Cumberland, Senator Spear.

The Secretary read the bills.

Mr. FOSTER of Hancock: Mr. President, it strikes me that that bill relative to catching smelts in Salt Pond should not be included in "fish and game."

Mr. SPEAR: Mr. President, I move that that bill lie upon the table with the other two.

Thereupon, on the motion made by Mr. Spear of Cumberland, the Senate voted to lay upon the table, pending passage to be enacted, and especially assigned for tomorrow morning at ten o'clock:—
