Friday, March 13, 1931 Senate called to order by the President.

Prayer by the Rev. A. T. Mc-

Whorter of Augusta.

Journal of yesterday read and approved.

Mr. Weeks of Somerset out of order and under suspension of the

order and under suspension of the rules, presented the following order and moved its passage:
ORDERED, The House concurring, that when the Senate and House adjourn, they adjourn to meet Monday, March 16, at fourthirty o'clock in the afternoon.

Mr. CROSBY of Penobscot: Mr. President, I think the members may realize that on Monday next occur a great many of our town meetings and it may well prove very difficult for quite a few of us to be here on Monday. I would to be here on Monday. I would suggest that the order be amended to read "Tuesday" instead of "Monday." For the purpose of amendment, if agreeable to this body, I move this order lie on the table temporarily.

Mr. SOUTHARD of Kennebec: Mr. President, I yield to the Senator from Cumberland, Senator

Spear.

Mr. SPEAR of Cumberland: Mr. President, personally I have no interest in this bill but I think as Chairman of the Committee on Towns perhaps an explanation would be in order. We had a very lengthy hearing down in the "Hall of Flags" on this bill. Everybody, I think, had a chance to say all they wanted to. The "Ought Not to Pass" report was signed by eight members and the "Ought to Pass" report by two. We asked the proponents of the bill if they would be willing to submit to a referen-dum to the voters of the two towns and they said "No", because Hancock was larger than Lamoine or the village of Marlboro of course, which is in Hancock. They said passage would kill it. The op-ponents of the bill were willing it should be submitted to the voters. It seemed to us and those who signed the "ought not to pass" report, that the legislature should

not be called upon to give one part of the town to another town without adequate compensation without referring it to a larger number of people than was involved the first time. The whole matter has been troublesome because of one faction being outnumbered by I would move, Mr. and Members of the the other. President and Members of Senate, that we adopt the majority

report, "ought not to pass."

Mr. LITTLEFIELD of York: Mr. President, I being a member of the Committee would like to say that we put in a whole afternoon down there in hearing this case and the only thing I could draw from this was that two years ago the same case was before the Towns Committee and we gave them a referendum which they said was perfectly all right, as you will remember. They went home and they had the referendum and the referendum came out in the defeat of the division, then they put up a great holler that everything was crooked and all wrong, and these people had defrauded the other people, etc., and they took this case into court and as I understand it,—I may be a little wrong here, but the Supreme Court, to say the least, said that they did have an election and the election was all right and proper and one witness got up and said it was a crooked deal right along with his conversation in regard to the Supreme Court, and I asked him if he wished us to understand that he meant the Su-preme Court had given them a crooked deal. He said, "Oh no, no." He didn't want us to understand that. I said, "Would you like another referendum and see if you can have it all straight?" He said. "No, either give us this bill or kill it, one or the other." We talked it all over and had quite a lengthy session and finally one man was missing,—one Senator, I think, on the committee—and the Chairman made us all sign our names on the back of the bill. He said it was so we could not back out over night and I guess that was all right. (Laughter). Seven signed the bill and the other two members signed a minority report. The next day the other Senator came in and I understand he signed the majority report so that the way it stands,

is eight and two, and I hope this Senate will uphold the committee's

report. Mr. WEATHERBEE of Penobscot: Mr. President, this is quite an important matter and most of the Senators have not informed themselves about the details of this case, especially about the evidence of fraud that has been asserted in some quarters to have something to do with the decision in the referendum. I think the matter should lie on the table and be especially assigned. I therefore, move this bill lie on the table and be especially assigned for next Wednesday.

The motion to table and assign prevailed.

On motion by Mr. Aldrich of Sagadahoc, the Senate voted to take from the table, An act to register and license persons in the practise of barbering and to create a Board of Barber Examiners (L. D. 52), tabled by that Senator earlier in today's session pending acceptance of the report of the Committee on Public Health, "Ought to Pass."

Mr. ALDRICH of Sagadahoc: Mr. President, I yield to the Senator from Cumberland, Senator Slocum.

Mr. SLOCUM of Cumberland: Mr. President, my motion was to accept the report of the Commit-

On motion by Mr. Weeks of Somerset, a division of the Senate was had.

Eight having voted in the affirmative and sixteen in the negative, the motion to accept the report of the committee was lost.

Thereupon, on motion by Mr

Greenleaf of Androscoggin, the Senate voted to concur with the House in the indefinite postponement of the bill.

On motion by Mr. Spear of Cumberland, the Senate voted to reconsider its action taken earlier in today's session whereby An act to amend Section 118 of Chapter 29, of the Revised Statutes of 1930 (S. P. 534, L. D. 834) was passed to be engrossed; and on further motion by the same Senator the bill was laid upon the table pending passage to be engrossed.

On motion by Mr. Towle of Kennebec, the Senate voted to take from the table, An act relating to Agricultural Societies (H. P. 702, L. D. 358), tabled by that Senator earlier in today's session pending consideration; and on further motion by the same Senator leave to withdraw the bill was granted in concurrence.

On motion by Mr. Weatherbee of Penobscot, the Senate voted to take from the table, House Report from the Committee on Library, "Ought not to pass" on H. P. 626, Resolve for the purchase and distribution of Ward's Syllabus-Digest of the Maine Reports, tabled by that Senator on March 6th pending motion to commit to the Committee on Judiciary, and on further motion by the same Senator the bill was committed to the Committee on Judiciary.
