Mr. WEATHERBEE of Penobscot: Mr. President, the Committee on Salaries and Fees reported this bill "ought not to pass" after having learned that the entire delegation from Penobscot County was opposed to what they then be-lieved was an increase in salary. It later developed that if the measure had passage it would not, in fact, be an increase in salary but would be giving to the clerk of court \$300, being a sum he lost in fees due to the change in the law court. Yesterday afternoon the delegation from Penobscot County had a meeting and changed its vote upon this proposition.
